6.2 MPE Calculation

According to the formula S= $\frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

dBm

- 1) P (Watts) = Power Input to antenna = 10^{-10} / 1000
- 2) G (Antenna gain in numeric) = 10[^] (Antenna gain in dBi /10)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm²

The Max Conducted Peak Output Power is 63.83mW in highest channel;

The best case gain of the antenna is 2.4dBi. 2.4dB logarithmic terms convert to numeric result is nearly 1.74.

$$S = \frac{PG}{4R^2\pi} = \frac{63.83 \times 1.74}{4 \times 400 \times 3.14} = 0.0221 \text{ mW/cm}^2$$

So the device is exclusion from SAR test.
