1 MPE EVALUATION OF MOBILE DEVICES

Human exposure to RF emissions from mobile devices (47 CFR §2.1091) may be evaluated based on the MPE limits adopted by the FCC for electric and magnetic field strength and/or power density, as appropriate, since exposures are assumed to occur at distances of 20 cm or more from persons.

1.1 LIMITS FOR GENERAL POPULATION/UNCONTROLLED EXPOSURE

1.2 MPE EVALUATION FORMULA

$$Pd = \frac{Pt}{4 * \pi * R^2}$$

Where

Pd= Power density in mW/cm²

Pt= EIRP in mW

π= 3.1416

R= Measurement distance

CONCLUSION:

Both of the WLAN 2.4G & 5.0G can transmit simultaneously, the formula of calculated the MPE is:

$CPD1 / LPD1 + CPD2 / LPD2 + \dots \text{etc.} < 1$

CPD = Calculation power density

LPD = Limit of power density

Non-beamforming mode

WLAN 2.4G + WLAN 5.0G = $0.177 / 1 + 0.217 / 1 = 0.394$

Beamforming mode

WLAN 2.4G + WLAN 5.0G = $0.320 / 1 + 0.428 / 1 = 0.748$

Therefore, the maximum calculation of this situation is 0.748, which is less than the "1" limit.
