A minimum of 30 unique waveforms are required for each of the Short Pulse Radar Types 2 through 4. 


DFS Measurement System

DFS measurement system consists of two subsystems: (1) The radar signal generating subsystem and (2) the traffic monitoring subsystem.


System Block Diagram



Conducted Method




Setup for Master with injection at the Master



The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

The aggregate channel closing transmission time is calculated as follows:

Aggregate Transmission Time = N*Dwell Time

N is the number of spectrum analyzer bins showing a device transmission Dwell Time is the dwell time per bin (i.e. Dwell Time = S/B, S is the sweep time and B is the number of bin, i.e. 8192)
