

Valore KB100 Fast operation manual

I . Bluetooth mode

1. Bluetooth version: Bluetooth 3.0 compliant, support HSP, HFP, A2DP, AVRCP agreement, with "di di" prompt, Bluetooth device name for Valore KB100
2. Long press the power button for 2 seconds boot, boot speakers boot prompt, the bluetooth indicator light blue light into the bluetooth mode, speakers from bluetooth state prompt
3. Blue light to 100 ms flash into the matching condition, mobile search to Valore KB100 confirm can connect device name, if you need a password input (0000), the connection is successful after blue light normally on sound box to prompt the sound, music playing in the process of blue light to 1000 ms slow flash. Have paired mobile phones to open the first bluetooth and open speakers automatically back to united.

II. TF card model

1. Insert boot bluetooth mode TF card automatically enter the TF card playback mode, if the speakers have insert TF card device, after the boot directly into the TF card play mode
2. Play in the process of light is flashing blue light to 1000 ms slower, suspended blue light normally on
3. Remove the TF card equipment, speakers into bluetooth mode automatically

III. The headset functionality

1. Insert the headset "headphones" jack, can listen to stereo music
2. Headset insert time, automatically cut off the horns playback mode

IV. Charging

Insert the USB cable speakers or computer can connect 5 v charger to speakers built-in battery

V. This machine is all the mode boot volume is 60% of the total volume by default. When the battery voltage is lower than 3.2 V sound will automatically detect and low electric alarm prompt, when the battery voltage is lower than 3.0 V and sound will prompt automatic shutdown

VI. This machine is designed for soft boot mode, in order to avoid wrong operation or the battery voltage suddenly down cause crashes cause inconvenience, this machine is specially design reset key. Behind the reset button in the headset, appear crash happens, as long as a toothpick or other small machine plug the headphone press the reset button to restart
