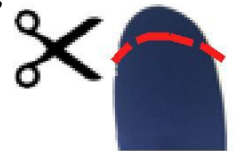


When prompted by the website, enter the device serial number found on the bottom of the SoleTrakr Personal Locator as shown here.

Remove the insole from the shoe that the SoleTrakr Personal Locator will **3** be installed in, and using it as a guide; trim the SoleTrakr to the correct length. A step-by-step video is located on www.soletrakr.com under “Support”.



Charge the SoleTrakr for at least 2 hours for the first time. The SoleTrakr must be charged regularly, and requires a minimum 1 hour to fully charge. Current battery level and low power warnings are available through www.soletrakr.com.

Insert the SoleTrakr into the shoe in which it will be worn; verify fit; and log in to www.soletrakr.com to verify the device is showing correct location and activity.

FCC RF Exposure Information and Statement The SAR limit of USA (FCC) is 4.0 W/kg averaged over one gram of tissue. Device types: ST.1 (FCC ID:

2AE3F-SOLETRAKR15) has also been tested against this SAR limit. The highest SAR value reported under this standard during product certification when properly worn on the body is 3.43W/kg. This device was tested for typical body-worn operations with the back of the handset kept 1.5cm from the body. To maintain compliance with FCC RF exposure requirements, use accessories that maintain a 1.5cm separation distance between the user's body and the back of the handset. The use of belt clips, holsters and similar accessories should not contain metallic components in its assembly. The use of accessories that do not satisfy these requirements may not avoided.with FCC RF exposure requirements, and should be avoided.

Body-worn Operation

This device was tested for typical body-worn operations. To comply with RF exposure requirements, a minimum separation distance of 1.5cm must be maintained between the user's body and the handset, including the antenna. Third-party belt-clips, holsters, and similar accessories used by this device should not contain any metallic components. Body-worn accessories that do not meet these requirements may not comply with RF exposure requirements and should be avoided. Use only the supplied or an approved antenna.
