To Whom It May Concern:

The SA-TX is a handheld product which integrates a low frequency magnetic emitter. The SA-TX cannot be used as a radiofrequency module standalone; the RF module is completely integrated.

The SA-TX is part of a detection system which is named SAVEX. The SA-TX allows peoples who bring it, to be detected by the reception system installed on vehicle and so, inform the driver about a collision risk between the machinery and the pedestrian.

It can also be placed on another vehicle for the same application.

The antenna must either be permanently attached or employ a "unique" antenna coupler (at all connections between the module and the antenna, including the cable). The "professional installation" provision of § 15.203 is not applicable to modules but can apply to limited modular approvals under paragraph (b) of this section.	X	
(v) The modular transmitter must be tested in a stand-alone configuration		X
(vi) The modular transmitter must be equipped with either a permanently affixed label or must be capable of electronically displaying its FCC identification number.	X
