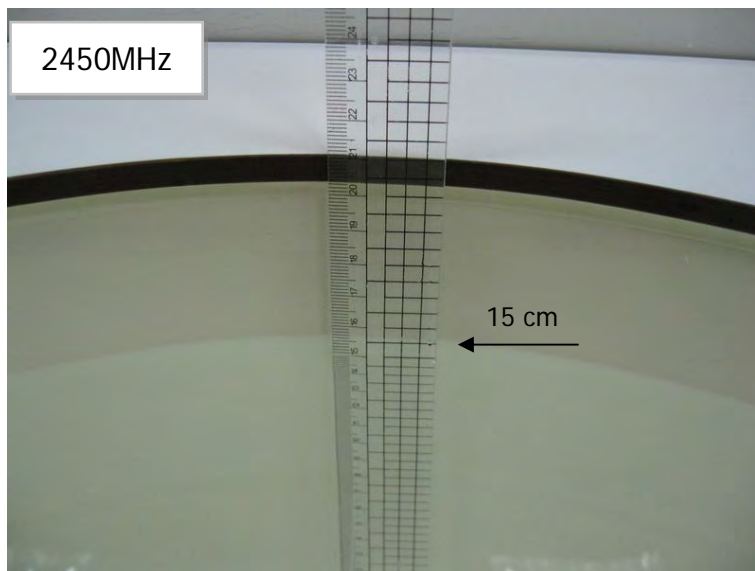

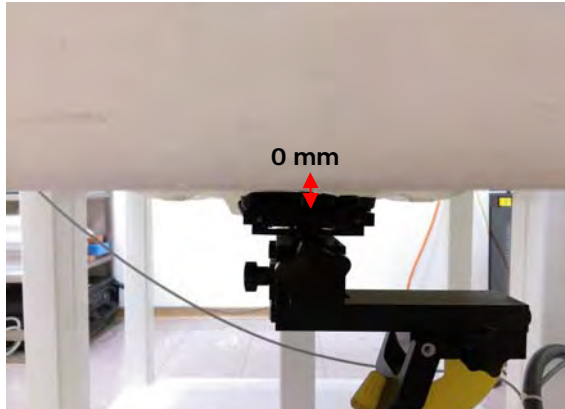

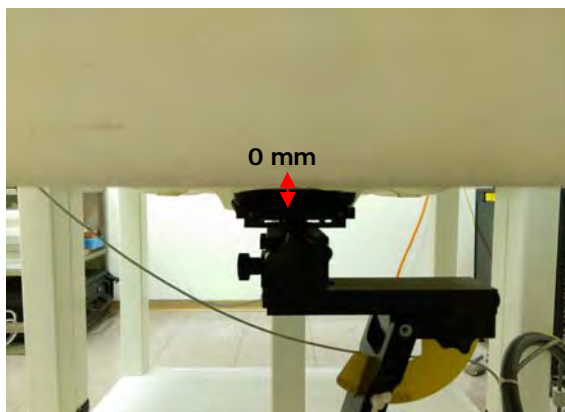

**Fig.5 EUT Front side\_2 to flat phantom**

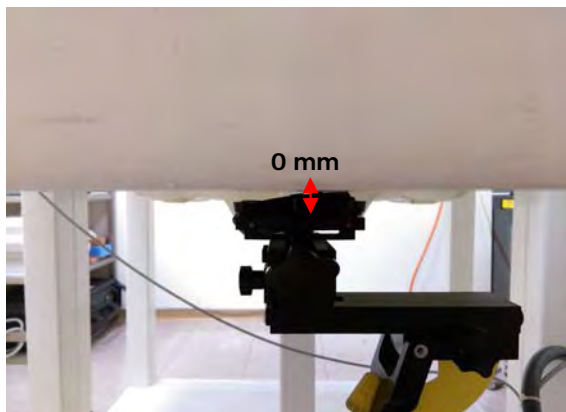

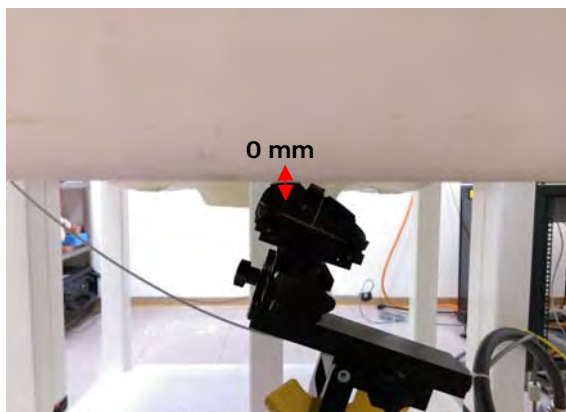

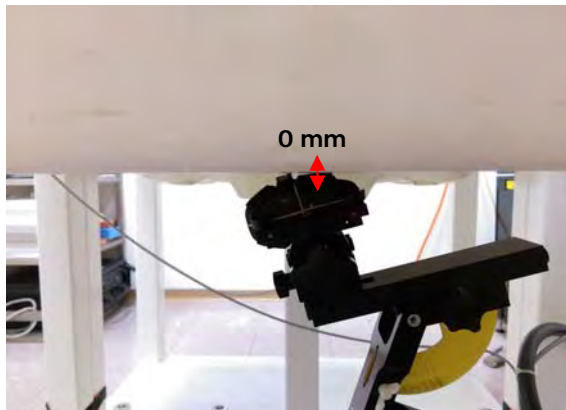

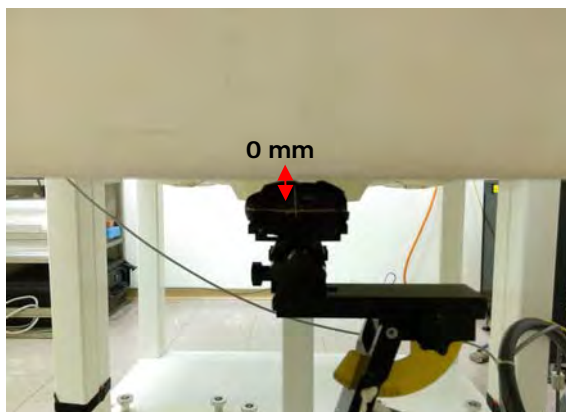

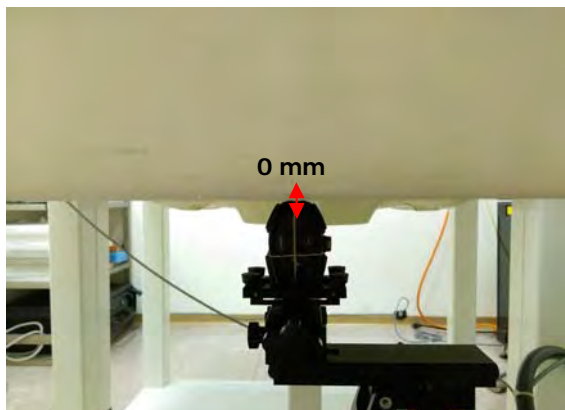

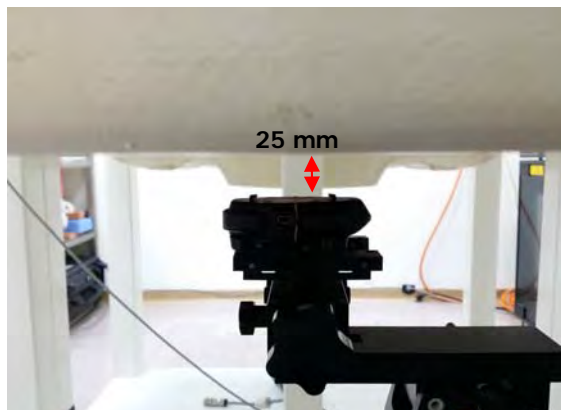
