#### 2. SYSTEM TEST CONFIGURATION

## 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

#### 2.2. EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

#### 2.3. Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plan. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz,. The CISPR Quasi-Peak and Average detector mode is employed according to §15.207. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

#### 2.3.2 Radiated Emissions

The EUT is a placed on as turn table. For emissions testing at or below 1 GHz, the table height shall be 0.8 m above the reference ground plan. For emission measurements above 1 GHz, the table height shall be 1.5 m. The turn table shall rotate 360 degrees to determine the position of maximum emission level. ### Fig. 2-1 Radiated Emission & AC Power Line Conducted Emission





Fig. 2-2 Conducted (Antenna Port) Configuration








(A) Radiated Emission Test Set-UP Frequency Below 30MHz.

- 2. The EUT was placed on a turn table with 0.8m for frequency< 1GHz and 0.8m for frequency> 1GHz above ground plan.
- 3. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
- 4. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
