Start by plugging the coordinator into the gateway. Then plug the gateway into the power.

Sensors

Stones contain a variety of sensors, including:

- Temperature + Humidity
- Light Level
- Sound volume level

Light level is a relative measurement and does not correspond to a specific lux. The number is used to indicate change or general on/off.

Sound volume level is sampled ~1000 times a second and averaged to a single volume measurement each second. **It is impossible to record or transmit audio of any length.**

Size

The stone is 2.75" x 2" x 0.8".

Environmental conditions

Stones will work well above and below typical living conditions. They have been tested to -5C and 65C and use components rated above that.

Warranty

Quietyme, Inc. ("Quietyme") warrants to the original purchaser that your Stone electronic device (the "Product") shall be free from defects in materials and workmanship under normal use for a period of one (1) year from the date of purchase.

Quietyme does not warrant that the operation of the Product will be uninterrupted or error-free. Quietyme is not responsible for damage arising from failure to follow instructions relating to the Product's use.

This Limited Warranty does not cover software embedded in the Product and the services provided by Quietyme to owners of the Product. Refer to the license agreement accompanying the software and the Quietyme services terms of use for details of your rights with respect to their use.

Remedies

If a hardware defect arises and a valid claim is received by Quietyme within the Warranty Period, Quietyme will, at its option and to the extent permitted by law, either (1) repair the Product at no charge, using new or refurbished replacement parts or (2) replace the Product with a new or refurbished Product. In the event of a defect, to the extent permitted by law, these are your sole and exclusive remedies. Shipping and handling charges may apply except where prohibited by applicable law. This Limited Warranty is valid only in the jurisdictions where the Products are sold by Quietyme itself or through its authorized reseller or agent, and is valid to the extent permitted by the applicable laws of such jurisdictions. Any replacement hardware product will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer, or for any additional period of time that may be applicable in your jurisdiction.

How to Obtain Warranty Service
