

# Hang-A-Round

## HANGING SPEAKER & SPEAKERPHONE



- 1. Charging Port:** Use the provided mini-USB cord to charge the speaker.
- 2. Phone:** Press to answer/hang-up a phone call.  
Press to "Pause" music when in Bluetooth mode.
- 3. ON/OFF:** Turn the device ON & OFF.
- 4. Indicator Light:** Shines BLUE when a device is paired.  
Shines RED while charging. Blinks RED when battery is low.
- 5. AUX Input:** Plug in AUX cord to play songs from MP3 player, CD player & other external devices.

### Charging the Bluetooth® Speaker:

Plug the mini-USB cord into the side of the speaker. Then plug the USB into your computer's USB port. When charging, the red LED light will be on. Charge for 2-3 hours for 3-4 hrs of playing time. Unplug the USB cord once the speaker is fully charged. When the power gets low, the red light will blink and you will hear a beeping sound.

### Pairing the Bluetooth® Speaker:




1. Turn 'ON' the speaker by using the switch on the back. The blue lights will quickly blink until the speaker is connected.
  2. In your device settings, turn the Bluetooth® function 'ON'. Make sure your device is no further than 3 feet away.
  3. Wait for your device to recognize the speaker (Hang A Round Speaker).
  4. Connect your device with the speaker (Hang A Round Speaker) by selecting that specific option in your device settings. The blue light will stay on once it is connected.

### Using the AUX Cable:

Connect the provided AUX cable to the speaker port and your external devices AUX port. Connecting a device using the AUX port will override Bluetooth® mode.

### To Use the Phone Function:

1. To answer a phone call, press the  button on the side of the speaker.
  2. To hang up a phone call, press the  button.  
Press & hold press the  button to decline any incoming calls.
