## RT Restaurant Guest Call System

### User Manual

1. **Turn on receivers:** Put receivers on charging slot, then remove receivers from charging slot. Receivers will automatically turn on.
2. **Turn off receivers:** Press “801”, then “Send” to turn off receivers. Note that receivers are also turned off during charging.
3. **Call receivers:** To call receivers, press receiver number, then “Send”.
4. **Find receivers:** Press “805”, then “Send” to alert receivers. Note that receivers will not alert during charging.
5. **Range test:** Press “806”, then “Send” to test transmitting distance. Transmitter will keep sending signals to alert receiver #1 until it is out of range.
6. **Turn on & off buzzer:** Remove receivers from charging slots. Press “807”, then “Send” to turn off buzzer (vibration only). Press “808”, then “Send” to turn on buzzer (vibration + beep).

## **Federal Communication Commission Interference Statement**

## ***FCC Radiation Exposure Statement***
