## 2. Charging Cable

Connect charging cable with power adaptor, then connect with pin contacts at the end of longer wrist band, shown as below:



The watch will power on automatically while charge up to 2%, please consume all battery for first 3 times, it will help to keep the battery in best use status.

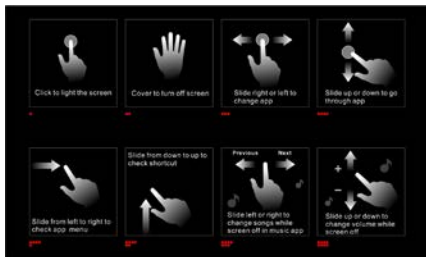
### **3. Install SIM Card and take it out**

Power off the watch, put the metal contact part of SIM card upside, shown as below; if you want to take the SIM card out, please power off the watch first.



### **4. Power on and off**

Use the SIM card screw driver to press the up button of back side until you see the ROCKIOO logo.



Go to settings, slide to bottom and select power off.

## 6. FCC statement

## RF Exposure Information (SAR)

This device meets the government's requirements for exposure to radio waves. This device is designed and manufactured not to exceed the emission limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission of the U.S. Government.

Tests for SAR are conducted using standard operating positions accepted by the FCC with the watch transmitting at its highest certified power level in all tested frequency bands.

The FCC has granted an Equipment Authorization for this model watch with all reported SAR levels evaluated as in compliance with the FCC RF exposure guidelines.

To comply with RF exposure requirements, a minimum separation distance of 10 mm must be maintained between the user's mouth, and this model watch including the antenna during voice communications.

This device is restricted to worn on the wrist operations.
