


Please use 9V/1.67A or 5V/2A adapter for charging




LED indicator



CONNECTION SCHEMATIC DIAGRAM



Charging area



a. Power the charger using the USB cable, connecting to a power supply.

b. Place the phone in the charging area.

c. The indicator turns red when powered on.

d. The indicator turns green while charging.

e. The indicator turns from green to red when fully charged.

Tips:


The quick charge feature requires the use of a power adapter compatible with the fast charging standard. Please remove the phone after each full charge. Slight overheating may occur when charging a fully charged phone.

Precautions

1. Use the device in an indoor and a dry environment, avoid high temperature, humid, or sooty environment;
2. Avoid strong magnets or magnetic objects;
3. Avoid places that are easily accessible to infants;
4. Do not open the product or repair without authorization.

Claims process:

To obtain remedies under this Warranty, MYNT must receive Customer's claim before the end of the Warranty Period. Customer shall bear the cost of shipping the Device to MYNT. By sending the Device, Customer agrees to transfer ownership to MYNT. MYNT will not return the original Device to Consumer. MYNT warrants that any repaired or replaced Device is covered for the remainder of the original Warranty Period. If the claim is justified based on this Warranty, MYNT shall bear the cost of shipping the repaired or replacement Device to the Customer. Any product returned to MYNT without a valid warranty claim or without a Return Form may be rejected, returned at sender's cost (subject to prepayment) or disposed of in MYNT's sole discretion.

MYNT Refund Policy

We have strived to create a wireless charger you will love. However, we realize the Product you receive from MYNT may not be exactly what you expected. The original retail purchaser of the Product may return all MYNT purchased in the original transaction, in their original condition, with the original receipt and packaging, within 30 days of the date of delivery to the original retail purchaser and MYNT will exchange it or provide a full refund of the original purchase price. Please note that this policy applies only to Products you purchase directly from MYNT. This is in addition to your legal rights and your rights under the MYNT hardware one (1) year Worldwide Warranty referred to above.

All returns must be authorized.

Warranty

We cover the MYNT device for one full year under warranty. MYNT is splash proof but not waterproof. Environmental Friendly MYNT is made out of steel, silicon, and plastic. It is recyclable with other types of electronics.

Limited Hardware Warranty

This Limited Warranty applies to the MYNT wireless charger product (Product), in various packages, purchased from this webstore. The MYNT wireless charger products will be free from defects in materials and workmanship under regular use for one year from the date of delivery to the original retail purchaser ("the Warranty Period"). When a defect in the Product arises within the Warranty Period, MYNT will: (a) repair or replace it with a new or refurbished product or component; or (b) refund the original purchase price upon return of the defective Product.
