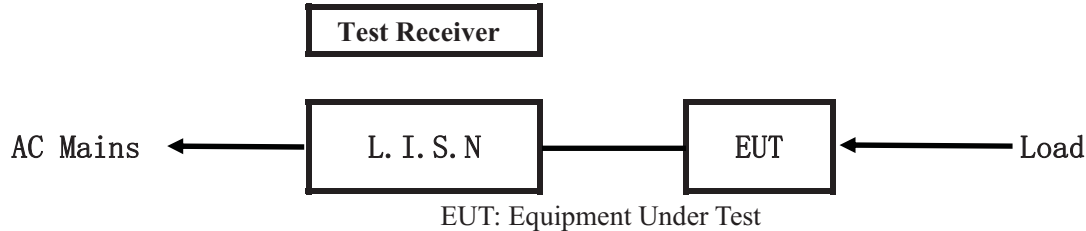

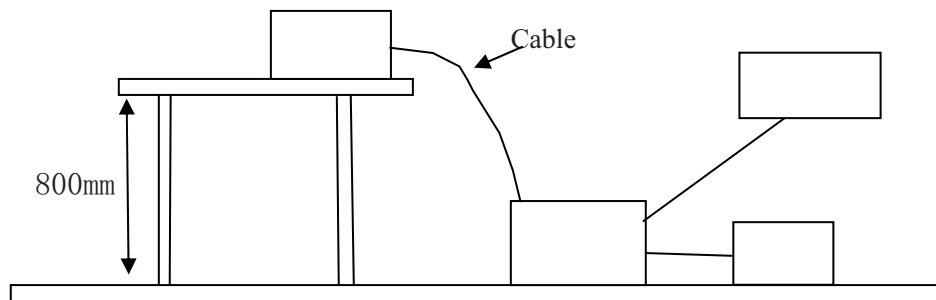

## 6 Radiated Emission Test

### 6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.10–2009. The radiated test was performed at Timeway Laboratory. This site is on file with the FCC laboratory division, Registration No.899988
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10–2009.
- (3) The frequency spectrum from 30 MHz to 25 GHz was investigated. All readings from 30 MHz to 1 GHz are Quasi-peak values with a resolution bandwidth of 120 kHz. **CH01 for 11g at 54Mbps: Vertical**



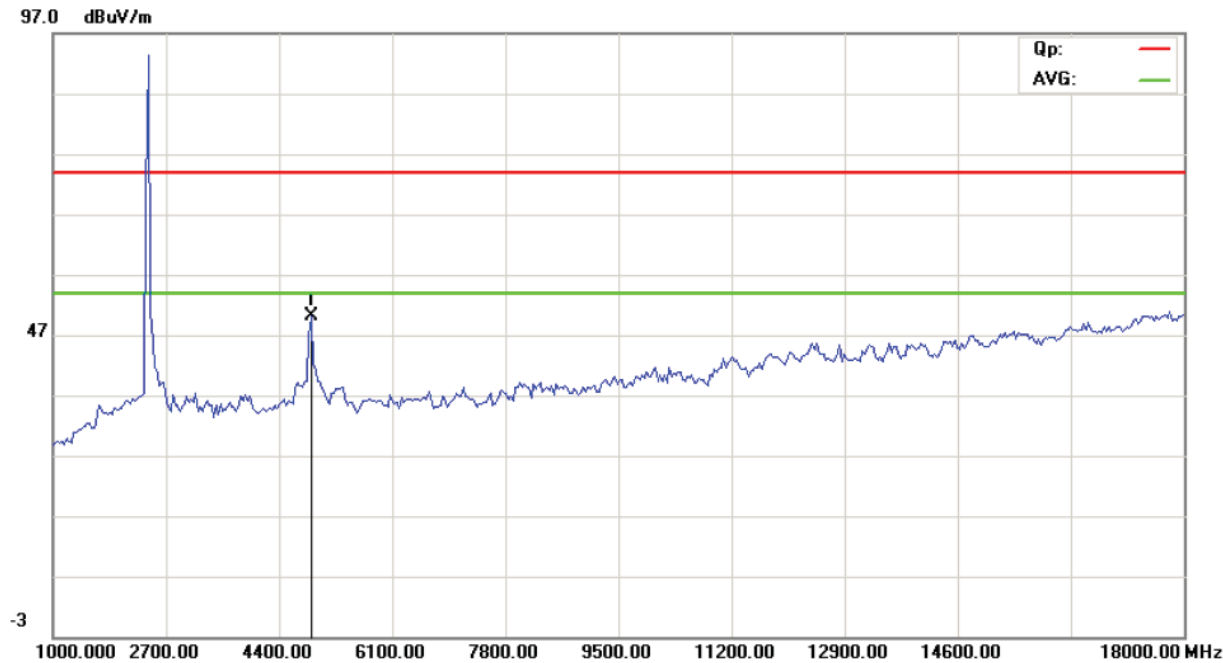

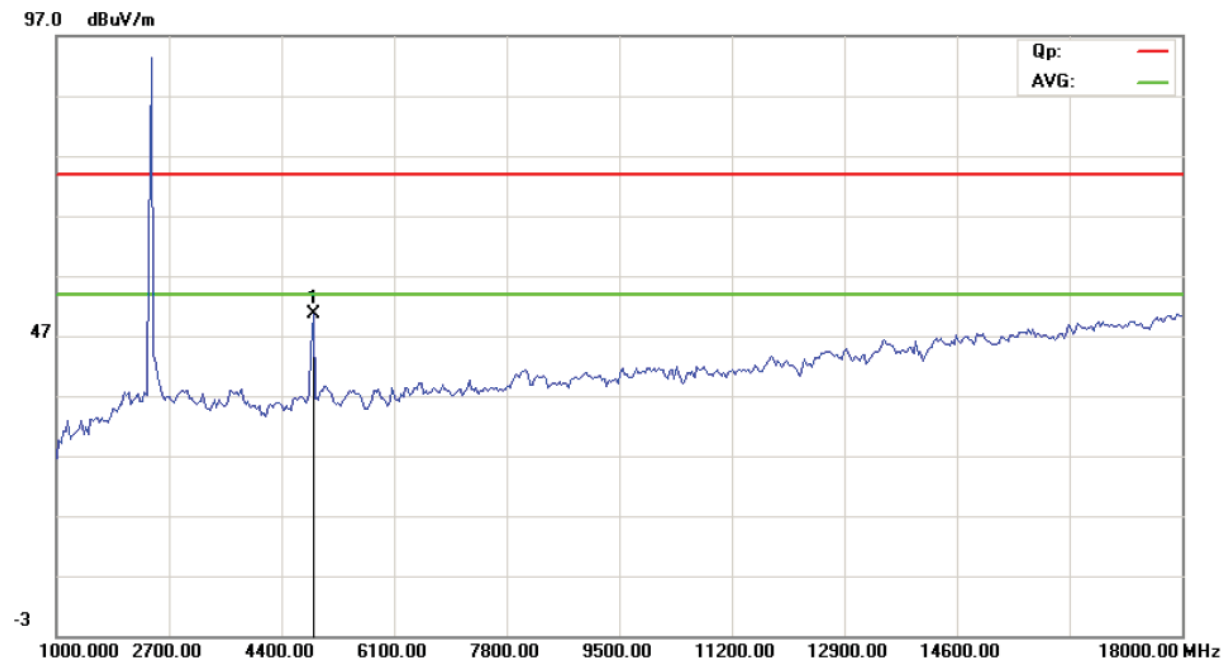

CH06 for 11g at 54Mbps: Vertical

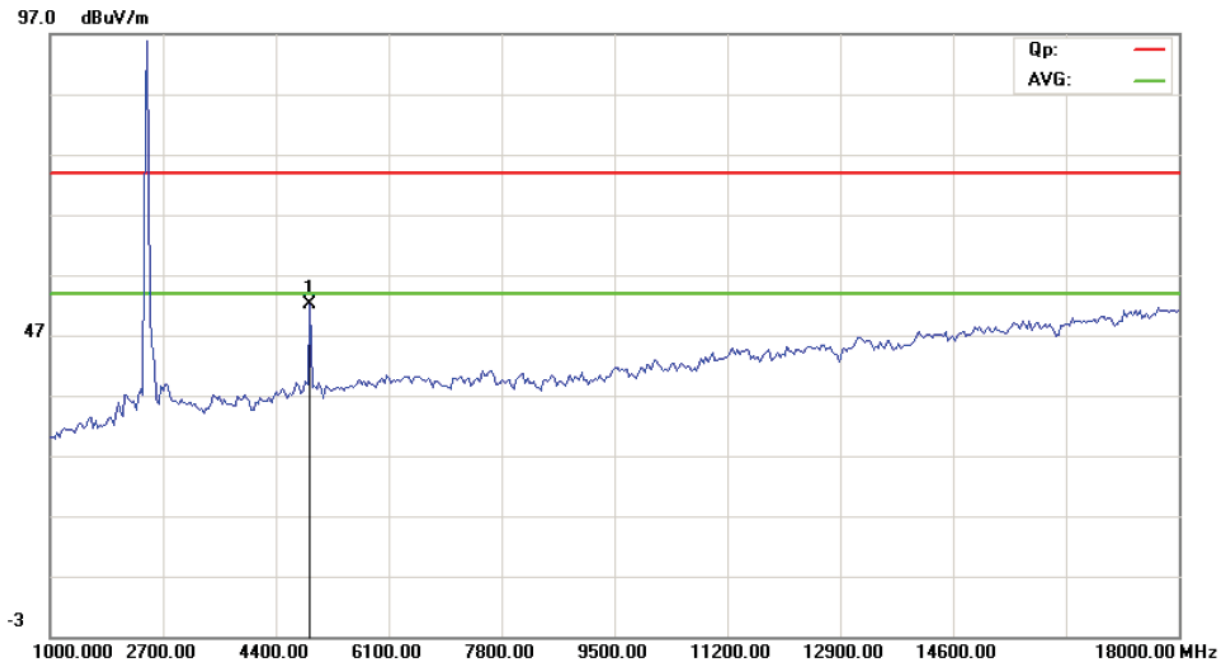


CH06 for 11g at 54Mbps: Horizontal

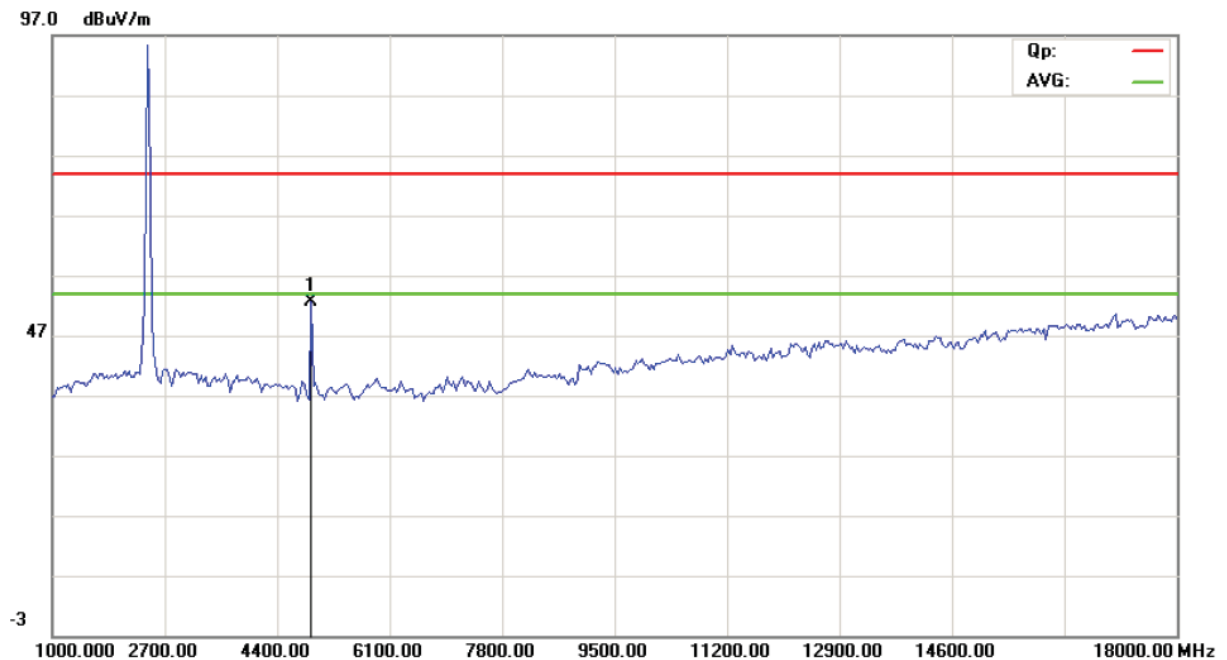

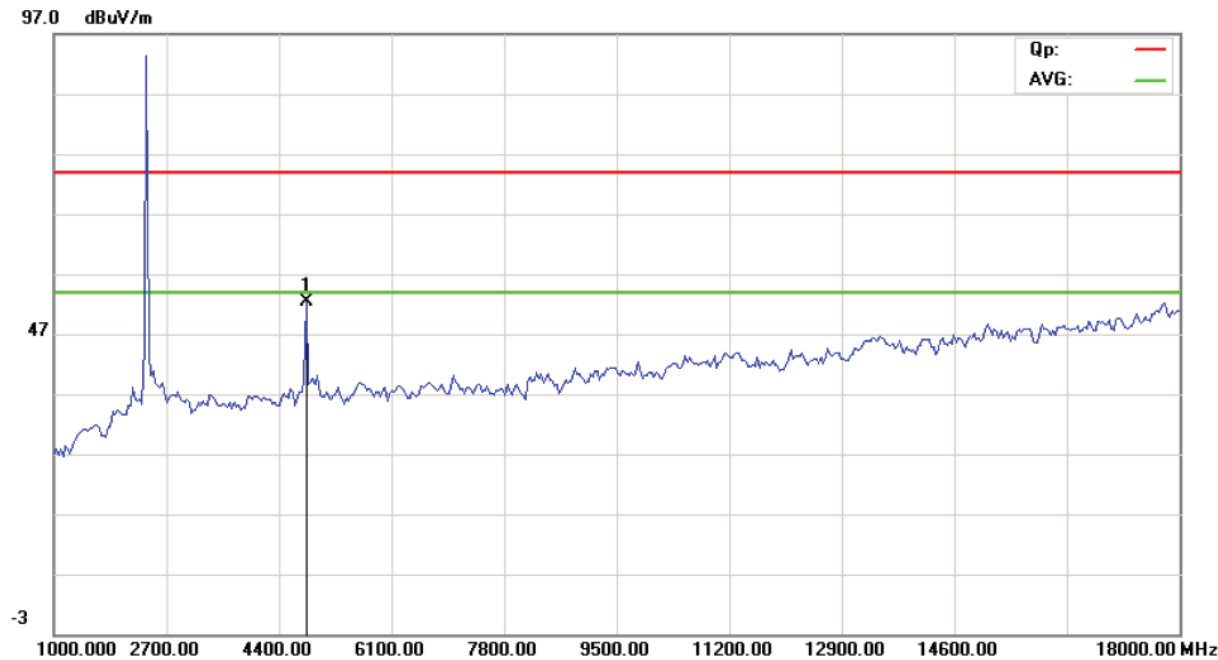

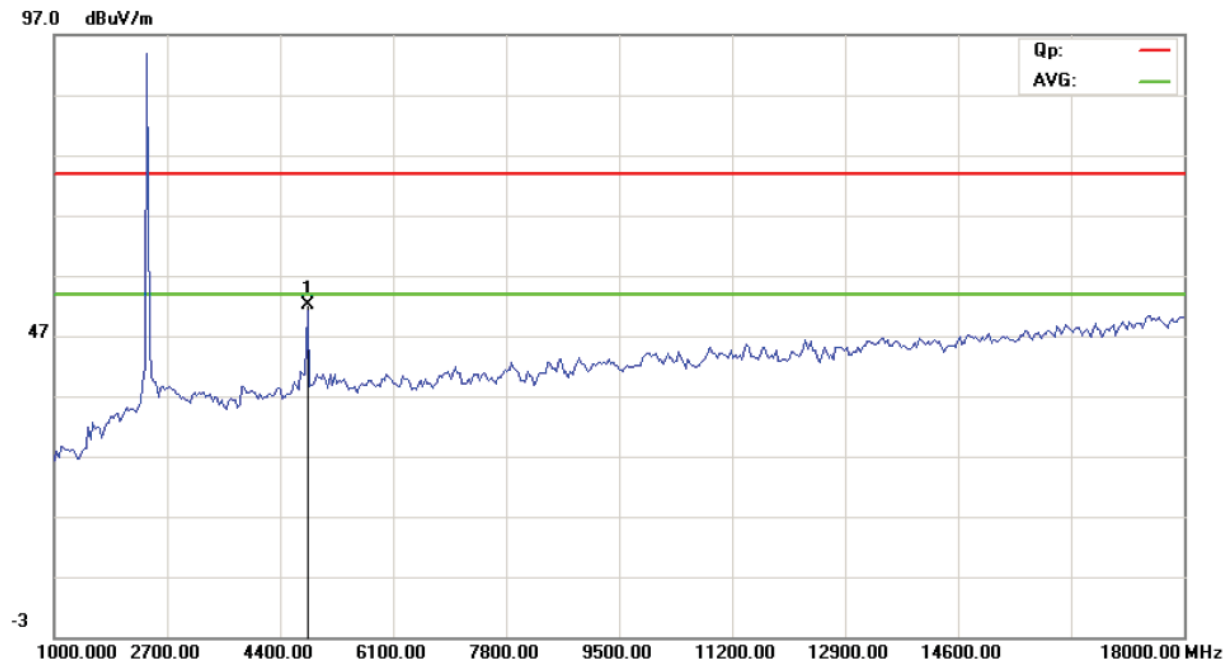

**CH01 for 11b at 11Mbps: Horizontal**



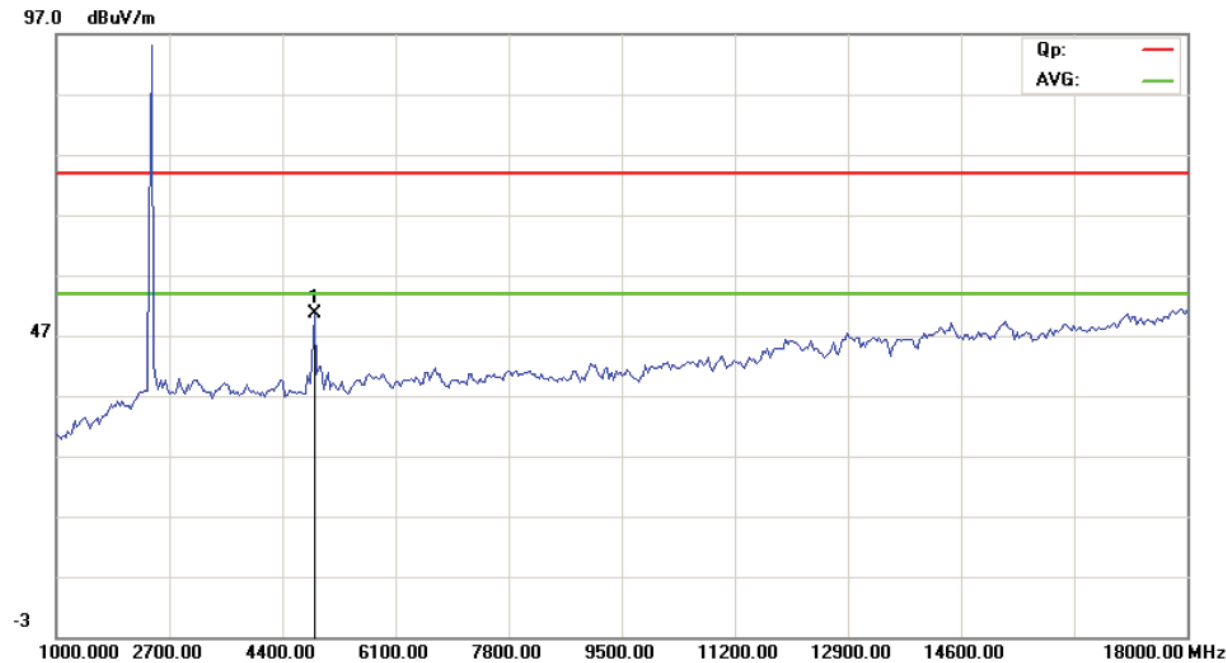

**CH01 for 11n HT40 at 6.5Mbps: Horizontal**



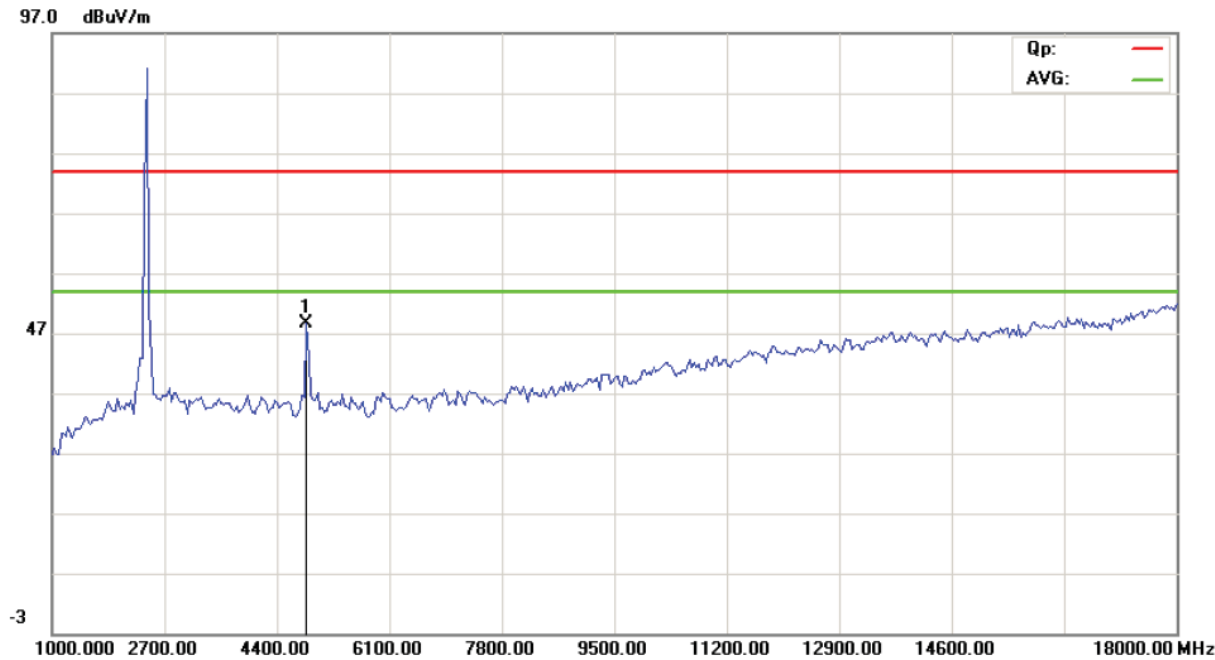
