You will hear...

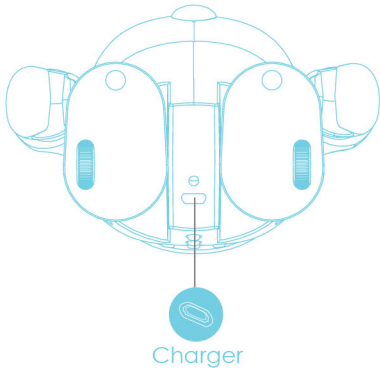
hello, I'm Choicee Qee Robot

Hold the switch for 5 seconds and the Bluetooth light should start to blink.

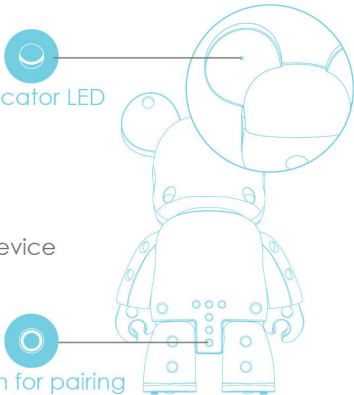
In the smart phone Bluetooth menu, search for the device and select the device name "Choicee Qee Robot" to pair it.

Pair it and your done!

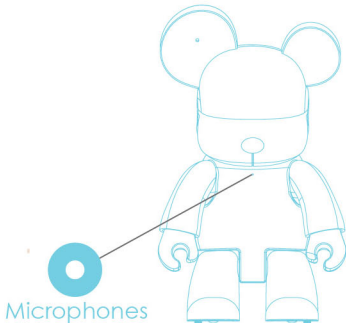
Indicator LED

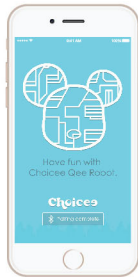
