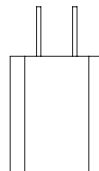
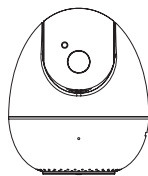
Flash blue slowly : waiting for a wi-fi network configuration.

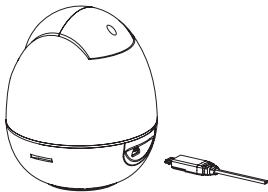


■ Installing

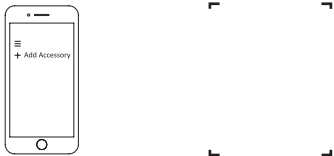
1. Please install waciao APP on App Store first.



2. Connect the two ends of the USB cable respectively to the device and power adapter, and plug in the power. When the blue light starts to flash, can be paired



3. Open waciao APP, create a home , join a device, scan QR CODE, or enter a passcode manually.



Note: To add more accessories (or repeat the outlet setup process), tap the "+" icon and then tap "Add accessory".

■ Restore factory settings

Connect the device to a power source. Press the reset button for 5 seconds, until the LED light flashes in blue slowly that indicates you have restored the IPCamera to factory settings.
