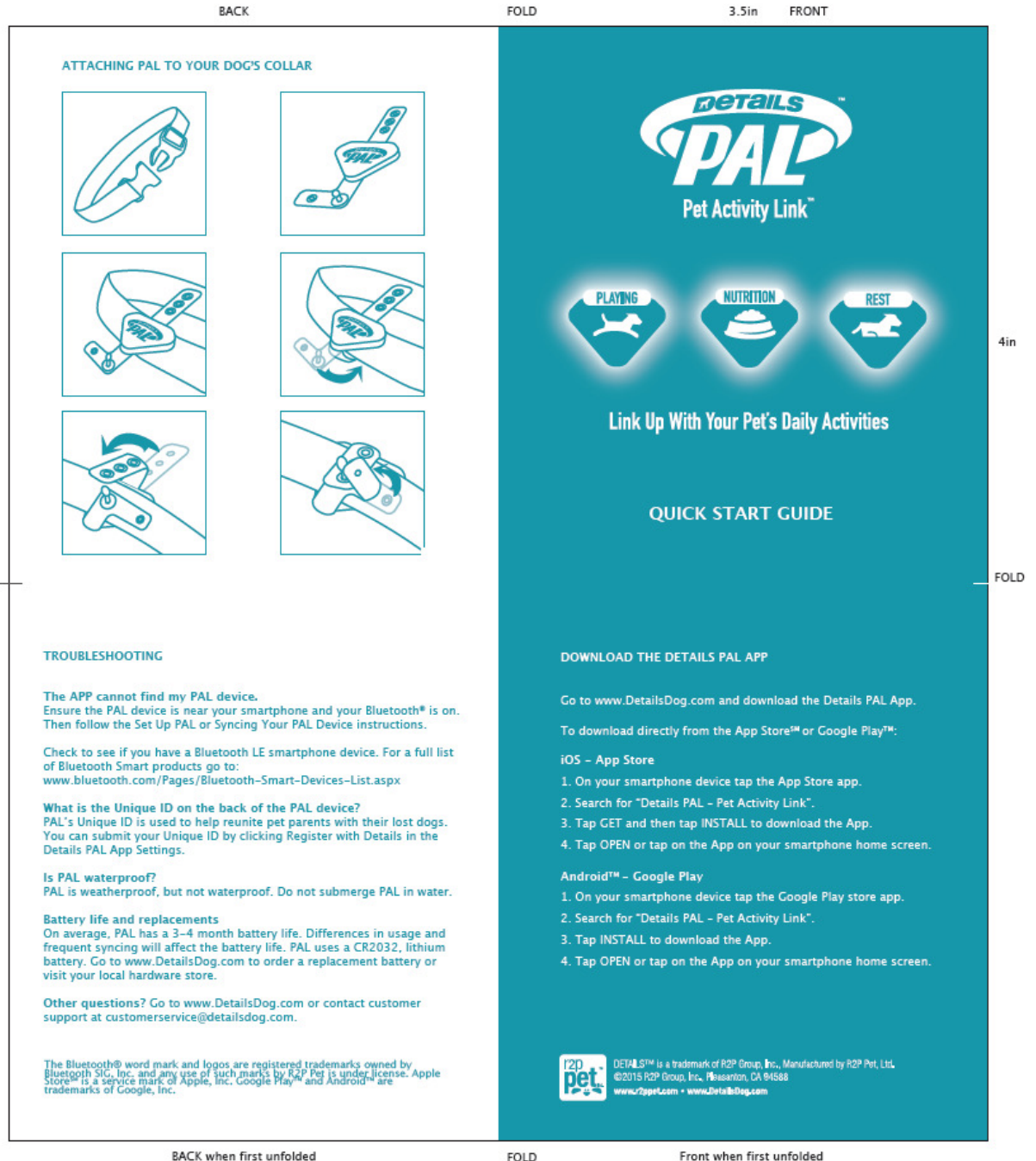

MIDDLE

CREATE AN ACCOUNT & SET UP PAL

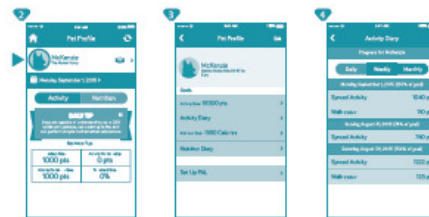
1. On your smartphone – home screen, open the Details PAL App.
2. Tap an icon to create a new Account (Facebook, Twitter, Email).
3. Create your dog's profile and tap DEVICE SET UP.
4. Tap YES WE HAVE A DETAILS PAL.
5. Follow the instructions to setup your PAL device:
 - a. To wake your PAL up from sleep mode use a pen, paper clip or other small pointed object to press the button on the back of the device.
 - b. Hold the button down until the LED lights on the front of the device begin to blink.

You're all set! The device is now in broadcast mode and can begin tracking your dog's activity. The App will determine your dog's Activity Goal 24 hours after the initial sync.



VIEWING YOUR DOG'S ACTIVITY/NUTRITION DIARY AND GOAL

1. In the Details PAL App, tap on your pet's profile.
2. Tap on your dog's photo in the top left corner of the screen.
3. View your dog's Activity and Nutrition Goals.
4. Tap on the Activity or Nutrition Diary to see your pet's daily, weekly and monthly progress.



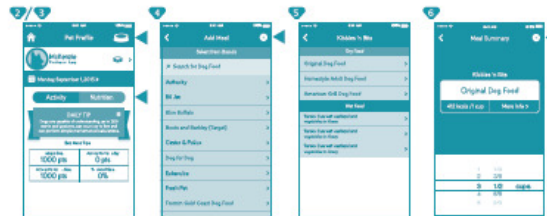
SYNCING YOUR PAL DEVICE

1. On your smartphone – home screen, open the Details PAL App.
2. Login.
3. Tap on your pet's profile.
4. Tap the sync (c) button in the top right corner of the screen.
5. Tap SYNC WITH PAL.



LOGGING YOUR DOG'S FOOD

1. In the Details PAL App, tap on your pet's profile.
2. Tap NUTRITION.
3. Tap the dog food bowl in the top right hand corner of the screen.
4. Select your dog's brand of dog food from the list or tap the plus (+) button to manually add a dog food brand.
5. Choose the type of food (dry or wet).
6. Set the serving size and tap the plus (+) button in the top right hand corner to add the food.
