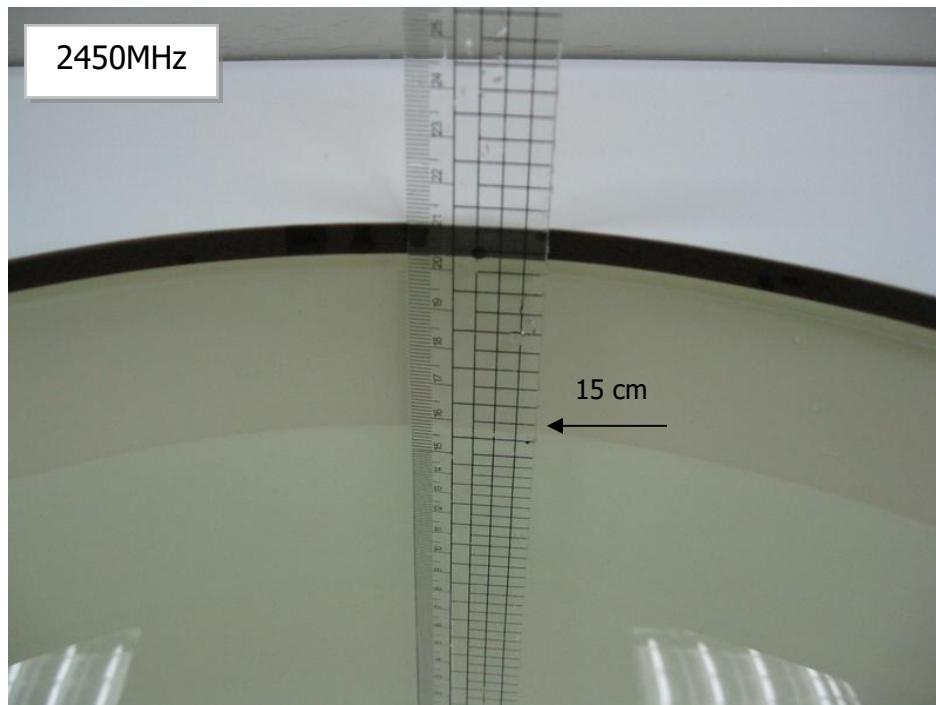

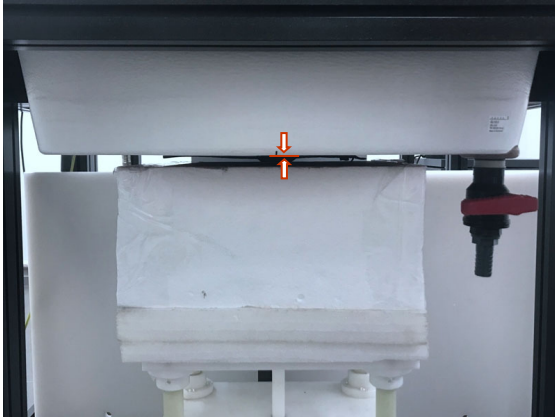

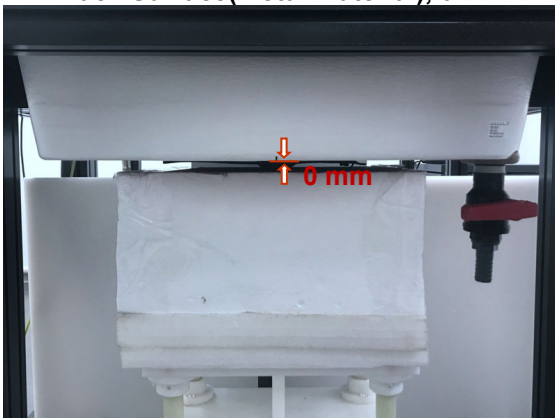
Extremity - distance between flat phantom and EUT is 0 mm

Back Surface(KY material), 0mm**

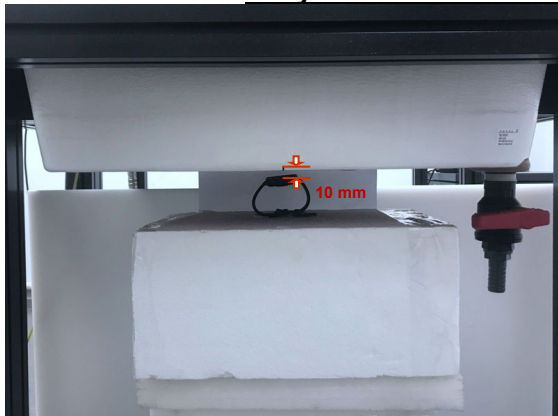

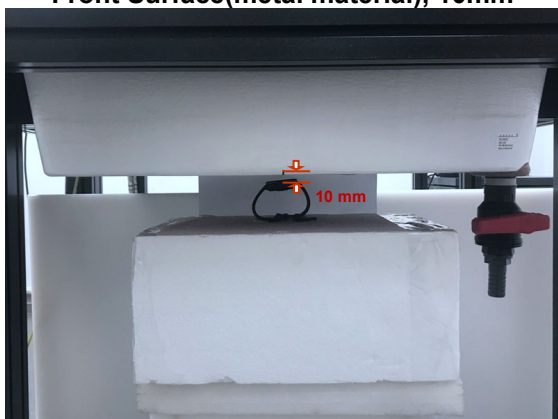

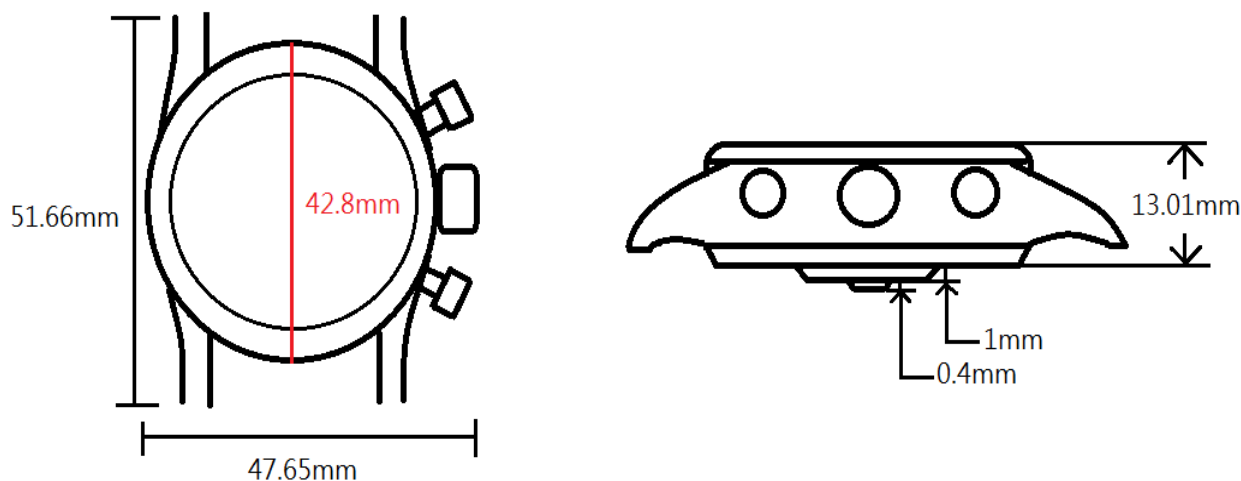
