To Whom It May Concern:

This letter is to request Limited Modular Approval in accordance with FCC Rule Part 15.212(b) for the certification request under FCC ID: 2AE05-PT-704. This product is a 2.4GHz Ranging Radio Module and can be used in Railway Worker Personal Alert Devices.

Declaration of conditions.

N	(i) The radio elements of the module have their own shielding. The physical crystal and tuning capacitors may be located external to the shielded radio elements
Y	(ii) The module has buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with part 15 requirements under conditions of excessive data rates or over-modulation.
N	(iii) The module has its own power supply regulation.
Y	(iv) The module complies with the antenna and transmission system requirements of §§15.203, 15.204(b) and 15.204(c). The antenna(s) are either permanently attached or employ a "unique" antenna coupler (at all connections between the module and the antenna, including the cable).
