### Inquiry on 01/15/2016 :

#### Inquiry:

I am currently in process of submitting a product for approval through the TCB and they have requested that I receive approval for the label placement directly from the FCC. The product in question will have the FCC ID of 2AERJ-O-01 and is a hunting dog tracking collar. I am attaching a document of the label placement in the unit and our justification document. If you have further questions after reviewing the documents, please contact me.

### FCC response on 01/27/2016

There are two conditions that you need to add to justify your request.

1. Justification that this location is the only practical place to put the FCC ID.
2. The part must be unique to this certification product. The concern is that a similar removable part can be used that contains a different label.

I have updated our Justification Document with the two conditions you mention. Please review and respond.

### FCC response on 02/01/2016

I am having an issue understanding the below language. It should be clear that it is a

unique part for this dog collar under this FCC ID.

the issue is the statement.

It is unique to any other Dog Collar system on the market.

The antenna access panel is a custom molded plastic part which is designed to fit around the antennas and attach to the collar base. It is unique to any other Dog Collar system on the market.

---Reply from Customer on 02/01/2016---

The meaning behind "It is unique to any other Dog Collar system on the market." is that the antenna access panel is only designed to fit this system with this FCC ID. The panel is not made to fit any other product from this manufacturer or any products from any other manufacturer.

#### **FCC response on 02/01/2016**

You have to change

"It is unique to any other Dog Collar system on the market"

to

"The access panel is only designed to fit this system with this FCC ID and is not made to fit any other product from this manufacturer or any products from any other manufacturer."

I understand the second wording. The first seems to say that it is for all dog collars.

I have updated the Justification document with the preferred wording. Is this acceptable? Are we approved on the label placement?
