


Figure 3.6-1: Setup diagram

### 6.1 Uncertainty of measurement

---

UKAS Lab 34 and TIA-603-B have been used as guidance for measurement uncertainty reasonable estimations with regards to previous experience and validation of data. Nemko Canada, Inc. follows these test methods in order to satisfy ISO/IEC 17025 requirements for estimation of uncertainty of measurement for wireless products.

Measurement uncertainty budgets for the tests are detailed below. Measurement uncertainty calculations assume a coverage factor of  $K = 2$  with 95% certainty.

### 8.1 FCC 15.31(e) Variation of power source

---

#### 8.1.1 Definitions and limits

---

##### FCC §15.31:

(e) For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. For battery operated equipment, the equipment tests shall be performed using a new battery.

#### 8.1.2 Test date

#### 8.1.3 Observations, settings and special notes

---

The testing was performed as per ANSI C63.10 Section 5.13.

- a) Where the device is intended to be powered from an external power adapter, the voltage variations shall be applied to the input of the adapter provided with the device at the time of sale. If the device is not marketed or sold with a specific adapter, then a typical power adapter shall be used.
- b) For devices where operating at a supply voltage deviating  $\pm 15\%$  from the nominal rated value may cause damages or loss of intended function, test to minimum and maximum allowable voltage per manufacturer's specification and document in the report.
- c) For devices with wide range of rated supply voltage, test at 15% below the lowest and 15% above the highest declared nominal rated supply voltage.
- d) For devices obtaining power from an input/output (I/O) port (USB, firewire, etc.), a test jig is necessary to apply voltage variation to the device from a support power supply, while maintaining the functionalities of the device.

For battery-operated equipment, the equipment tests shall be performed using a variable power supply.

#### 8.1.4 Test data

---

The EUT AC Input supply voltage was varied between 85% and 115% of the nominal rated supply voltage. No change to transmitter performance was observed.

## 8.2 FCC 15.31(m) Number of frequencies

### 8.2.1 Definitions and limits

#### FCC §15.31:

(m) Measurements on intentional radiators or receivers, other than TV broadcast receivers, shall be performed and, if required, reported for each band in which the device can be operated with the device operating at the number of frequencies in each band specified in the following table:

*Table 8.2-1: Frequency Range of Operation*

### 8.2.3 Observations, settings and special notes

#### Per ANSI C63.10 Subclause 5.6.2.1:

The number of channels tested can be reduced by measuring the center channel bandwidth first and then applying the following relaxations as appropriate:

- a) For each operating mode, if the measured channel bandwidth on the middle channel is at least 150% of the minimum permitted bandwidth, then it is not necessary to measure the bandwidth on the high and low channels.
- b) For multiple-input multiple-output (MIMO) systems, if the measured channel bandwidth on testing the middle channel exceeds the minimum permitted bandwidth by more than 50% on one transmit chain, then it is not necessary to repeat testing on the other chains.
- c) If the measured channel bandwidth on the middle channel is less than 50% of the maximum permitted bandwidth, then it is not necessary to measure the bandwidth on the high and low channels.

#### Per ANSI C63.10 Subclause 5.6.2.2:

For devices with multiple operating modes, measurements on the middle channel can be used to determine the worst-case mode(s). The worst-case modes are as follows:

- a) Band edge requirements—Measurements on the mode with the widest bandwidth can be used to cover the same channel (center frequency) on modes with narrower bandwidth that have the same or lower output power for each modulation family (e.g., OFDM and direct sequence spread spectrum).
- b) Spurious emissions—Measure the mode with the highest output power and the mode with the highest output power spectral density for each modulation family (e.g., OFDM and direct sequence spread spectrum).
- c) In-band PSD—Measurements on the mode with the narrowest bandwidth can be used to cover all modes within the same modulation family of an equal or lower output power provided the result is less than 50% of the limit.

## 8.3 FCC 15.203 Antenna requirement

---

### 8.3.1 Definitions and limits

---

#### FCC §15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.

## 8.4 FCC 15.207(a) AC power line conducted emissions limits

### 8.4.1 Definitions and limits

#### FCC §15.207:

a) Except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table, as measured using a 50  $\mu$ H/50  $\Omega$  line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

ANSI: C63.10 subclause 6.2

If the EUT normally receives power from another device that in turn connects to the public utility ac power lines, measurements shall be made on that device with the EUT in operation to demonstrate that the device continues to comply with the appropriate limits while providing the EUT with power. If the EUT is

operated only from internal or dedicated batteries, with no provisions for connection to the public utility ac power lines (600 VAC or less) to operate the EUT (such as an adapter), then ac power-line conducted measurements are not required.

For direct current (dc) powered devices where the ac power adapter is not supplied with the device, an "off-the-shelf" unmodified ac power adapter shall be used. If the device is supposed to be installed in a host (e.g., the device is a module or PC card), then it is tested in a typical compliant host.




Figure 8.4-1: AC power line conducted emissions – spectral plot on phase line




Figure 8.4-2: AC power line conducted emissions – spectral plot on neutral line

## 8.5 FCC 15.247(a)(2) Minimum 6 dB bandwidth for systems using digital modulation techniques

### 8.5.1 Definitions and limits

#### FCC §15.247 (a)(2):

(a) Operation under the provisions of this Section is limited to frequency hopping and digitally modulated intentional radiators that comply with the following provisions:

(2) Systems using digital modulation techniques may operate in the 902–928 MHz, 2400–2483.5 MHz and 5725–5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.




Figure 8.5-2: 6 dB bandwidth on mid channel




Figure 8.5-4: 99% Occupied bandwidth on low channel




Figure 8.5-5: 99% Occupied bandwidth on mid channel

## 8.6 FCC 15.247(b) (3)(4)) Transmitter output power and e.i.r.p. requirements

### 8.6.1 Definitions and limits

#### FCC §15.247:

(b) The maximum peak conducted output power of the intentional radiator shall not exceed the following:

(3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the *maximum conducted output power* is the highest total transmit power occurring in any mode.

(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.




Figure 8.6-1: Output power on low channel




Figure 8.6-2: Output power on mid channel




Figure 8.6-3: Output power on high channel

## 8.7 FCC 15.247(d) Spurious (out-of-band) unwanted emissions

### 8.7.1 Definitions and limits

#### FCC §15.247 (d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).







Figure 8.7-1: Radiated spurious emissions at the upper band edge, peak








Figure 8.7-5: Radiated spurious emissions 30 MHz – 1 GHz, low channel




Figure 8.7-6: Radiated spurious emissions 30 MHz – 1 GHz, mid channel




Figure 8.7-7: Radiated spurious emissions 30 MHz – 1 GHz, high channel




Figure 8.7-8: Radiated spurious emissions 1 – 18 GHz, low channel




Figure 8.7-9: Radiated spurious emissions 1 – 18 GHz, mid channel




Figure 8.7-10: Radiated spurious emissions 1 – 18 GHz, high channel




Figure 8.7-11: Radiated spurious emissions 18 – 25 GHz, low channel




Figure 8.7-12: Radiated spurious emissions 18 – 25 GHz, mid channel




Figure 8.7-13: Radiated spurious emissions 18 – 25 GHz, high channel




Figure 8.7-14: Conducted spurious emissions on low channel






Figure 8.7-16: Conducted spurious emissions on high channel

## 8.8 FCC 15.247(e) Power spectral density for digitally modulated devices

### 8.8.1 Definitions and limits

#### FCC §15.247 (e):

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.




Figure 8.8-1: PSD plot on low channel




Figure 8.8-2: PSD plot on mid channel






Figure 8.8-3: PSD plot on high channel


