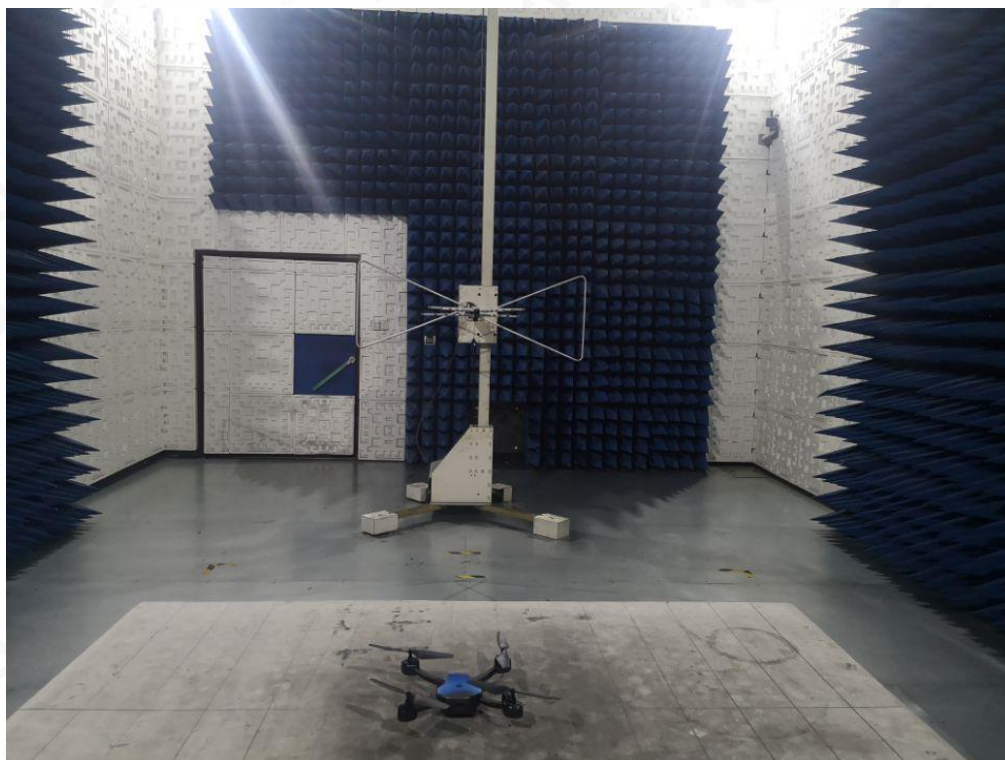

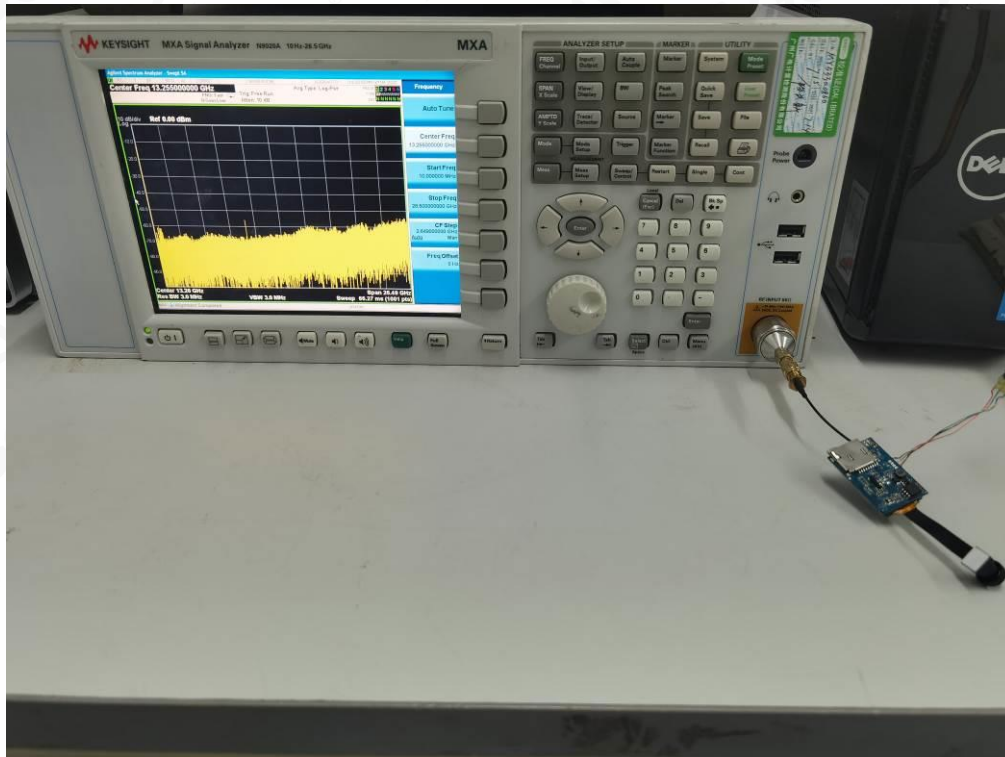

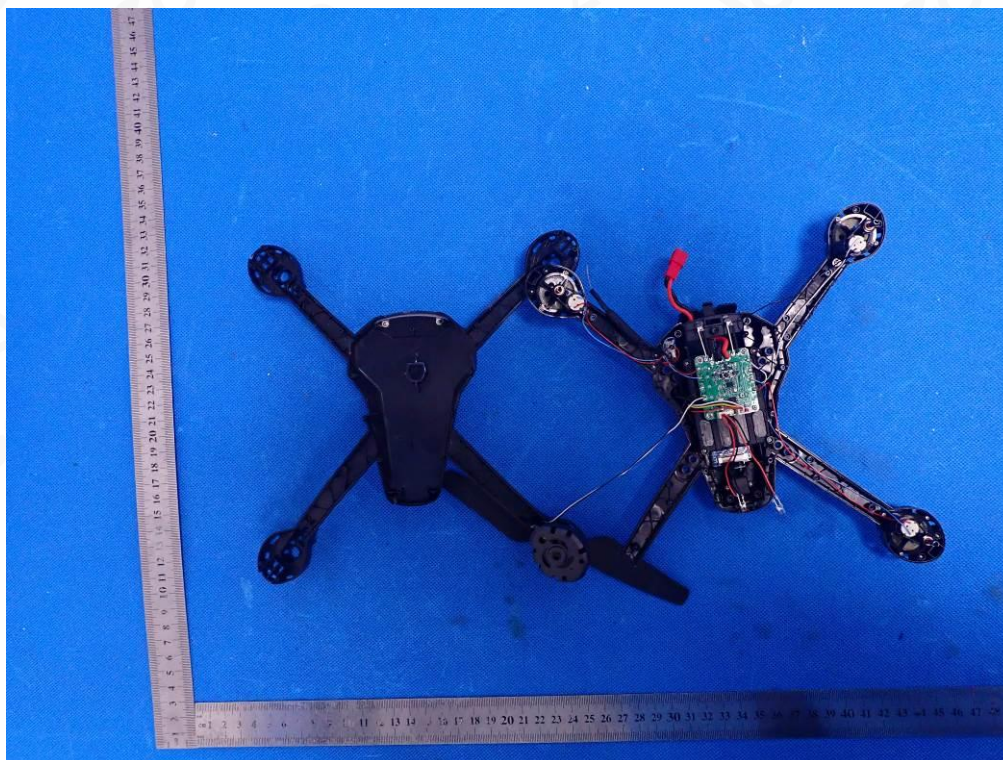




OPEN VIEW OF EUT-1

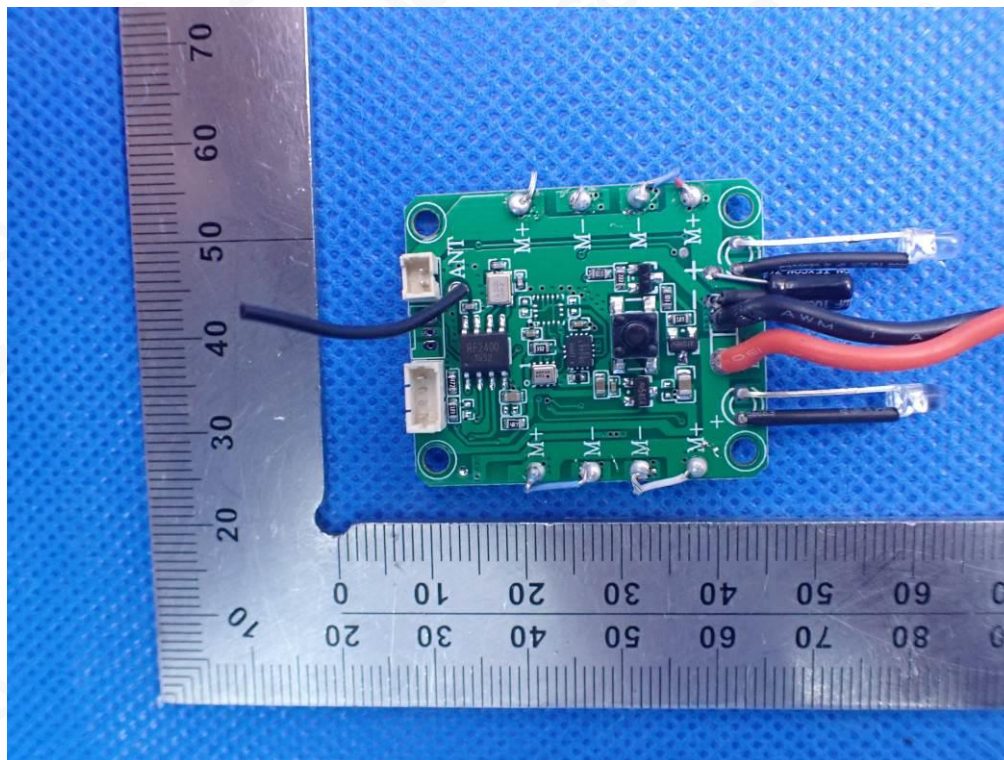

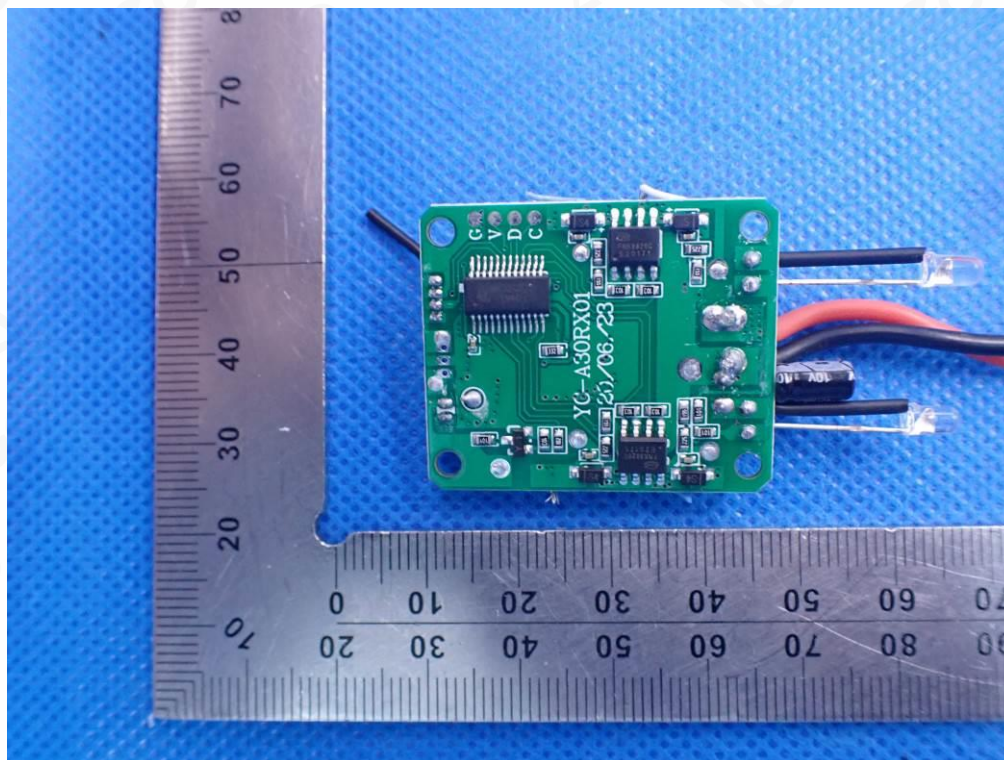




INTERNAL VIEW-1 OF EUT

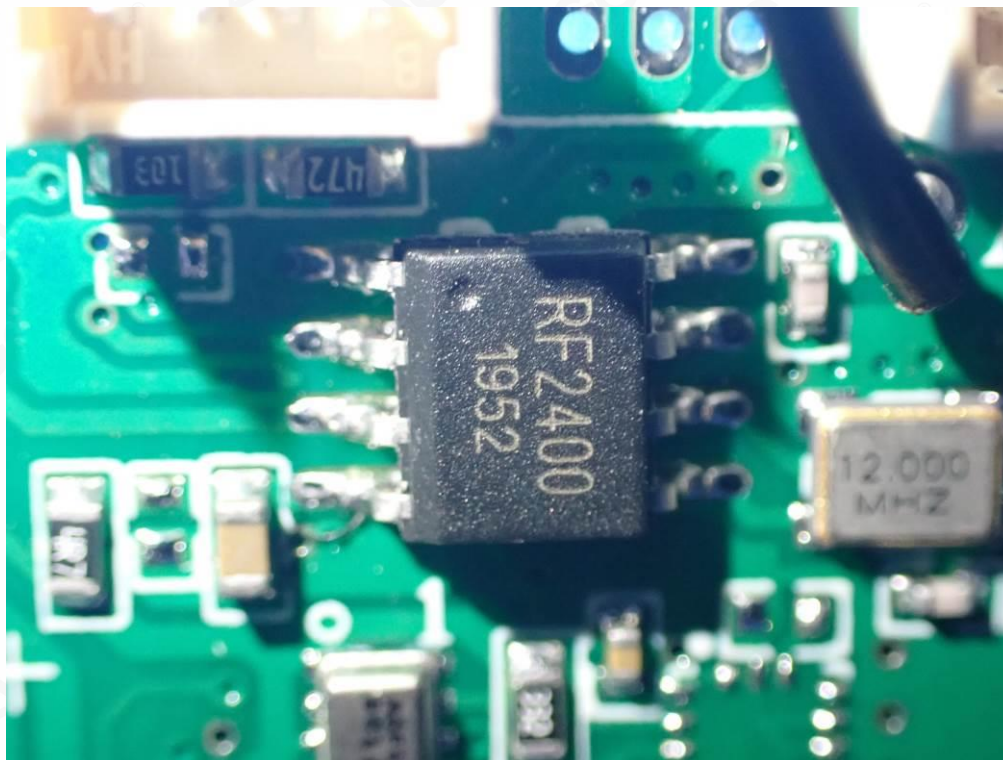

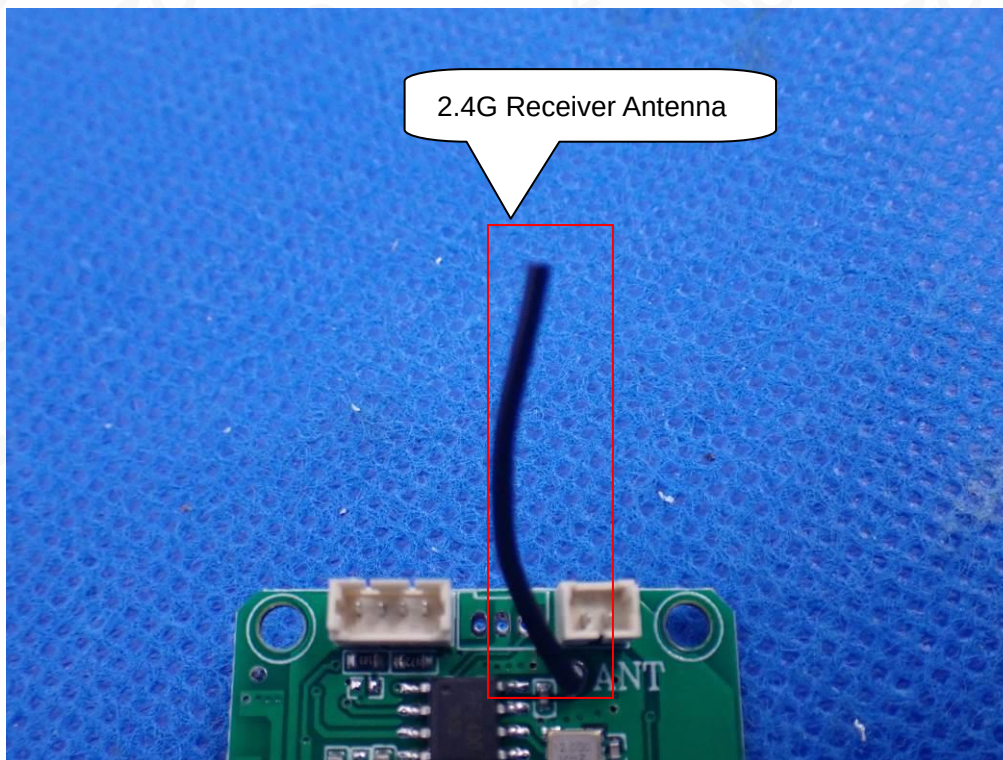




INTERNAL VIEW-3 OF EUT

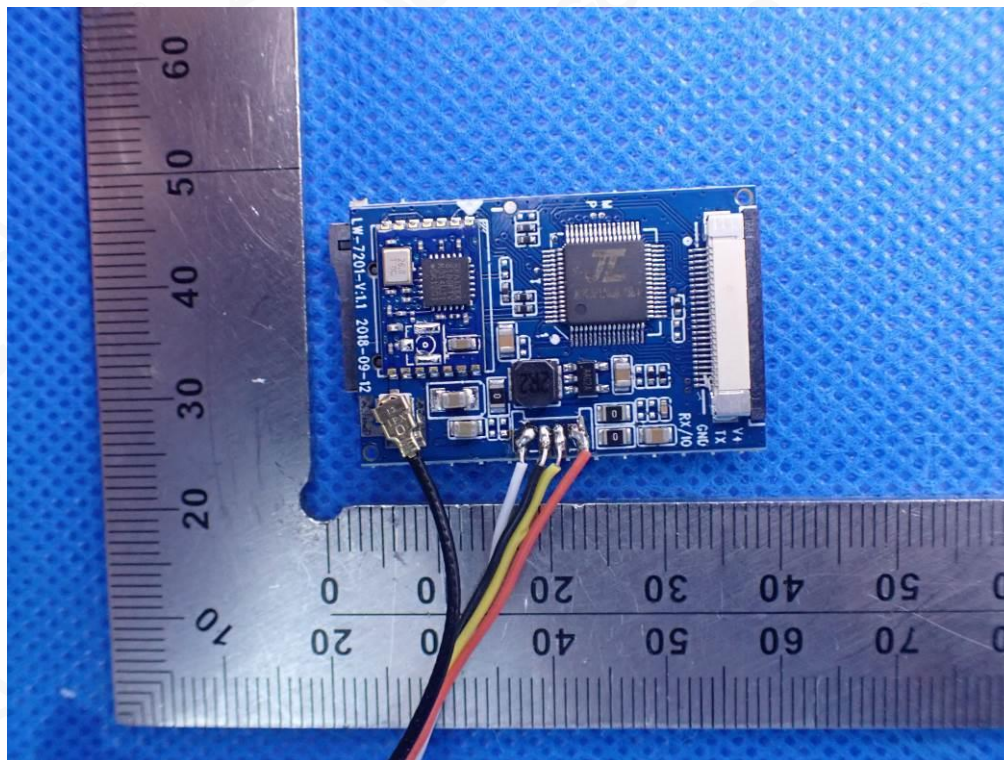

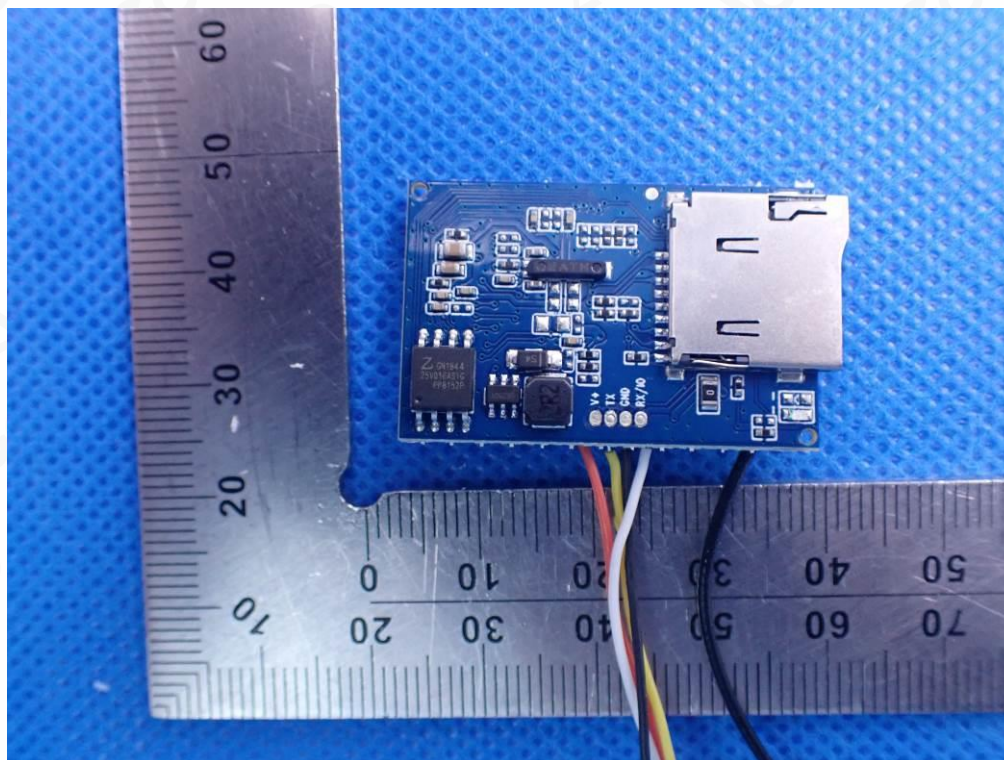




INTERNAL VIEW-5 OF EUT

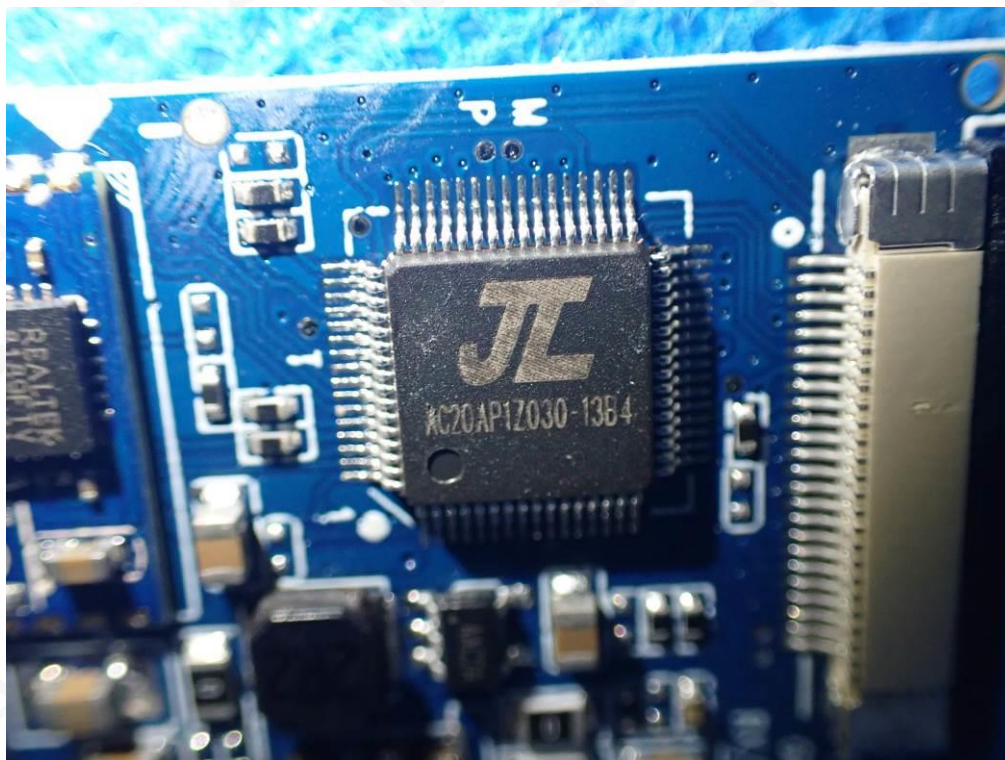

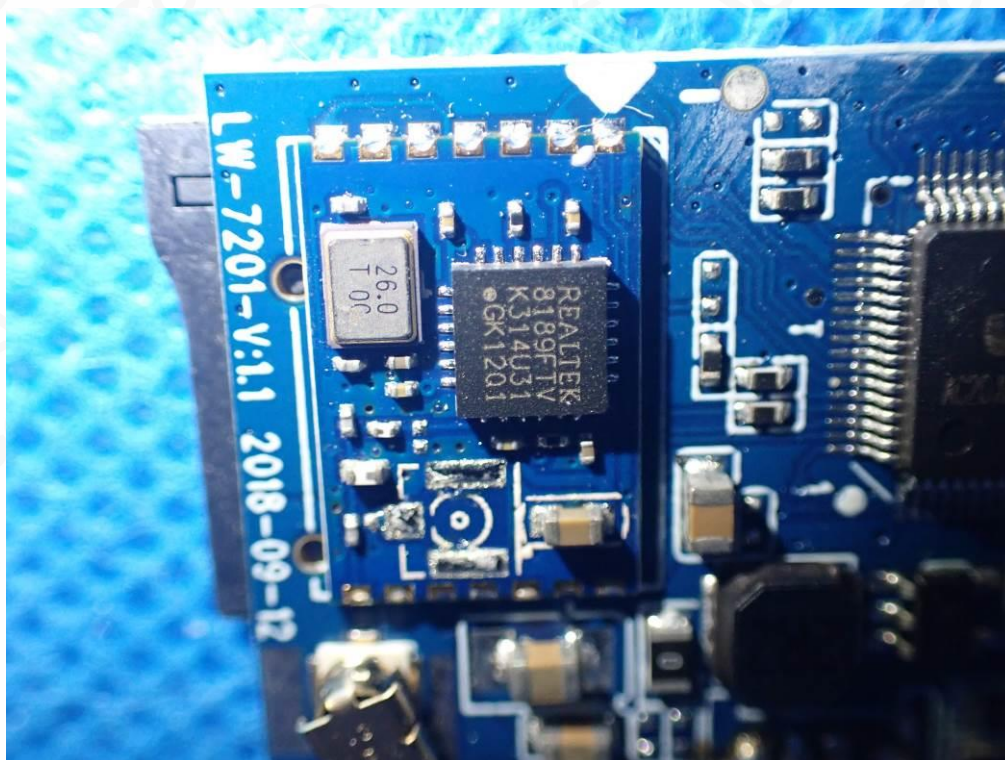




INTERNAL VIEW-7 OF EUT

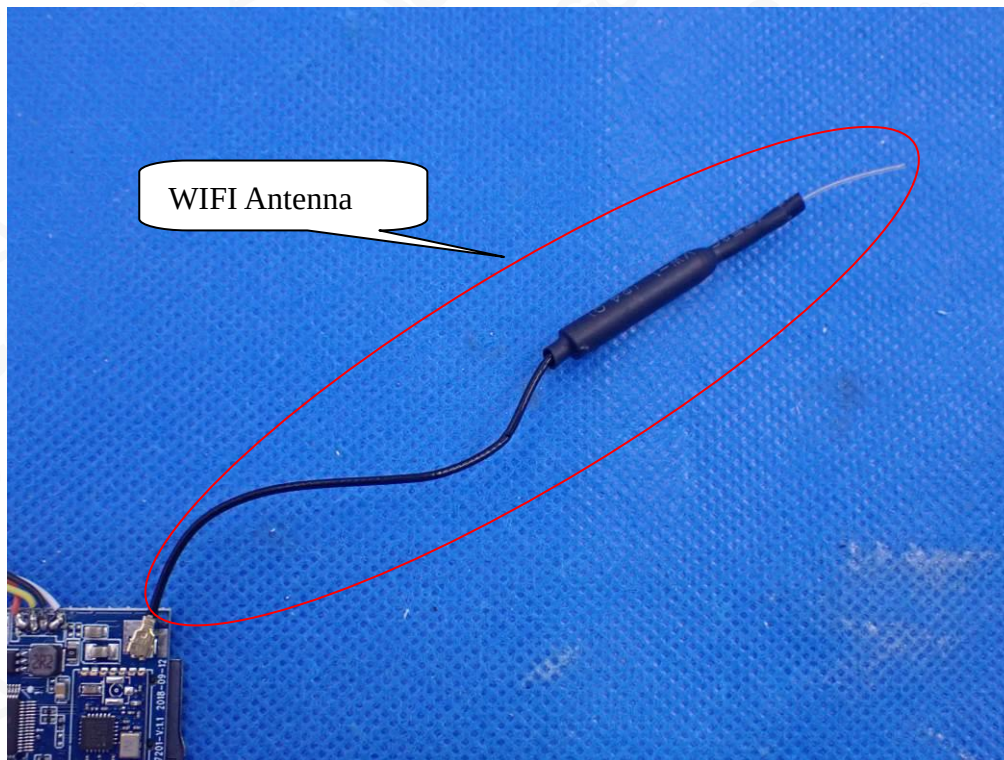
