



2.4. Short description of the Equipment under Test (EUT)

TIS001 is subscriber equipment in the WCDMA/GSM system. The HSPA/UMTS frequency band is Band II, Band IV; The GSM/GPRS/EDGE frequency band includes GSM850 and GSM900 and DCS1800 and PCS1900, but only Band II and Band V and GSM850 and PCS1900 bands test data included in this report. The Mobile Phone implements such functions as RF signal receiving/transmitting, HSPA/UMTS and GSM/GPRS/EDGE protocol processing, voice, video MMS service, GPS and WIFI etc. Externally it provides micro SD card interface, earphone port (to provide voice service) and SIM card interface. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices.

NOTE: Unless otherwise noted in the report, the functional boards installed in the units shall be selected from the below list, but not means all the functional boards listed below shall be installed in one unit.

2.5. EUT operation mode

The EUT has been tested under typical operating condition. There are EDR (Enhanced Data Rate) and BDR (Basic Data Rate) mode. The Applicant provides communication tools software to control the EUT for staying in continuous transmitting and receiving mode for testing. There are 79 channels of EUT, and the test carried out at the lowest channel, middle channel and highest channel.

1. For Radiated Emissions, By preliminary testing and verifying three axis (X, Y and Z) position of EUT transmitted status, it was found that "Y axis" position was the worst, then the final test was executed the worst condition and test data were recorded in this report.
2. For $\pi/4$ QPSK its same modulation type with 8-DPSK, and based exploratory test, there is no significant difference of that two types test result, so except output power, all other items final test were only performed with the worse case 8-DPSK and GFSK.

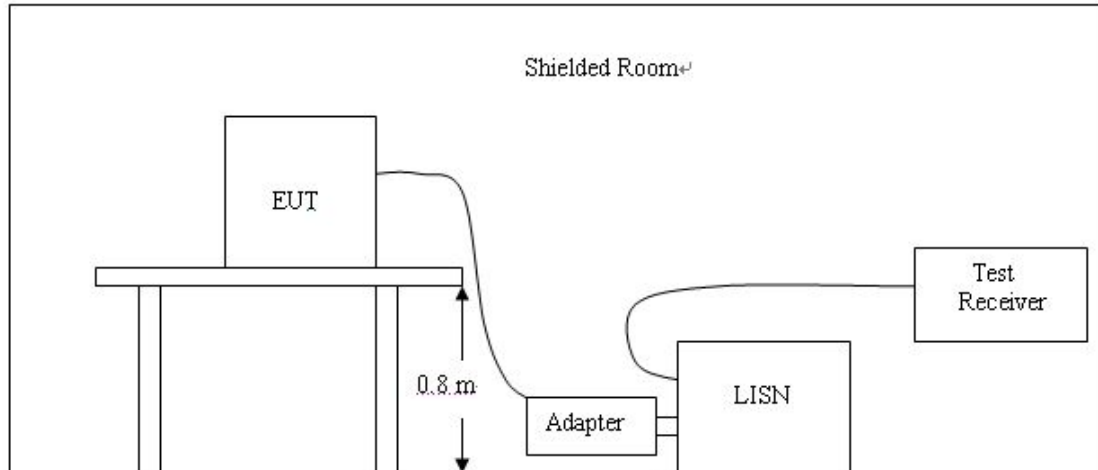

4. TEST CONDITIONS AND RESULTS

4.1. AC Power Conducted Emission

TEST PROCEDURE

1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system; a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.4-2009
2. Support equipment, if needed, was placed as per ANSI C63.4-2009
3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.4-2009
4. The EUT received DC5V power from the adapter, the adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
5. All support equipments received AC power from a second LISN, if any.
6. The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
7. Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
8. During the above scans, the emissions were maximized by cable manipulation.

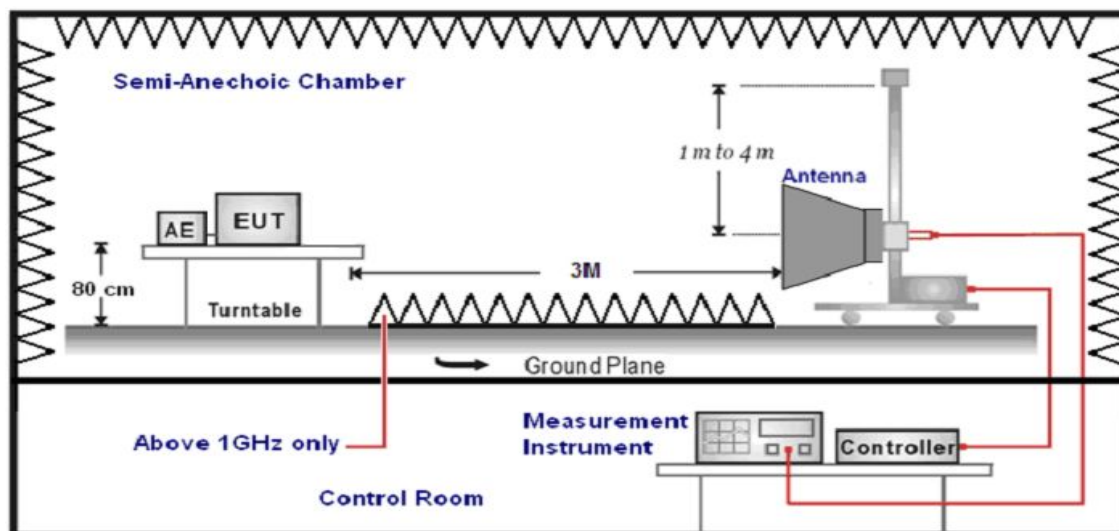

TEST PROCEDURE

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0°C to 360°C to acquire the highest emissions from EUT.
3. For the radiated emission test above 1GHz:
Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
4. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
5. Repeat above procedures until all frequency measurements have been completed.
6. The EUT minimum operation frequency was 32.768 KHz and maximum operation frequency was 2480MHz.so radiated emission test frequency band from 9 KHz to 25GHz.

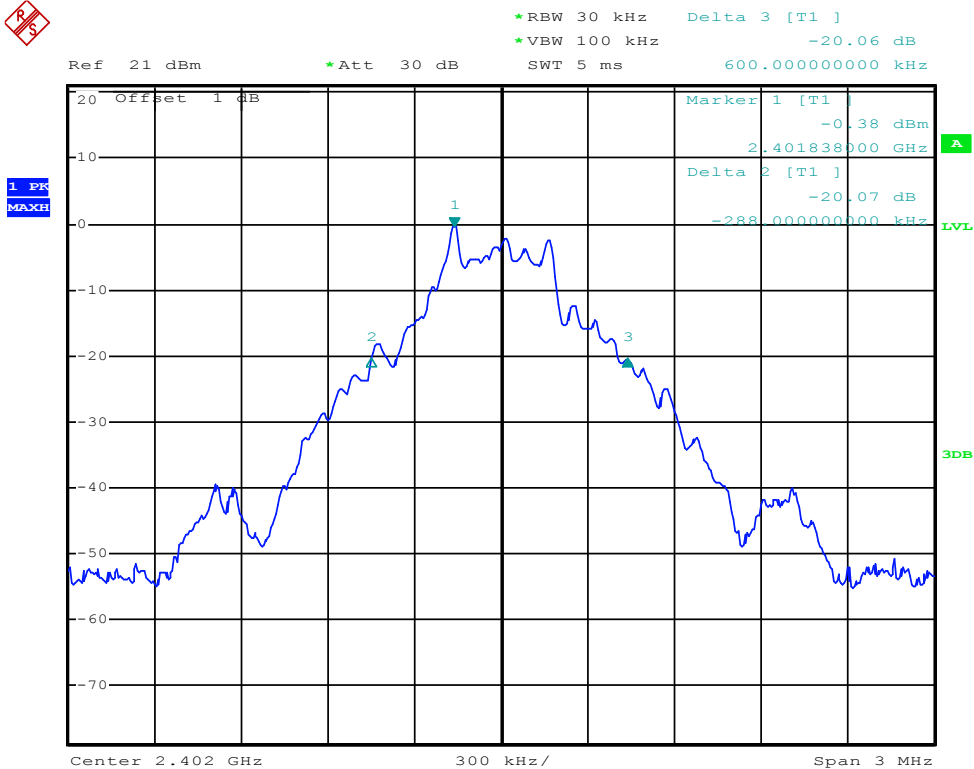

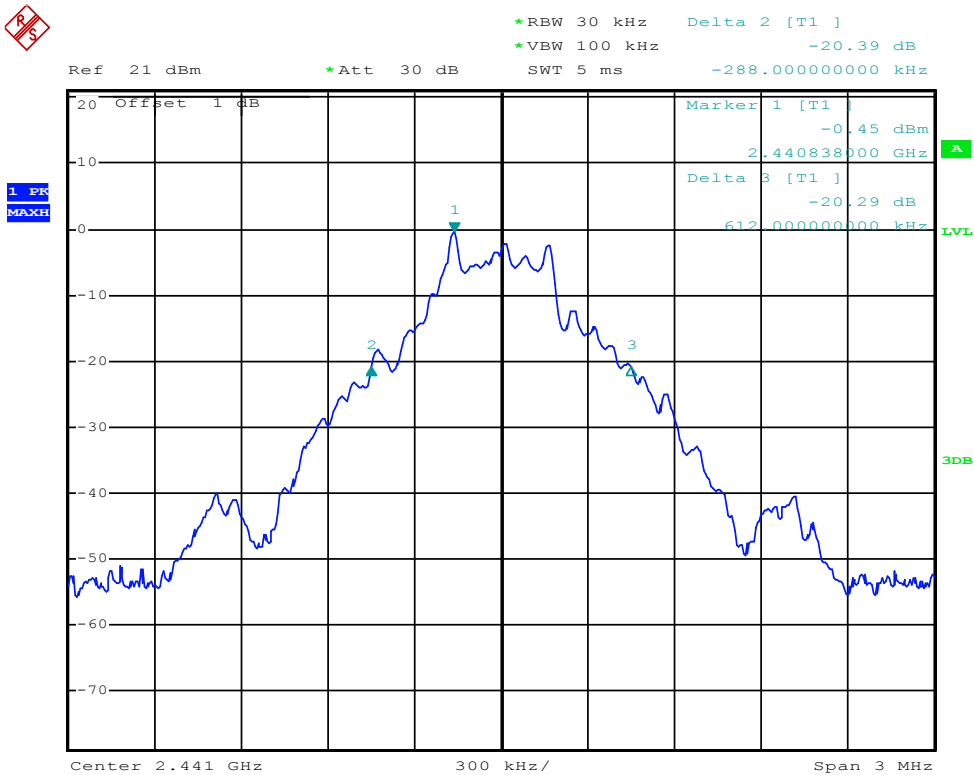

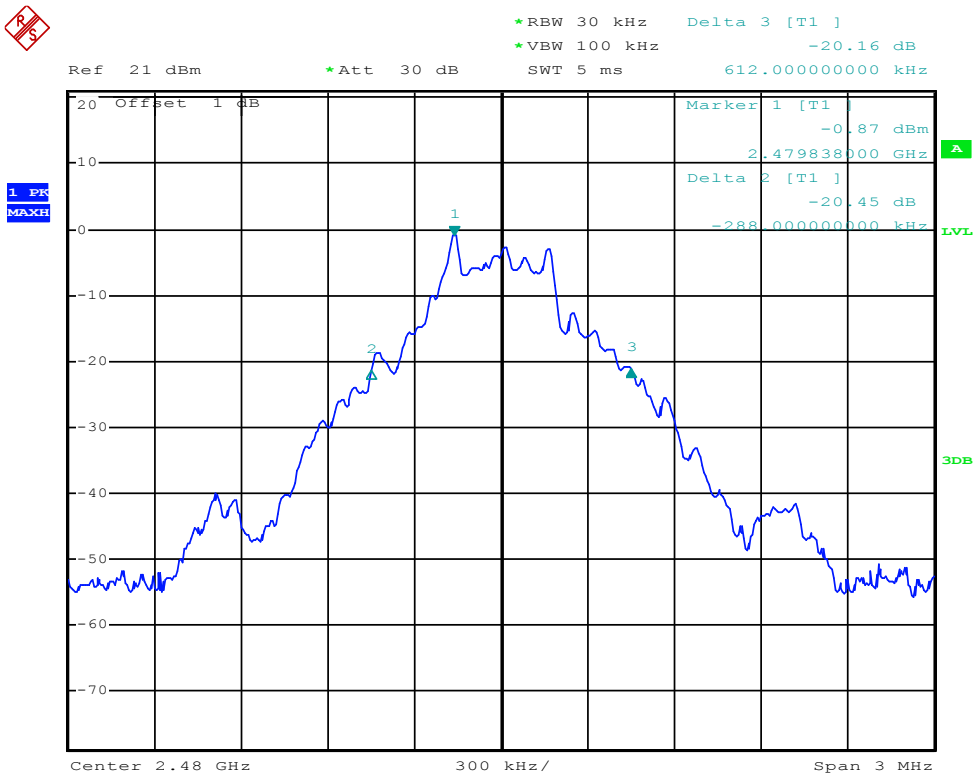

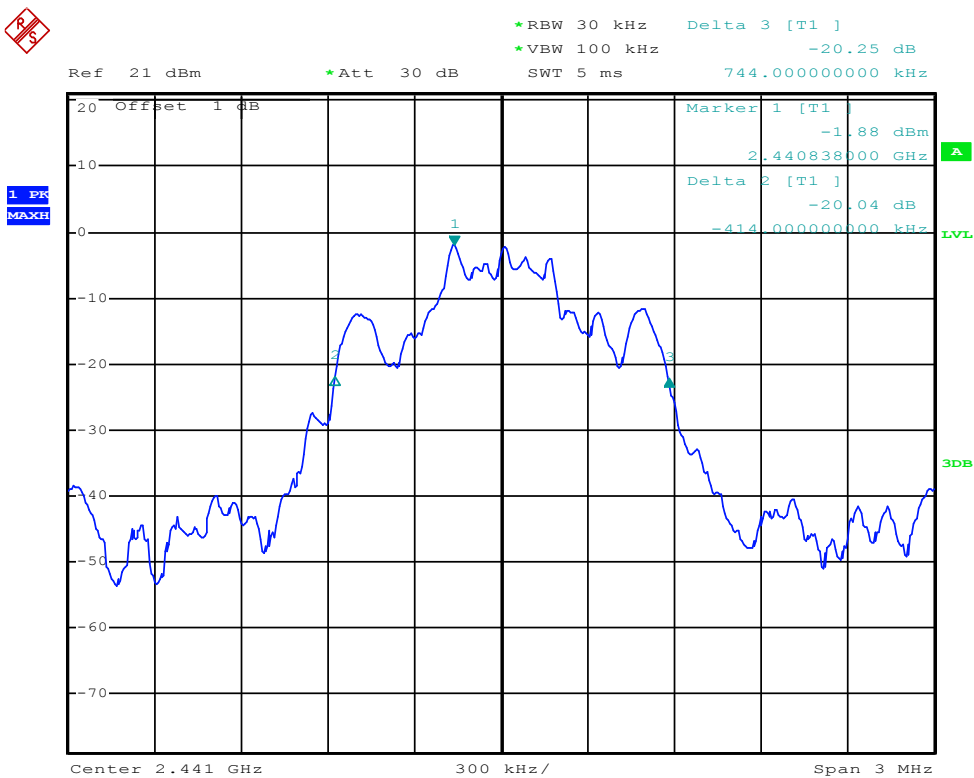
(Plot 4.4.1 A: Channel 00: 2402MHz @ GFSK)



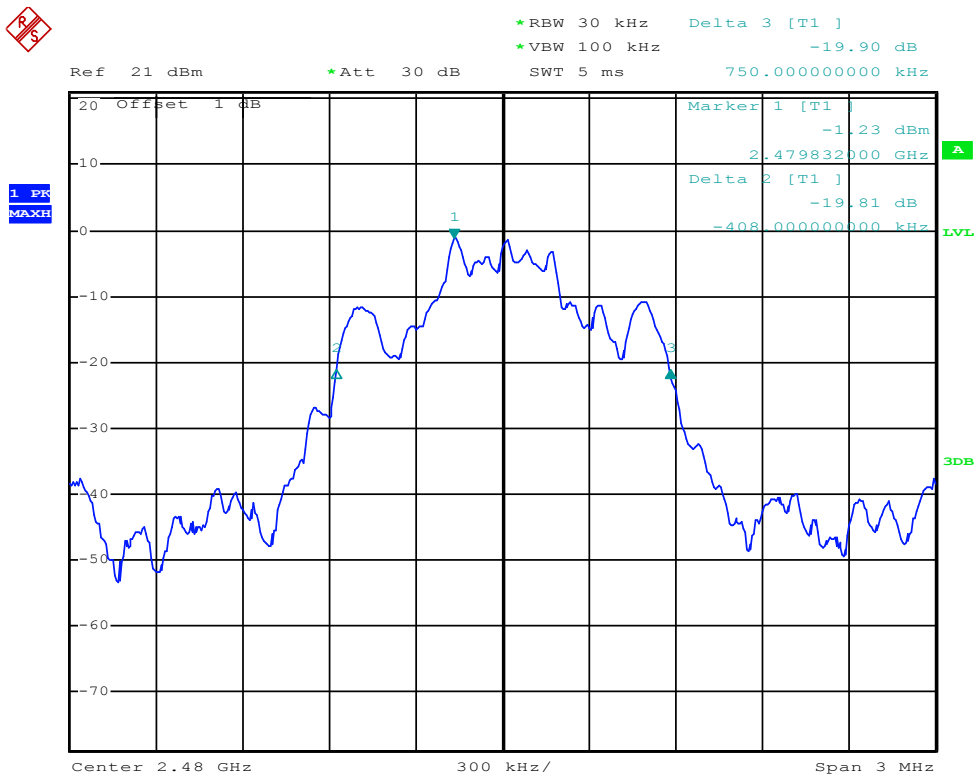
(Plot 4.4.1 B: Channel 39: 2441MHz @ GFSK)

4.5. Band Edge

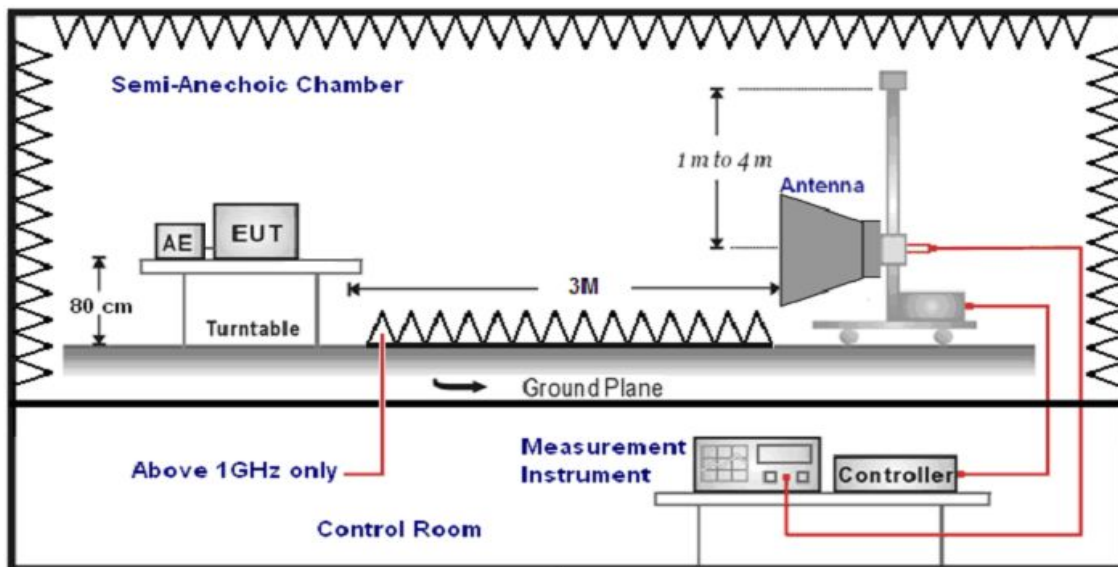

Attenuation below the general limits specified in §15.209(a) is not required. TEST PROCEDURE

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to a EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
3. Set RBW of spectrum analyzer to 100 kHz and VBW of spectrum analyzer to 300KHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz.

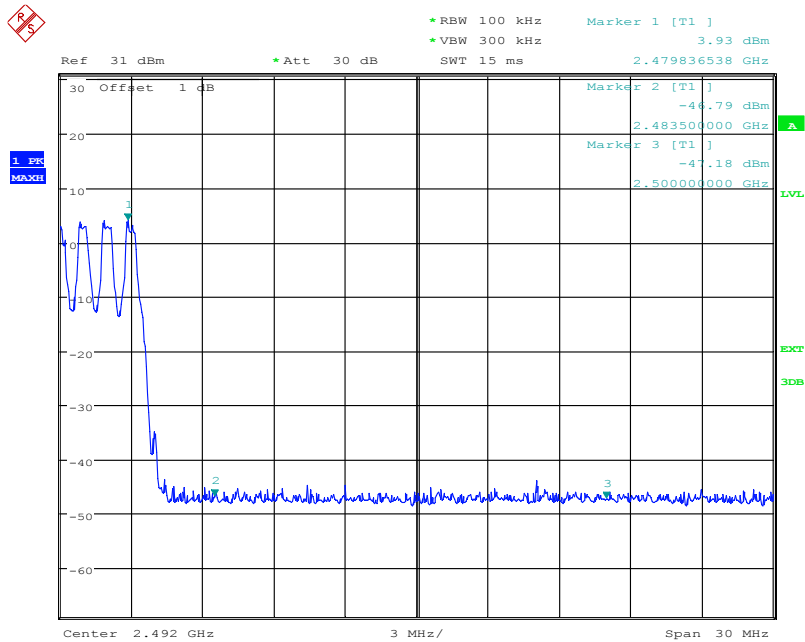

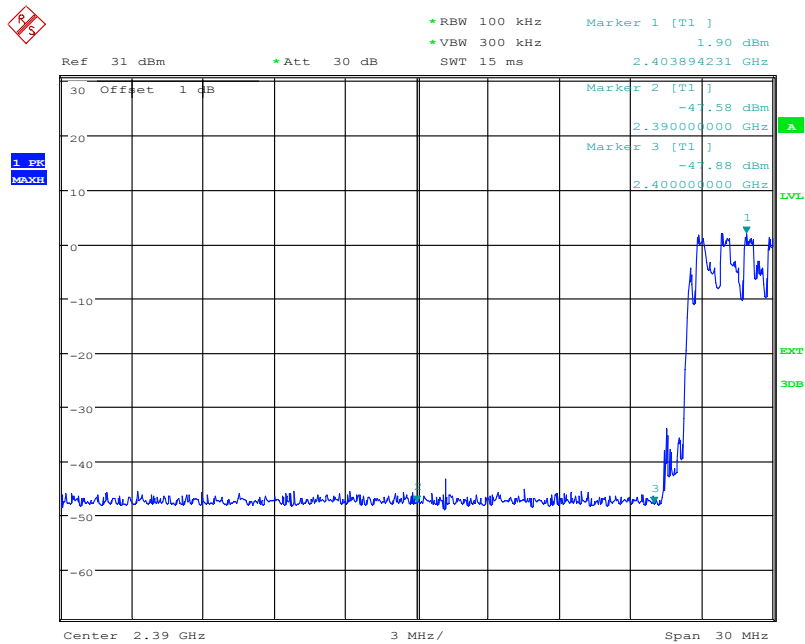

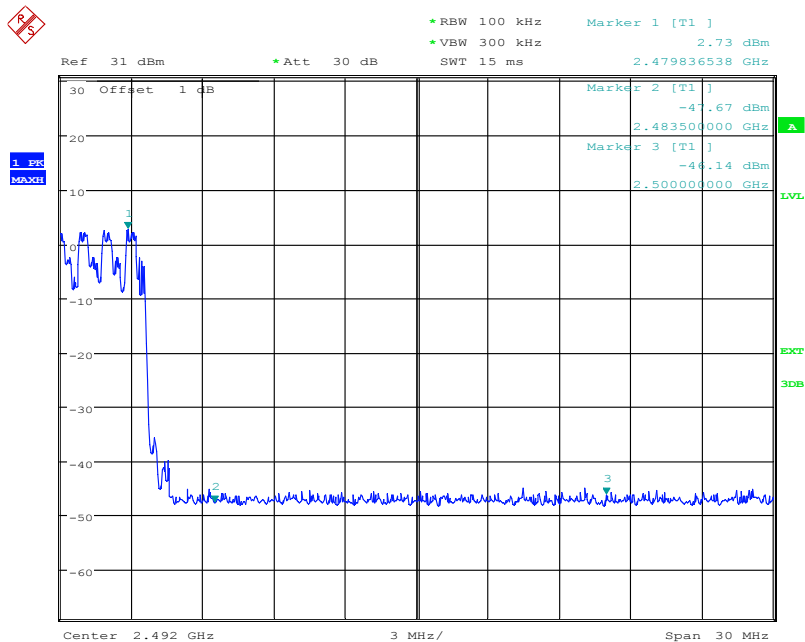

LIMIT

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.

The hops per second for all channels: The selected EUT Conf uses a slot type of 5-Tx&1-Rx and a hopping rate of 1600 [ch*hop/s] for all channels. So the final hopping rate for all channels is $1600/6 = 266.67 [\text{ch} \times \text{hop/s}]$

The hops per second on one channel: $266.67 [\text{ch} \times \text{hops/s}] / 79 [\text{ch}] = 3.38 [\text{hop/s}]$;

The total hops for all channels within the dwell time calculation duration: $3.38 [\text{hop/s}] \times 31.6[s \times \text{ch}] = 106.67 [\text{hop} \times \text{ch}]$;

The dwell time for all channels hopping: $106.67 [\text{hop} \times \text{ch}] \times \text{Burst Width} [\text{ms/hop/ch}]$.

4.9. Spurious RF Conducted Emission

4.10. Pseudorandom Frequency Hopping Sequence

TEST APPLICABLE

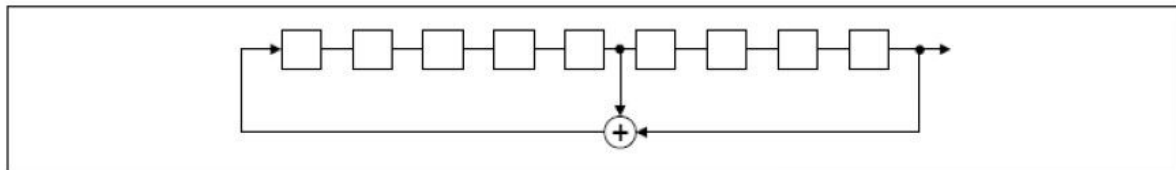
For 47 CFR Part 15C section 15.247 (a)(1) requirement:

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400–2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to channel frequencies that are selected at the system hopping rate from a pseudo randomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

EUT Pseudorandom Frequency Hopping Sequence Requirement

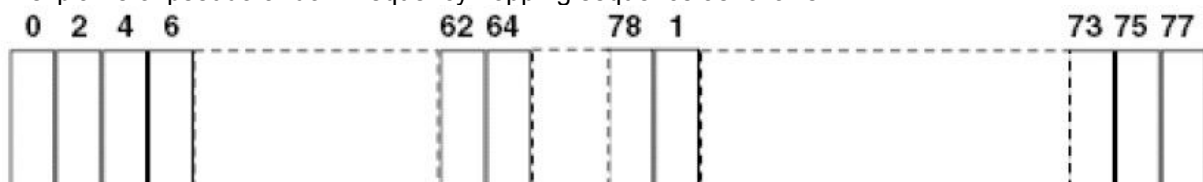
The pseudorandom frequency hopping sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first one of 9 consecutive ones, for example: the shift register is initialized with nine ones.

- Number of shift register stages: 9
- Length of pseudo-random sequence: $2^9 - 1 = 511$ bits
- Longest sequence of zeros: 8 (non-inverted signal)

Each frequency used equally on the average by each transmitter.

The system receiver has input bandwidths that match the hopping channel bandwidths of their corresponding transmitter and shifts frequencies in synchronization with the transmitted signals.

4.11. Antenna Requirement

Standard Applicable

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

And according to FCC 47 CFR Section 15.247 (c), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

Refer to statement below for compliance

The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited. Further, this requirement does not apply to intentional radiators that must be professionally installed.

Antenna Connected Construction

The maximum gain of Bluetooth antenna was -5.8dBi and it is a FPC ANT.
