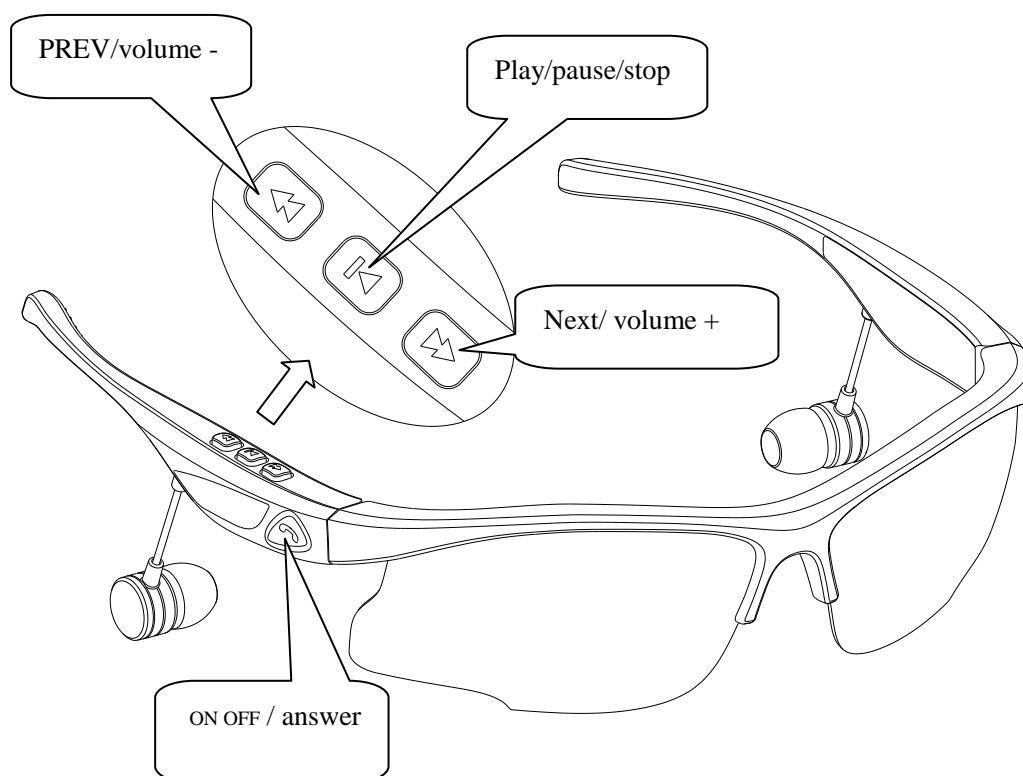

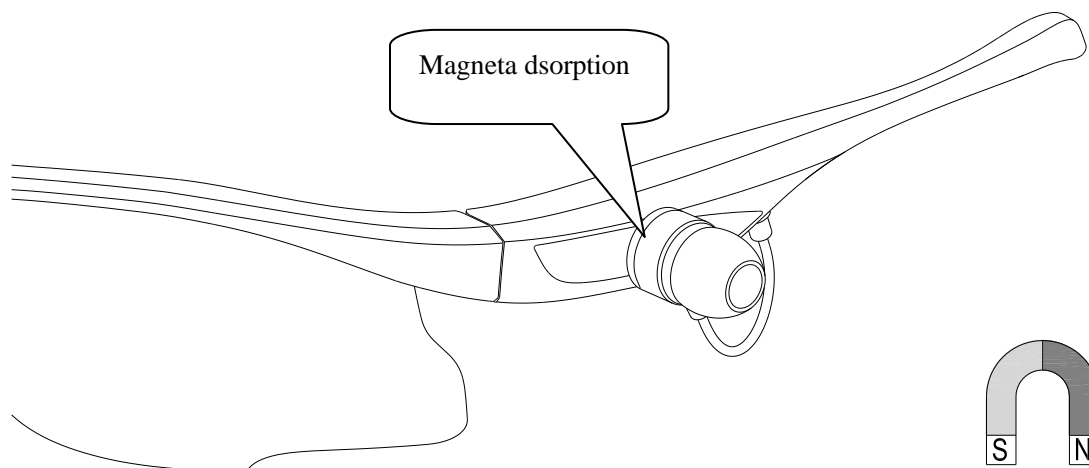

二. pairing:

1. Open your phone's bluetooth function, enter search condition;
2. Shutdown conditions hold switch machine button for 6 seconds, until the red and blue lights flashing, into pairing mode;

3. Discovery LBG200 "bluetooth device" and then click enter pairing; (part of mobile phone need to enter a password, please press 0000);
4. After the completion of the match; Under blue lights flash 3, the motor vibration into standby mode, after a ear to have a voice prompt;
5. If pairing failed, please again after turn off the phone with bluetooth headset in pairing mode;

三. Call function;

1 Answer the phone;

When new calls; Headphones have a bell, the motor vibration. Short press the switch machine can call;

2. Make a phone call; (acoustic)

Standby or music playback mode; Short press the switch machine into acoustic mode (mobile phone);

3. re-dial;

Continuous short press two switch machine, which can realize the final group number allocated

4. decline a call

Long press 2 seconds, switch machine decline a call

5. starting up

Long press 2 seconds, switch machine boot

6. shutdown

Long press switch machine 4 seconds to turn it off

四. Play Music

1. Play and pause

Short press the play/pause key; Can realize the current song play and pause;

2. PREV;

Short press 1 seconds on a song/volume and button; A song of songs played function implementation;

3. Next;

Short press buttons on one song/volume minus 1 SEC; Achieve the function of the next song song playing;

4. volume+;

Long press on the starter/volume and button; Can realize the function of song volume plus;

5. volume-;

Long press buttons on a song/volume reduction; We can realize the function of the volume decreases;
