

The ECG shall be used in conjunction with the intelligent display device. The Bluetooth for the system of intelligent display device shall be Version 4.2 or above.





- (2) Click on the installation package downloaded and complete the installation of the software according to the prompt.







(2) Connect the ECG recorder: On the software's Bluetooth search page, select the device whose name begins with mhealth365 for Bluetooth connection. After the connection is successful, the indicator should flash slowly.




(3) Measure and record the ECG: On the software page, follow the prompts and click it to start the measurement. Hold the ECG recorder with both hands and press the electrode with your thumb (refer to the figure below). At this time, keep the words "SnapECG" up. After the measurement, the software will prompt and generate a health report, from which you can view the record measured in the software.





Tips: when measuring, please keep quiet in an undisturbed environment. Don't exercise and talk.

(4) Consult professional ECG services: On the software page, you can browse the history report.



(5) Login registration: When you send a health report, the palmtop ECG software will automatically jump to the login page, and then you may complete the account registration according to the page prompt, and log in to your personal account; you can log in directly in case that you already have an account.





(6) After the measurement is completed, exit the software and both hands leave the electrode of ECG recorder for more than 3 seconds to shut down automatically.

3.4 Charging description

E-H09 is powered by an internal 3.7V rechargeable battery, and the battery is not detachable. Before use, please fully charge the battery to meet the needs of record time.

When the power of the equipment is low, the indicator will turn off automatically after the light flicker quickly. Please plug in the USB charging line to charge the device. When charging, please choose the 5V output adapter. When charging, the charging indicator is always bright; after full electricity, the indicator lights out automatically.

Chapter 4 Service and maintenance

- 1. When the product's surface is covered with dust or dirt, use dry, clean, and soft cotton cloth, or wet medical alcohol cotton ball to gently wipe it, but be sure to avoid alcohol drip or flew into the product.

Appendix B Common sense of heart health

1. What is the heart rate trend?

The rate of heart rate changes in a period of time, normally, the heart rate of adults is 60 to 100 times per minute.

2. What is the heart rate distribution?

Normal heart rate for a period of time, the heart rate is slightly faster, slower, too fast, too slow.

3. What is the rhythm trend?

A change in the rhythm of the beating of the heart for a period of time.

4. What is the abnormal rhythm distribution?

The proportion of abnormal rhythms, such as arrhythmias, premature beats and atrial fibrillation during a period of time.

5. What is premature beat?

The beat of the normal heart is the rule, and the heartbeat interval is basically the same. If the heart beats suddenly earlier, it is called premature pulsation in medicine.

6. What is atrial fibrillation?

Atrial fibrillation referred to as atrial fibrillation, that is, the atrial produce up to 350-600 times per minute irregular impulses, atrial fibrillation in various parts of the very uncoordinated chaos fibrillation, which lost the effective contraction, the vast majority occurred in patients with heart disease Of patients such as rheumatic heart disease, coronary heart disease and hypertension.
