

◆ Connection description

- Hold a pen near the conference table;
- Open the "Bluetooth" search page in "Settings";
- Find "SmartPen SP3" and click "Pairing". Whether "Pairing success" message appears, pair the SmartPen SP3 Completed;
- If it does not succeed, you can hold down the "Previous page" + "Next page" at the same time "Button" for more than 5s, wait for the indicator to flash in the order of red, green and blue. After a short repeat steps 1 to 3.
