1.7. Description Of Test Modes

The EUT has been tested under operating condition.

The EUT was set to transmit at 100% duty cycle.

For pre-testing, when performed with AC/DC ADAPTER, the input Voltage/Frequency AC 120V/60Hz and AC 240V/60Hz were used. Only recorded the worst case in this report.

Worst-case mode and channel used for 150kHz-30 MHz power line conducted emissions was the mode and channel with the highest output power, that was determined to be 802.11b mode(High Channel).

Worst-case mode and channel used for 9kHz-1000 MHz radiated emissions was the mode and channel with the highest output power, that was determined to be 802.11b mode(High Channel).

Worst-Case data rates were utilized from preliminary testing of the Chipset, worst-case data rates used during the testing are as follows:

802.11b Mode : 1 Mbps, DSSS.

802.11g Mode : 6 Mbps, OFDM.

802.11n Mode HT20: MCS0, OFDM.

2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10: 2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd..

2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to FCC's request, Test Procedure KDB558074 D01 DTS Meas Guidance v03r02 is required to be used for this kind of FCC 15.247 digital modulation device.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

2.3. General Test Procedures

2.3.1 Conducted Emissions

According to the requirements in Section 6.2 of ANSI C63.10: 2013, AC power-line conducted emissions shall be measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

2.3.2 Radiated Emissions

The EUT is placed on a turn table and the turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10: 2013

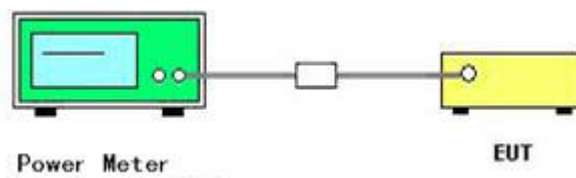

5.2. Power Spectral Density Measurement

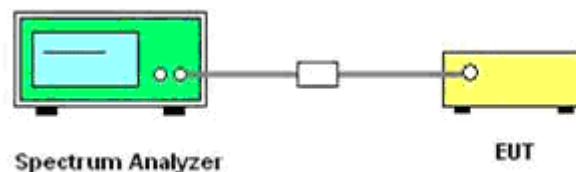
5.2.1. Standard Applicable

According to §15.247(e): For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

5.2.2. Test Procedures

- 1) The transmitter was connected directly to a Spectrum Analyzer through a directional couple.
- 2) The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
- 3) Set the RBW = 3 kHz.
- 4) Set the VBW $\geq 3 \times \text{RBW}$
- 5) Set the span to 1.5 times the DTS channel bandwidth.
- 6) Detector = peak.
- 7) Sweep time = auto couple.
- 8) Trace mode = max hold.
- 9) Allow trace to fully stabilize.
- 10) Use the peak marker function to determine the maximum power level in any 3 kHz band segment within the fundamental EBW.

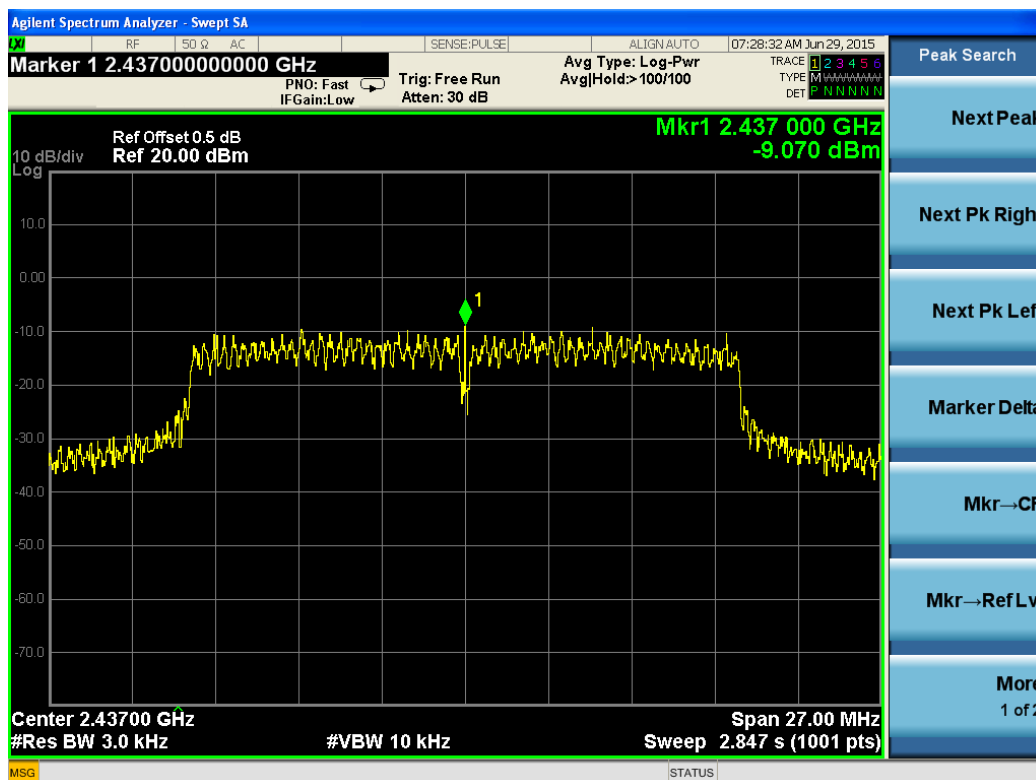
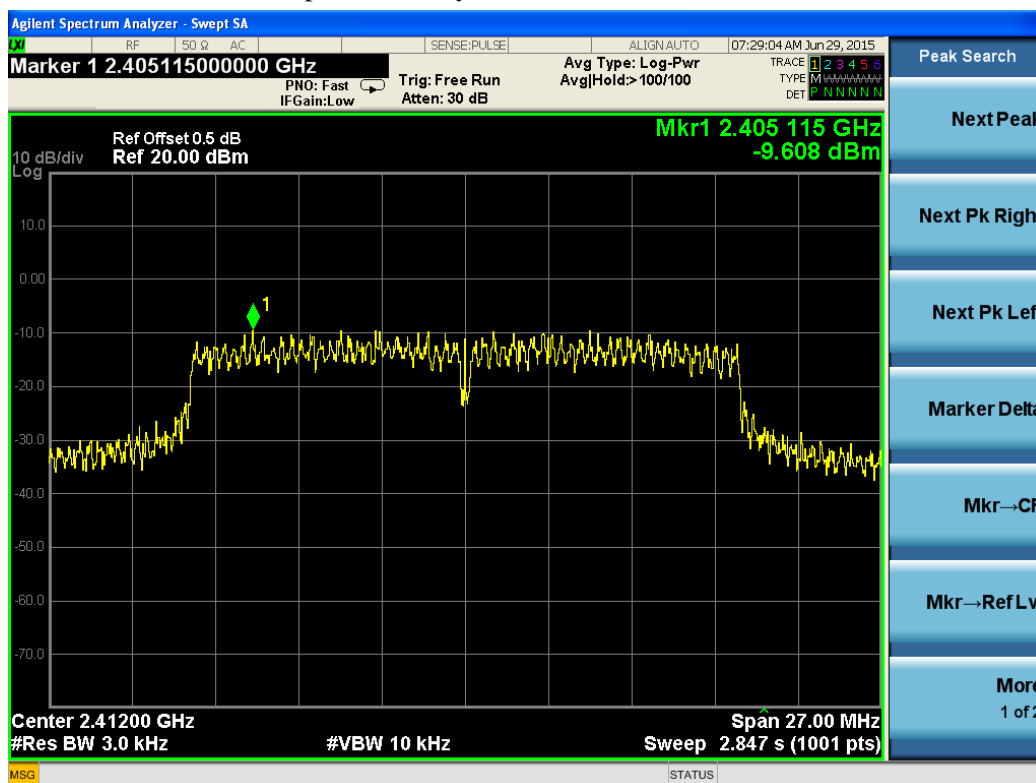


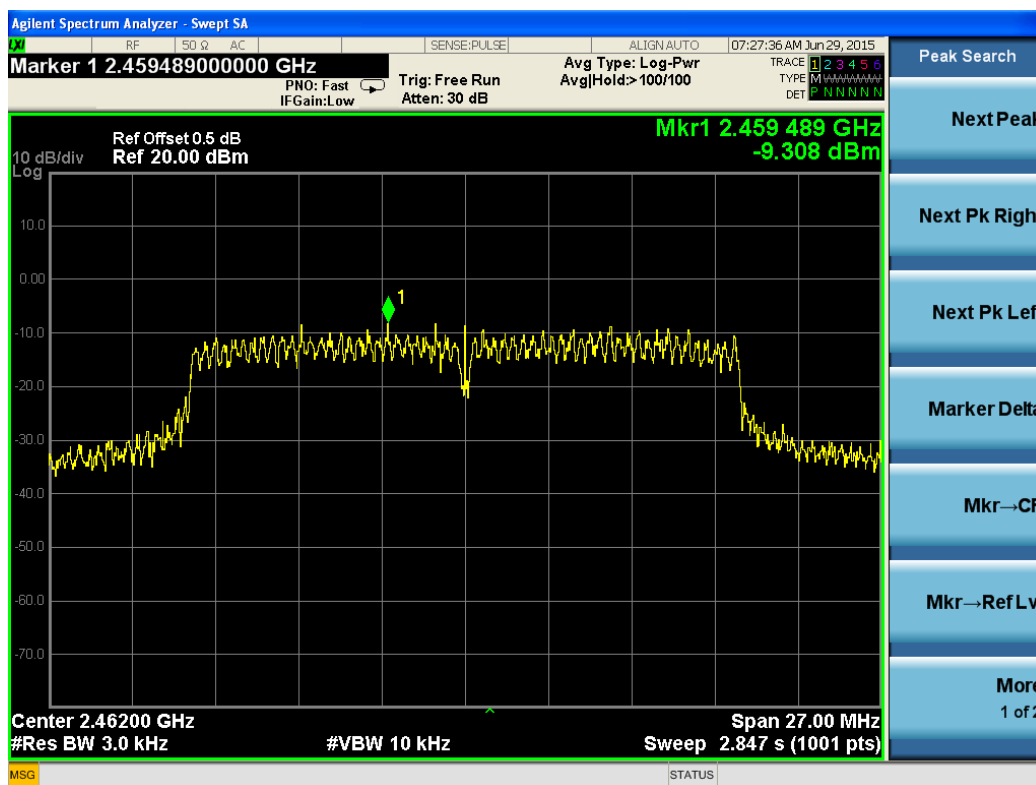
802.11g power density

According to §15.247(a)(2): Systems using digital modulation techniques may operate in the 902-928 MHz, 2400-2483.5MHz, and 5725-5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

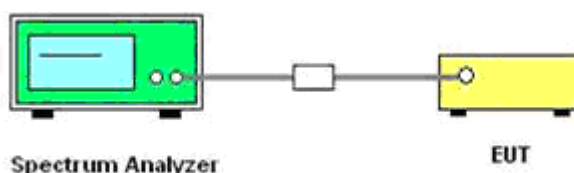

5.3.3. Test Procedures

- 1) The transmitter output (antenna port) was connected to the spectrum analyser in peak hold mode.
- 2) The resolution bandwidth and the video bandwidth were set according to KDB558074 D01 DTS Meas. Guidance v03r02.
- 3) Measured the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6dB relative to the maximum level measured in the fundamental emission.
- 4) For 20dB Bandwidth measurement, RBW is set in the range of 1% to 5% of the OBW, and VBW shall be approximately three times the RBW. Measured the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 20dB relative to the maximum level measured in the fundamental emission.

5.4.1. Standard Applicable

According to §15.247 (d): 20dBc in any 100 kHz bandwidth outside the operating frequency band. In case the emission fall within the restricted band specified on 15.205(a), then the 15.209(a) limit in the table below has to be followed.

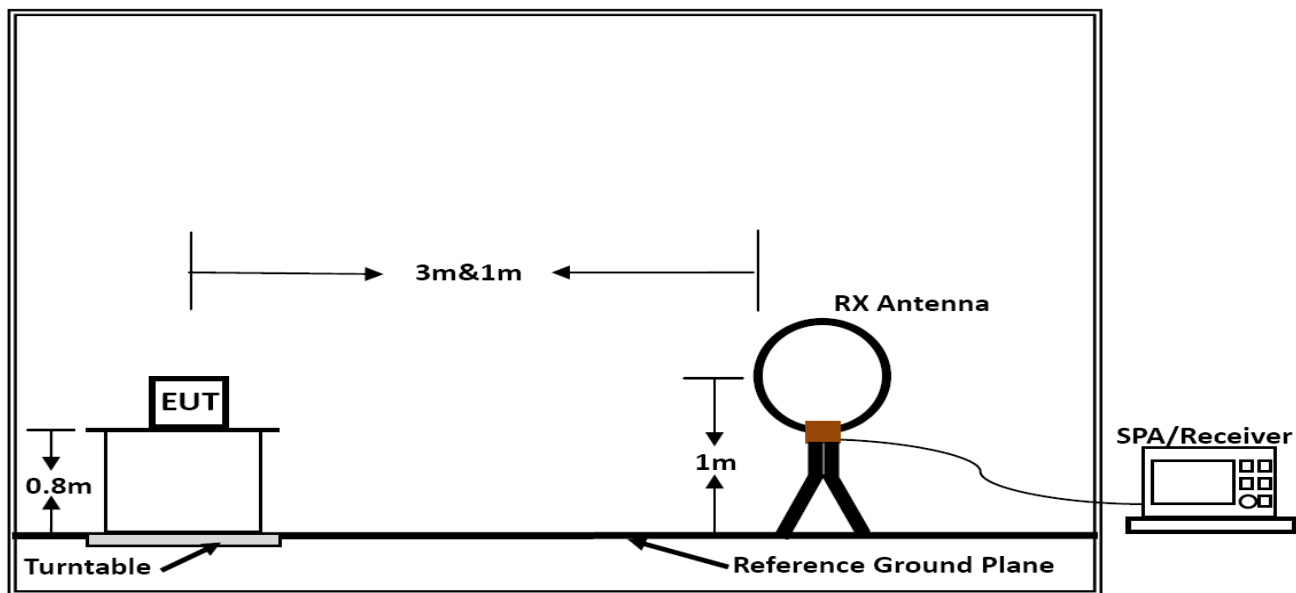
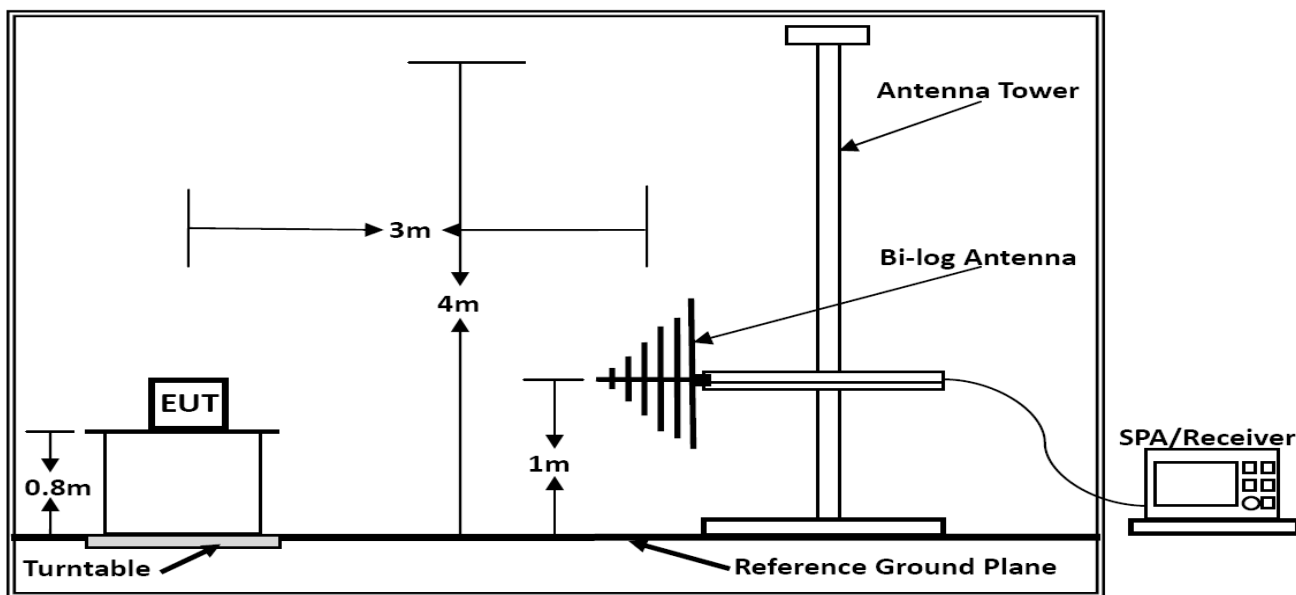

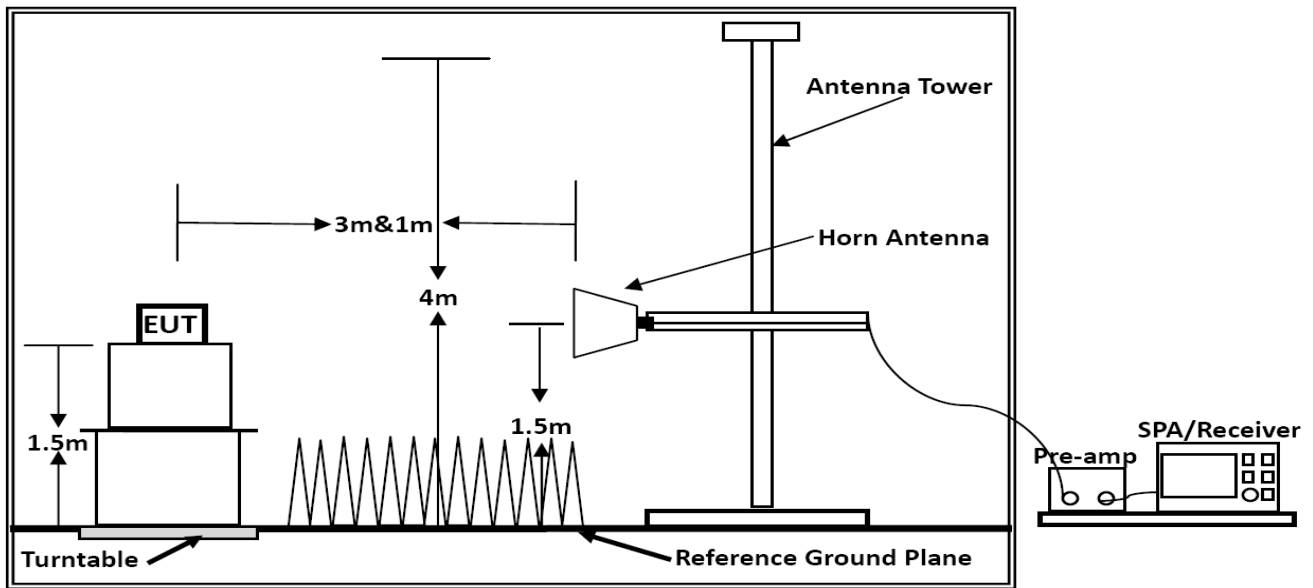
5.4.3. Test Procedures

- 1) Configure the EUT according to ANSI C63.10: 2013. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
- 2) Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
- 3) The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.

- 4) For each suspected emissions, the antenna tower was scan (from 1 m to 4 m) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading
- 5) Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
- 6) For emissions above 1GHz, use 1MHz VBW and RBW for peak reading. Then 1MHz RBW and 10Hz VBW for average reading in spectrum analyzer.
- 7) When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average absolute voltage during a 0.1 second interval during which the field strength is at its maximum value.
- 8) If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
- 9) For the radiated emission test above 1GHz: Place the measurement antenna away from each area of the EUT determined to be a source of emission at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane. The emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
- 10) In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High – Low scan is not required in this case.

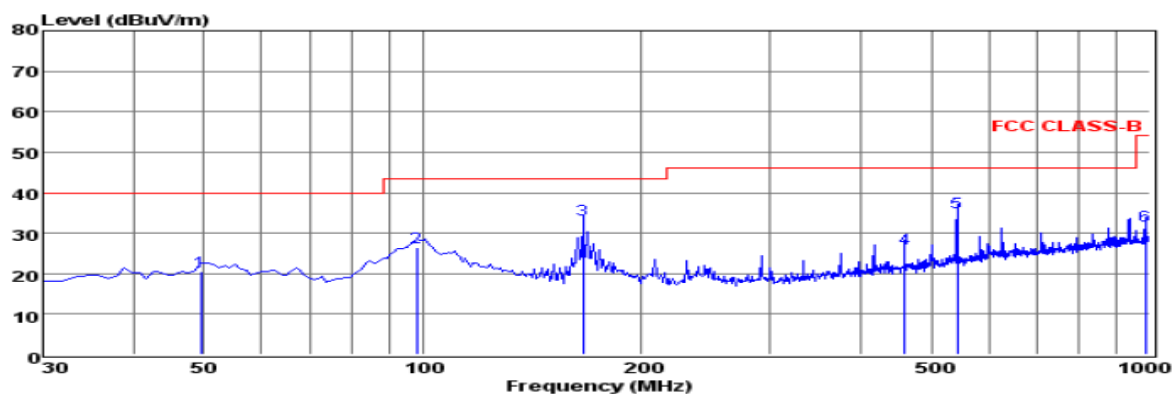

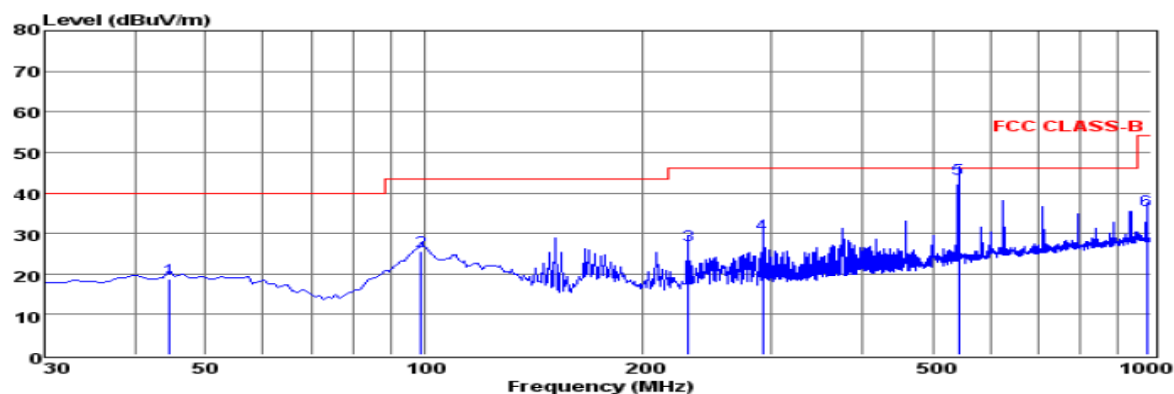

5.5. Conducted Spurious Emissions and Band Edges Test

5.5.1. Standard Applicable

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

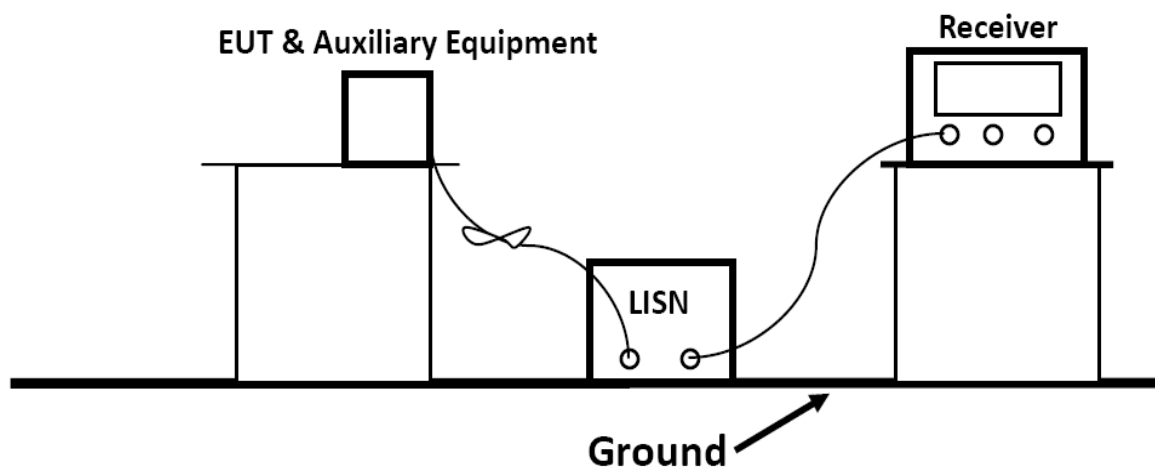
5.6. Power line conducted emissions

5.6.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 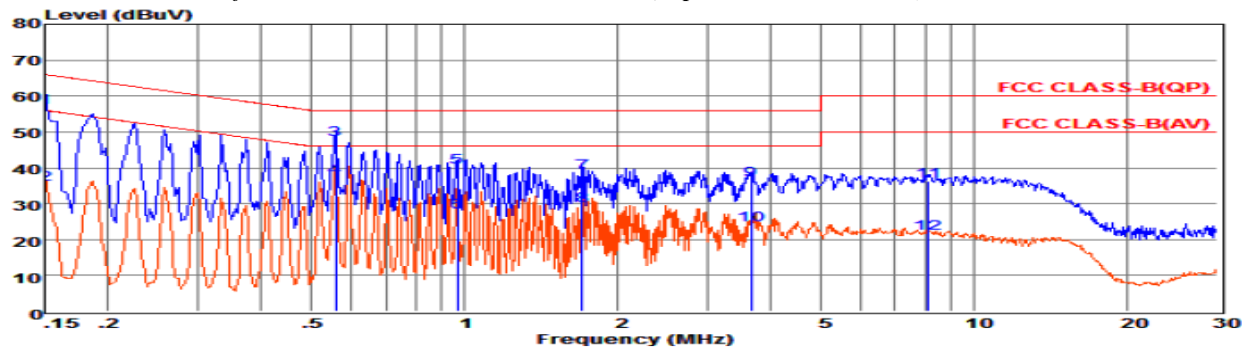

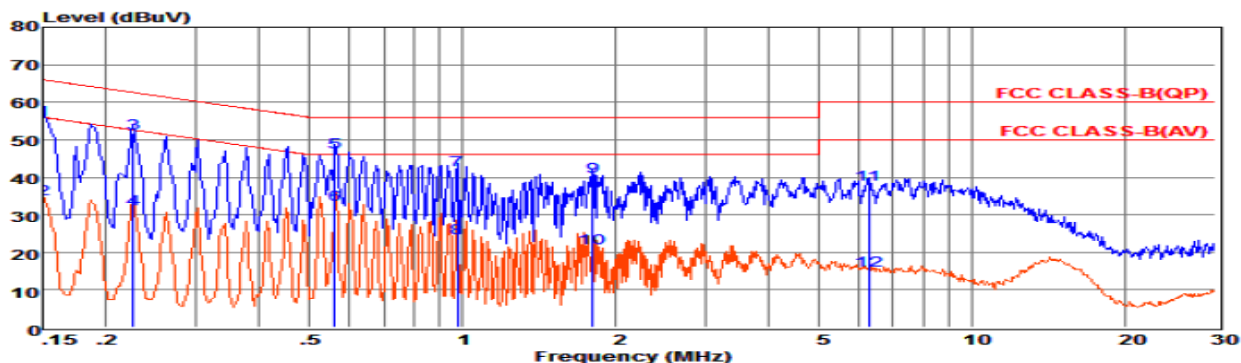
Test Result Of The EUT With AC/DC ADAPTER(Input: AC 240V/60Hz)

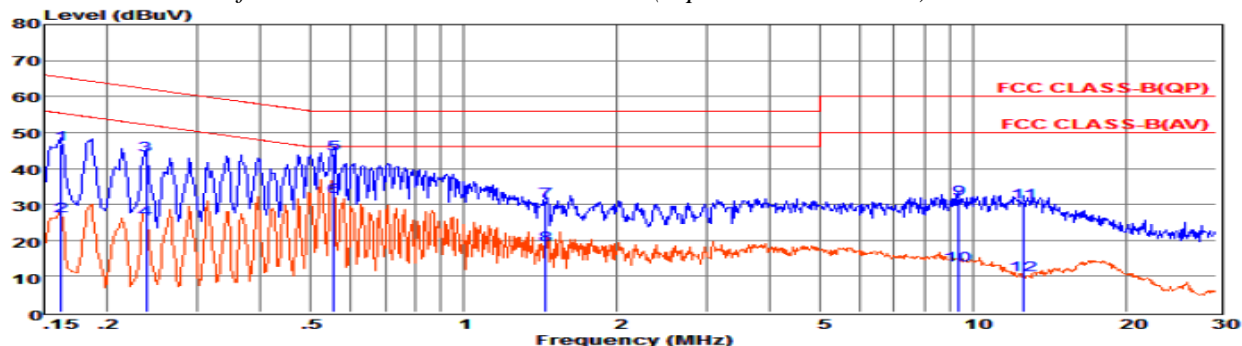

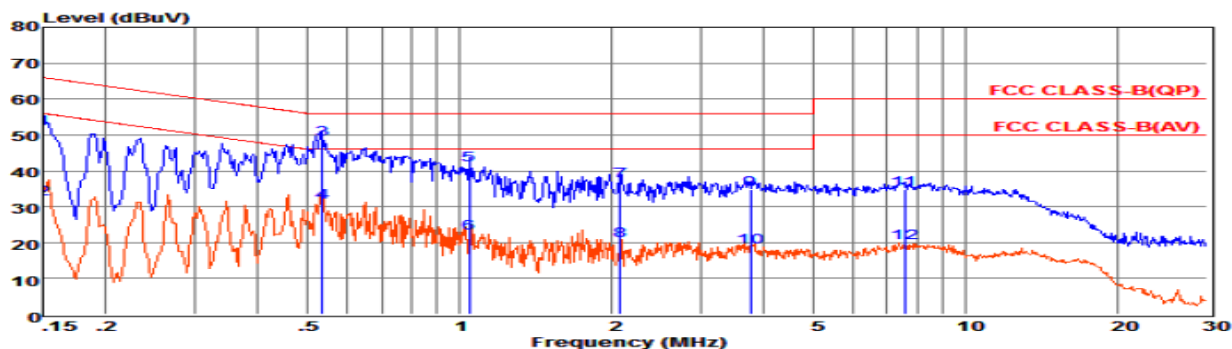

5.7. Antenna Requirements

5.7.1. Standard Applicable

According to § 15.203, An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.
