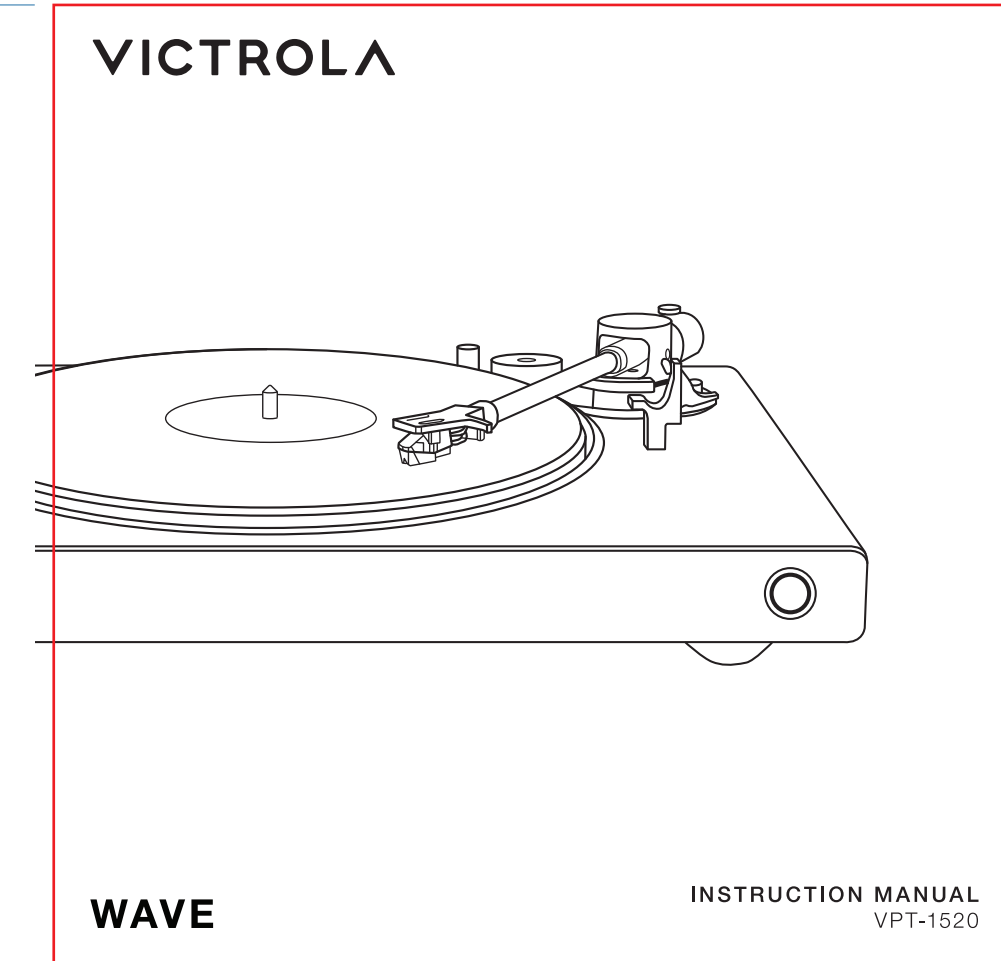
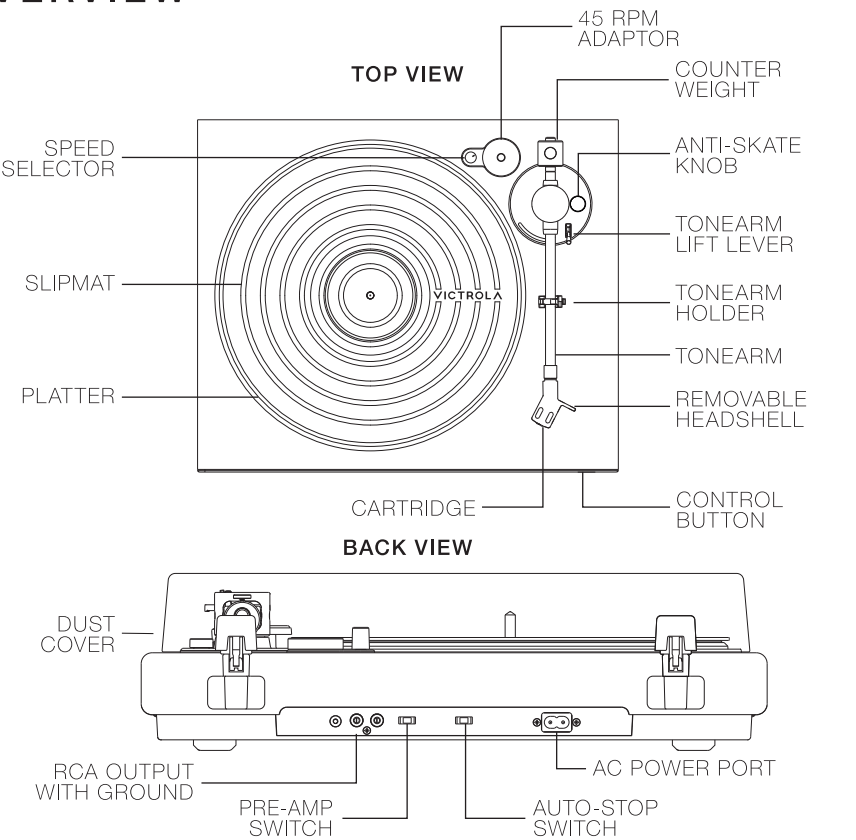

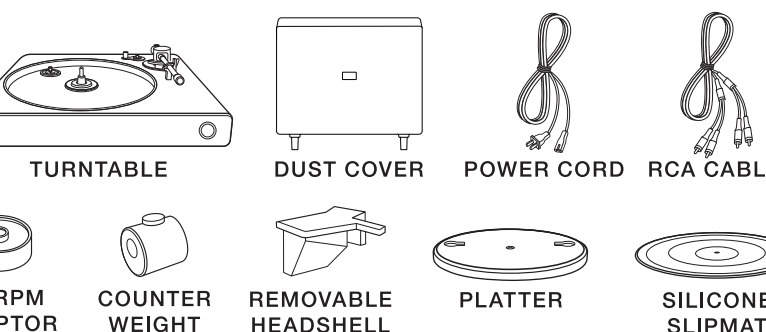

AUTO-STOP SWITCH

PRE-AMP SWITCH

LINE: Set the switch to line if connecting to line level input on speakers or amplifier.
PHONO: Set the switch to phono if using external pre-amp or amplifier with phono input.
