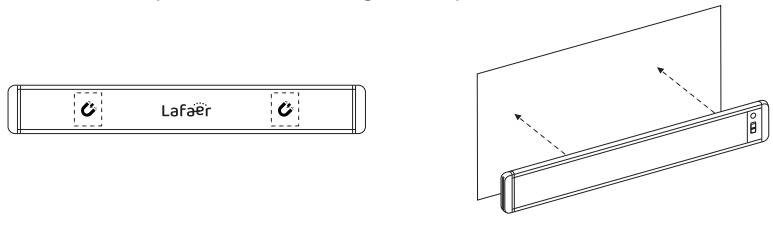

Installation

Option 1

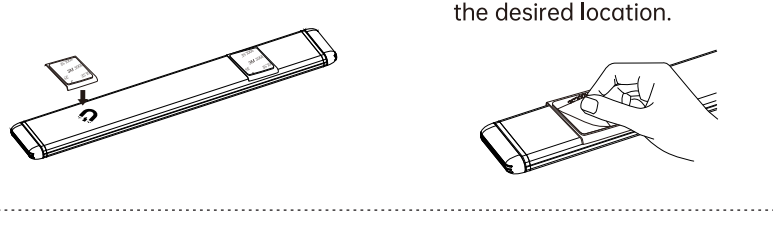
1 Attach to any metal surface magnetically.



Option 2

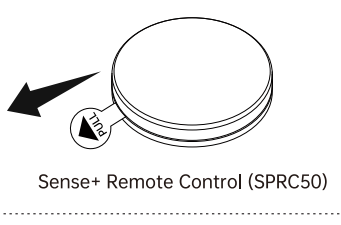
1 Attach the metal plates to the light .

2 Remove the backing from the adhesive and fix the lamp to the desired location.



Control Installation

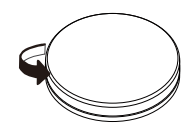
1 Pull the safety tag out from the Wireless Remote Control.



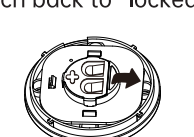
Sense+ Remote Control (SPRC50)

Replacing the Battery

1 Twist the cover switch to "unlocked" and remove the cover.



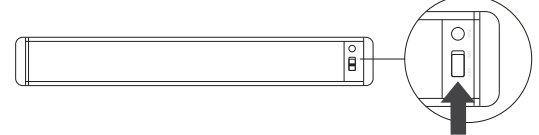
2 Reinstall the cover after replacing the button battery, and then twist the cover switch back to "locked".



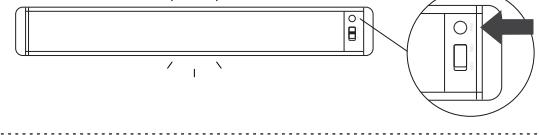
Pairing

To pair your LED lights with the wireless remote control, you need to

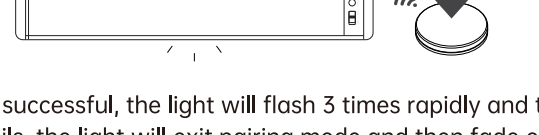
1 Turn on the light.



2 Long press the "Pair" button on the light, until it start flashing slowly.



3 Press once on the control.

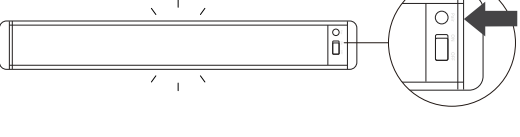


• If pairing is successful, the light will flash 3 times rapidly and then fade out.
• If pairing fails, the light will exit pairing mode and then fade out.

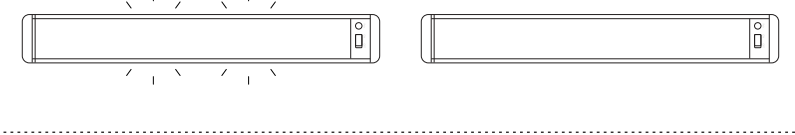
Unpairing

To unpair your lights from the wireless remote control:

1 Double-click the "Pair" button on the light.



2 The light will flash twice and then turn off.

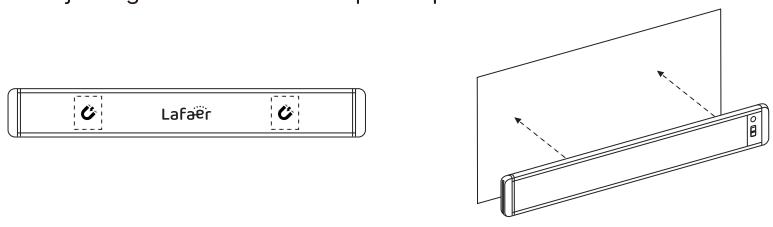

Opción 1

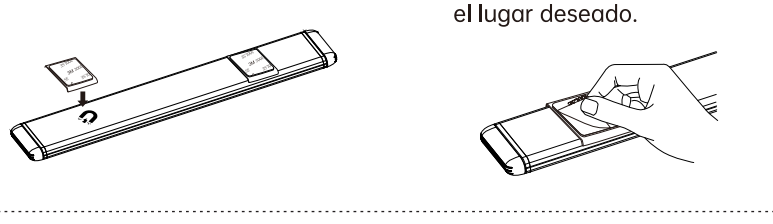
1 Se fija magnéticamente a cualquier superficie metálica.



Opción 2

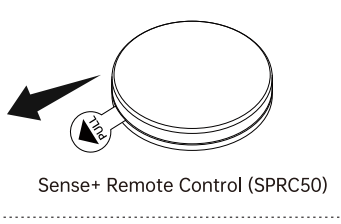
1 Fijar las placas metálicas a la luz.

Instalación del mando

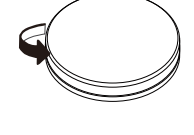
1 Extraiga la etiqueta de seguridad del mando a distancia inalámbrico.

1 Gire el interruptor de la tapa a «desbloqueado» y retire la tapa.



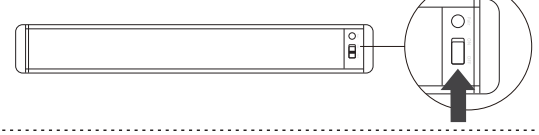
2 Vuelva a instalar la tapa después de sustituir la pila de botón y, a continuación, gire el interruptor de la tapa de nuevo a «bloqueado».



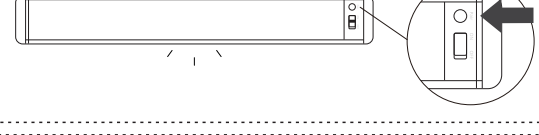
Emparejamiento

Para emparejar tus luces LED con el mando a distancia inalámbrico, necesitas

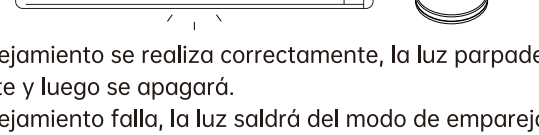
1 Enciende la luz.

3 Pulse una vez en el mando.

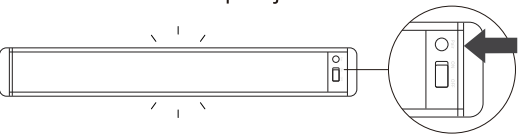


• Si el emparejamiento se realiza correctamente, la luz parpadeará 3 veces rápidamente y luego se apagará.
• Si el emparejamiento falla, la luz saldrá del modo de emparejamiento y se apagará.

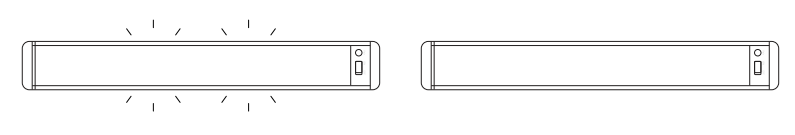
Desemparejar
