

Insert Cards & Power On

When powered up, your router will broadcast a Wi-Fi signal with the SSID: **GL-X300B-xxx**.

Hot plug for standard SIM card is not supported for this router.






Set up Router

If you cannot access the web-based setup page or cannot connect to the router, you can press the **Reset button**:

- Press and hold for **10 seconds**, and then release to reset the router to factory settings. All user data will be cleared.
