

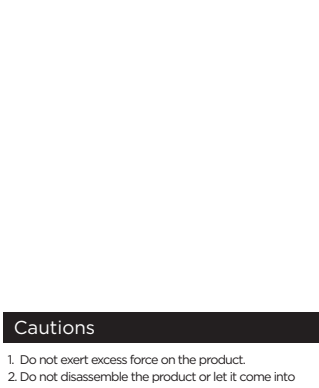

US Instruction



FCC Part 15 Compliance

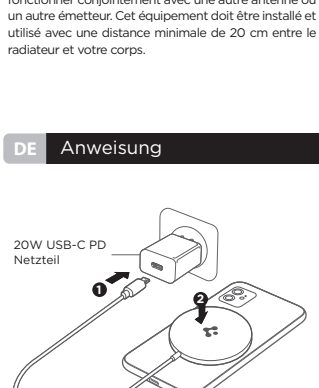

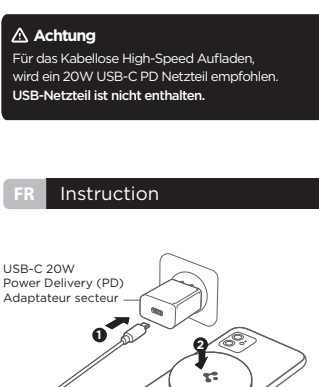
