

STANDARD AO1pro

- Paring with another BBT device :
1. Press&hold ② 2sec. to turn ON the power  
(After turned on the power, LED will flash 1 time The color of the LED will be shown battery status) Blue=Full  
Purple=Middle Red=Low
  2. Press&hold ① 3sec untill LED start flashing RED, when both devices are ON status.  
Then, Click one of BBT ① button **\*Do not press both!**
  3. Both BBT devices LED become blue color slow flashing.  
The devices are paired.

- Paring with the mobile phone:
1. Press&hold 4sec ② when the BBT power is **OFF** status untill LED start flashing RED/BLUE.
  2. Your mobile phone bluetooth must be serching mode status.
  3. Wait untill your mobile phone shows up "BBT pro" and select it. BBT LED become blue slow flash. The devices are paired.
- \*If you are already paired with your phone. You don't need to do the paring process for music button.**

HOW TO USE :

■INTERCALL■  
Press one of device' s ① buton. After 4 sec. start to talk  
**\*DO NOT press both device each other**  
Press ① to hung up talking  
■Handsfree■  
Incoming call:  
Press ② to pick up the phone call  
Hung up call:  
Press ② to hung up the phone call  
Redial:  
Press ② 2 times quickly  
■Music play■  
Play and Stop music:  
Press ③ to play or stop music  
Forward and Rewind:  
Press&hold 2sec. (+) for forward music. (-) for rewind  
■Reset■  
When the power if **OFF**. Press&hold 5sec.①&② at the same time.  
Untill purple color LED will lights up.  
**\*After reset, You need to do the first set up process.**

MASTER AO1Mpro

- Paring with multiple devices :
1. Press&hold ② 2sec. to turn ON the power  
(After turned on the power, LED will flash 1 time The color of the LED will be shown battery status) Blue=Full  
Purple=Middle Red=Low
  2. Press&hold ①&③ 3sec untill LED start flashing RED & BLUE  
Now MASTER unit entered the paring mode.  
Then, double Click ① (quickly press 2 times)  
**\*Before double click, STANDARD unit**
  3. Both BBT devices LED become blue color slow flashing.  
The devices are paired.

Paring with 2nd or 3rd device:  
See above process, and enter the paring mode, and double Click ② button. The 3rd device is also same process with ③ button.

**\*More devices, distance will be more shorter**  
1:1=1600m 1:2=800m each 1:3=400m each  
(We recommend to use 1:2)  
**\*MASTER cannot pair with a mobile phone**

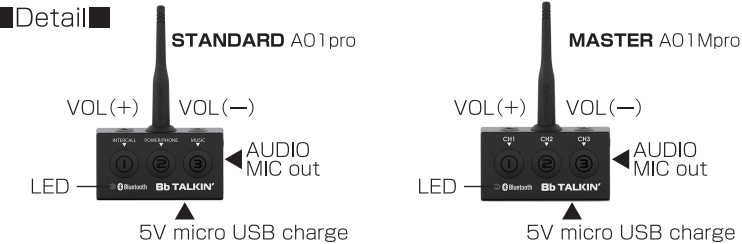
HOW TO USE :

■INTERCALL■  
Press 1 time ① button to call to the device you paried  
**\*Do not press CH1,2,3 together or too quickly**  
after CH1 is connected, then call out CH2 or CH3

■Stop intercall■  
Press 2 time quickly (double click) ① to stop CH1 device  
The same process for CH2 or CH3

■Call for ALL■  
Press 2 times CH1&CH3 at the same time

■Reset■  
When the power if OFF, Press&hold 5sec.①&② at the same time.  
Untill purple color LED will lights up.  
**\*After reset, You need to do the first set up process.**
