Given
$$S = \frac{P \times G}{4\pi d^2}$$
 (Equation 1)

Where d = distance in cm

P = Power in mW

G = Numeric antenna gain

S = Power Density in mW / cm²

Maximum Permissible Exposure

EUT Output Power=144.54mW

Numeric antenna gain=2.0

Substituting the MPE safe distance using d=20 cm into **Equation 1** :

Yields

The power density $S = 144.54 \times 2.0 / (4\pi \times 400) \text{ cm}^2 = 0.058 \text{ mW/cm}^2$

(For mobile or fixed location transmitters, the maximum power density is 1.0 mW / cm² even if the calculation indicates that the power density would be larger.)
