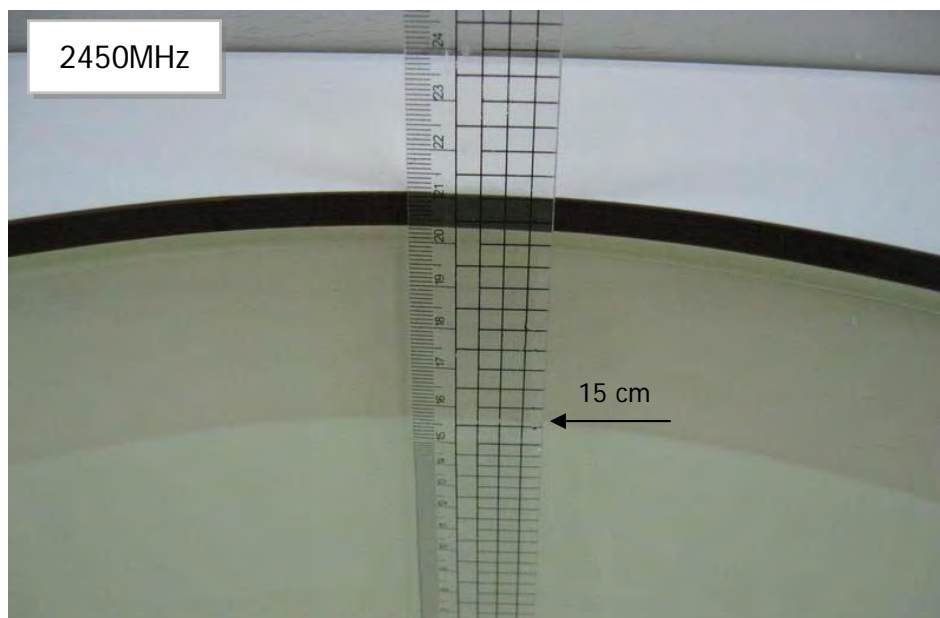

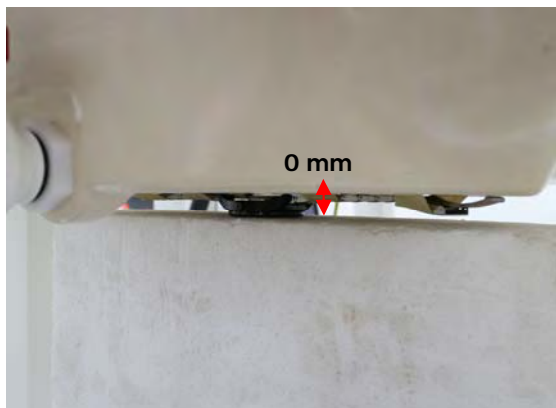


Fig.3 Configuration 1: watch's back touch against the flat phantom (gap: 1.25mm)

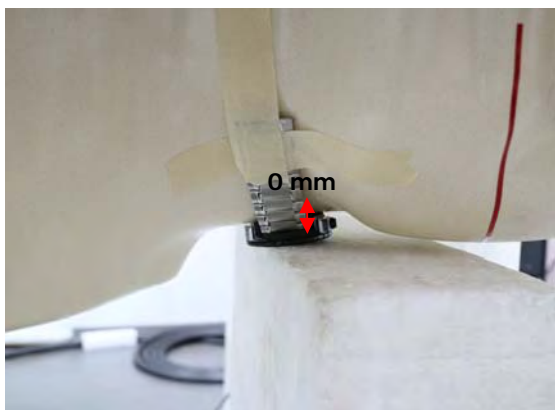


Fig.4 Configuration 2: watch's back touch against the neck phantom area (gap: 0mm)

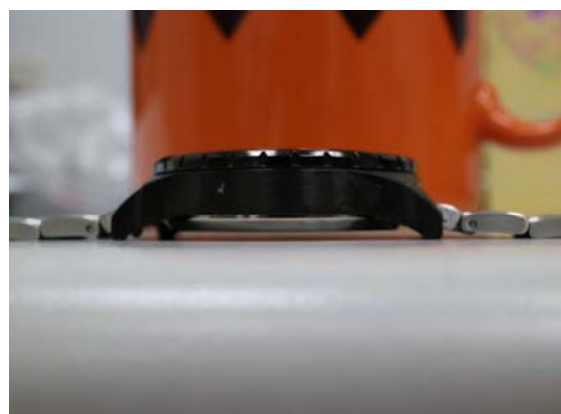
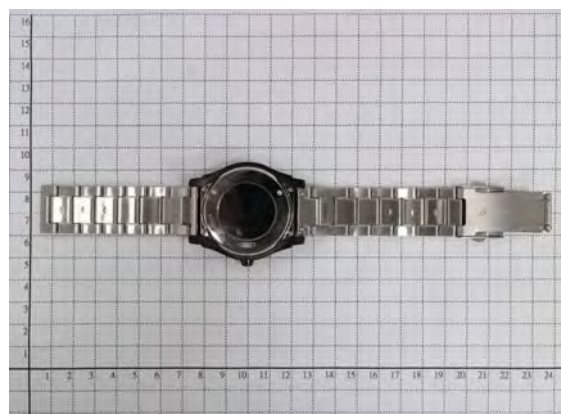


Fig.5 EUT
