User Guide

Step 1

Don't underestimate button battery. It can be used for 6 months! As the case with battery inside is fitted well, the small light will give out 5 flashes, see? Great first step!



(1) Remove the battery case.



(2) Put the battery into the attached case with the positive pole facing down.



(3) Plug it into the battery jar, 5 flashes of blue lights indicate a success.

The designers have racked their brains just for your convenience. You can replace the battery by pulling your little finger gently. It is so capricious with talents.



(4) Hold the bottom of batter case and pull it out.



(5) Remove the battery case to replace the battery.

Is your phone Fashion(able) enough? It support 4.3 or higher OS version for Android phone and IOS7.0 or higher for Apple phone with iPhone4s or newer.

Dear, if your phone version is too low, hurry up to upgrade it. Search the "ijiazu" in the App Store or scan the QR code below to download and install it. By the way, please give us praise.





Open ijiazu APP. There is no need of Bluetooth pairing, it will be automatically connected!

- 1. When you open the mobile APP, it might remind you to "Turn on Bluetooth" or prompt you to use privileges such as sound recording, location, phone calls etc. Please do make a choice.
- 2. It is recommended that ijiazu App should be on for automatic connection next time.
- 3. The App on Android phone may be killed automatically after a long time run. Just open it again.

Step 4

Come to your car and buckle up the strap just like wearing a watch. Fix it to the inside of the steering wheel (Note that you should install Voice-Controller to steering wheel firstly when a handle grip need to be installed moreover). Now the Voice-Controller will fit with your car. However bumpy the road is, they will not be separated.
