


Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)





Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)

Receiving Pattern (ϕ), $\vartheta = 0^{\circ}$









Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f_{eval}= 1900 MHz)






Uncertainty of Linearity Assessment: ± 0.6% (k=2)




Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)






Receiving Pattern (ϕ), $\vartheta = 0^{\circ}$









Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f_{eval}≈ 1900 MHz)






Uncertainty of Linearity Assessment: ± 0.6% (k=2)

 NORMx,y,z are only intermediate values, i.e., the uncertainties of NORMx,y,z does not affect the E²-field uncertainty inside TSL (see below ConvF).

NORM(f)x,y,z = NORMx,y,z * frequency_response (see Frequency Response Chart). This linearization is
implemented in DASY4 software versions later than 4.2. The uncertainty of the frequency response is included
in the stated uncertainty of ConvF.






Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)



Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)








Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f_{eval}= 1900 MHz)
