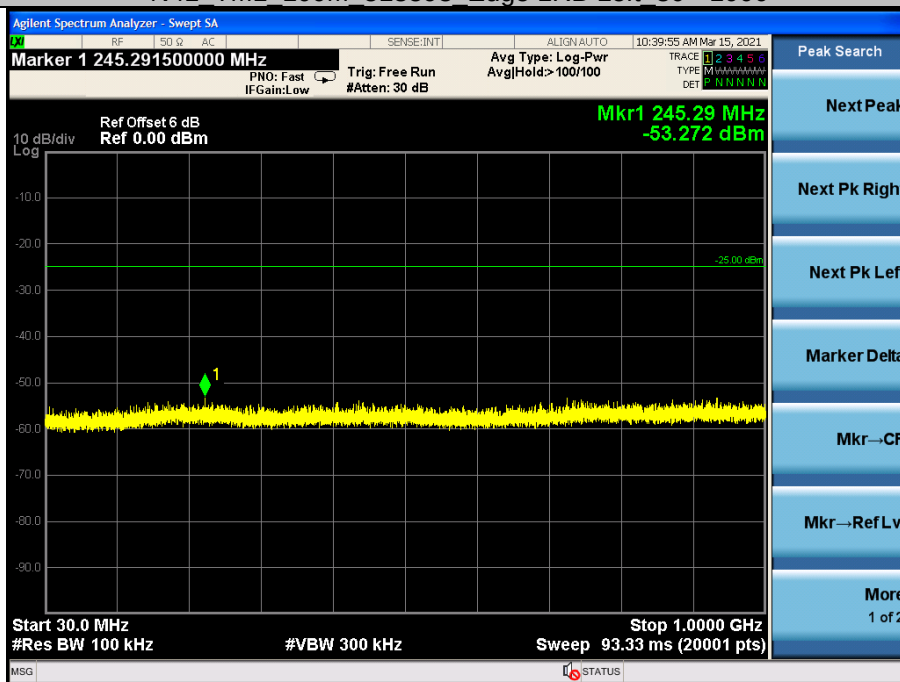
6 Spurious Emission at Antenna Terminal

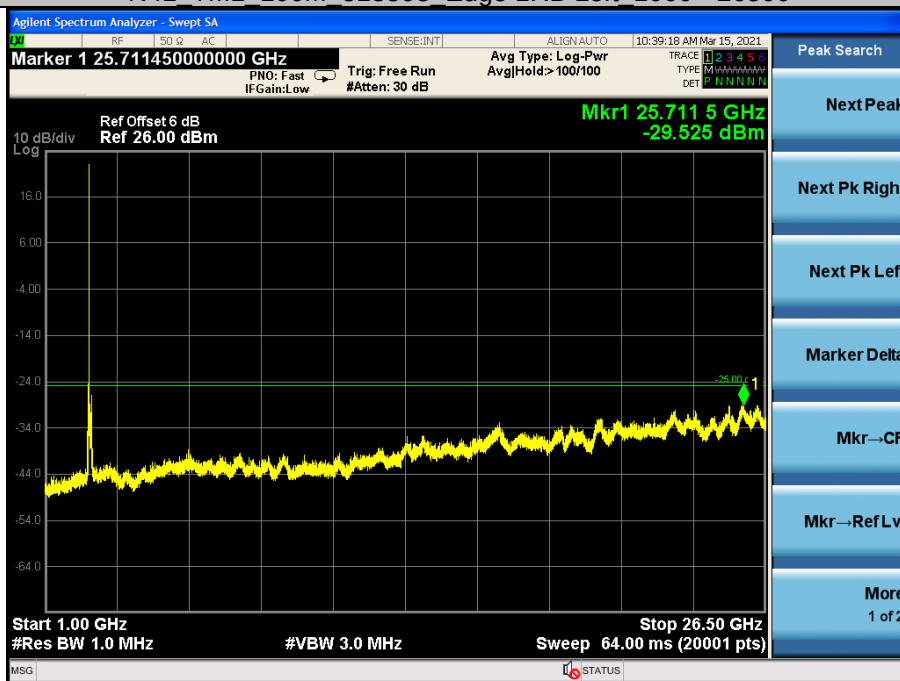

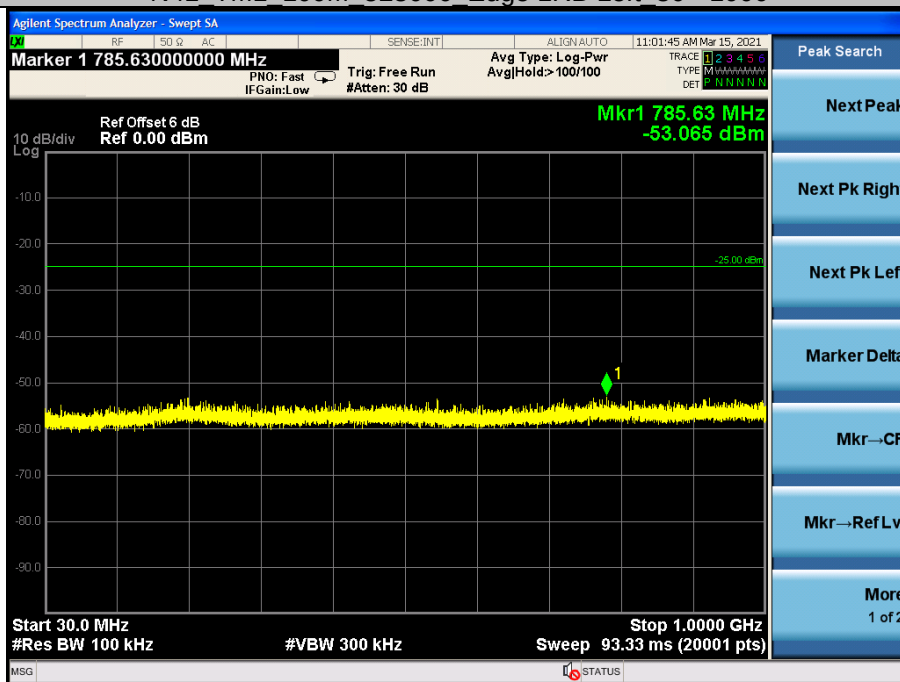

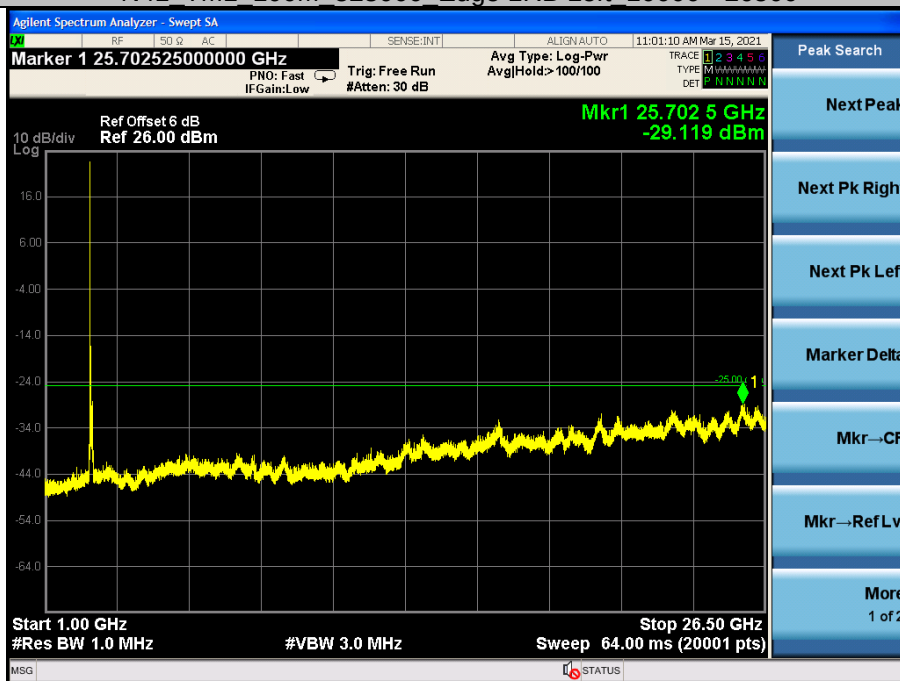
N41 TM1 100M 518598 Edge 1RB Left 1000 - 26500
