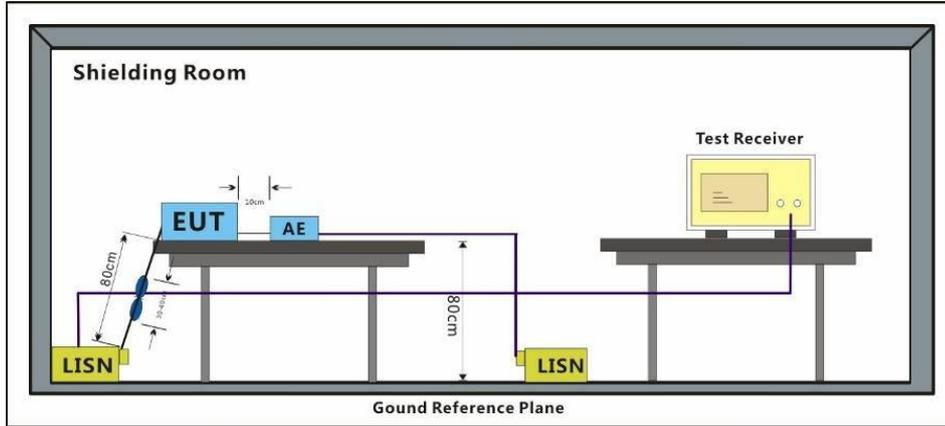





6.2.3 Test Setup Diagram






