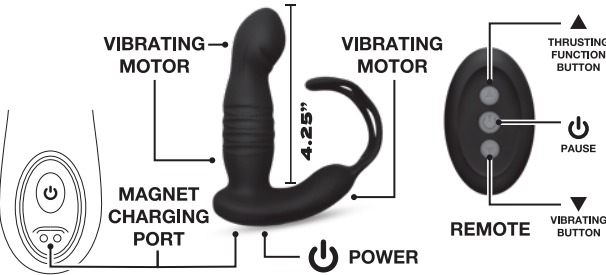

USER GUIDE



HOW TO USE

- **DEVICE POWER ON/OFF**
Press and hold the **⏻** button for 2 seconds to turn the device on and enter standby mode, press and hold for 2 seconds to turn off.
- **VIBRATION AND THRUSTING MODES**
Press the **⏻** button on the device continuously to cycle through the vibration and thrusting modes. Press the **⬆** button on the remote continuously to cycle through the vibration modes, press the **⬆** button on the remote continuously to cycle through the thrusting modes. When you turn on the vibration and thrusting mode using the **⏻** button on the device, you can also use the **⬆** and **⬇** buttons on the remote to control these 2 functions. Press and hold the **⏻** button for 2 seconds on the remote to stop both functions. There is a total of 10 patterns of vibration mode, there is a total of 5 patterns of thrusting mode.
- **CHARGING THE DEVICE**
Flashing Light (Red LED light): Item is charging. **Solid Light (Red LED light):** Item is fully charged. Apprx 120mins to fully charge for up to 60mins of use.
