

## User Guide

Miss On The Go™ by Miss VV Mystery inc.™

Miss On The Go™ (referred to as “product” in this document) is a sex toy in the vibrating Chinese balls category to help women tone up their pelvic muscles by enhancing Kegel exercises experience.

This product is for vaginal use only and has not been clinically tested and is not considered as a medical device.

### Specifications:

1. 5 vibration modes;
2. Up to 2.5 hours from full charge at maximum speed;
3. Material: medical silicone and ABS plastic (hypoallergenic) as well as internal electronic components;
4. Lithium rechargeable batteries;
5. Recharge with a USB cable (included);
6. Full charge in approximately 3 hours;
7. LED light indicator;
8. Decibel level: under 50 dB (the highest vibration setting is the loudest);
9. Waterproof up to up to 1meter/39”
10. Operating temperature between 10°C (50° F) and 40°C (104° F);
11. Weight : 65g (2.3 ounces);
12. Dimensions: vibrator (Length: 9,5 cm/3.74” - Height: 3, 6 cm/1.42”), antenna (Length : 14,6 cm/5.75” - Height: 0,7 cm/0.27”);
13. Device can be connected via Bluetooth® CSR 4.0 compatible with iOS and Android applications;
14. Packaging made of recycled materials;
15. CE, FCC, IC, RoHs certified

### Operation:

1. Press the ON/OFF button for 3 seconds to power the device, the LED light will flash every 5 seconds.
2. Refer to the appropriate section depending on whether the device is used with or without the mobile application.
3. Insert the device up to the second ball into the vagina, make sure the antenna coming out of your vaginal lips is directed toward the front to guaranty better comfort and efficiency of the device.
4. You may resume your activities as usual with the device inside your vagina and do your Kegel exercises. Refer to the SAFETY and PRECAUTIONS sections for more details.
5. When you are finished using the device, take it out of your vagina by pulling gently on the antenna. DO NOT pull on the antenna abruptly or use force over 10 lbs. pressure which is more than enough to remove the device. Press on the ON/OFF button for 3 seconds to turn off the device, the LED light will stop flashing.
6. When the device needs to be charged, connect the male plug of the USB cable provided to the back of the device, next to the certification symbols. Approximately 3 hours of charging is required for a full (when device is not in use). The LED light will flash every 3 seconds, indicating the device is in charging mode. The LED light will stay on once the charge is complete. You can unplug the device and enjoy a full charge on your next use.

#### Use with the mobile application:

You can use the device with the mobile application which can be downloaded on the App Store and Android Market.

**For maximum results when using device with the Bluetooth® connection, it is strongly recommended to:**

1. Keep smartphone within to 20 feet of the device;
2. Keep the device out of the water, specifically the antenna;
3. Keep the device outside the body when the body temperature raises and may affect the Bluetooth® signal;
4. Do not block signal by crossing your legs or being in a position that would prevent the signal to be picked up. It is possible that depending on your envelope, the antenna may not receive the signal;
5. Keep the antenna away from metal object such as zippers, metal chairs, computers etc.; Refer directly to the application for details and tutorials to facilitate the use of all features. After following the instructions on how to create your profile, you will be able to modify it at any desired moment in the Settings.

**When pairing your device, select Device and use the following Bluetooth® code: 000000 (6 x the number 0).**

Please note that during a session with a partner via the application, it is not possible to remotely control two devices at the same time. Only one device can be remotely controlled at a time.

When you send a request via the application, the other player has one minute to accept or decline.

Otherwise, the request will be cancelled and the person who initiated the request will receive a notification. If unavailable or busy, the other player will be able to see the cancelled request and see your profile name in the notifications of the smartphone.

**In case of Bluetooth® connection problems**, please make sure your device is ON to search for other Bluetooth® devices. Connect/disconnect your device within the application and try again. It is sometimes necessary to go into Bluetooth® settings of your smartphone and forget the device. You can then do the connection steps again and enter the pairing code (000000).

#### Use without the mobile application:

You may use the device without the mobile application. You will have to control the toy manually.

When in use (see above mentioned steps), change the settings by pressing the ON/OFF button and chose the desired setting (soft, medium, strong, pulse, throbbing and stop).

#### Cleaning and care:

The life of your device will be increased if you take care of it. It is important to clean your device before and after each use with a cleaner for medical silicon sex toy, which you can order in specialized shop with the advice of a professional if needed. Avoid using a cleaner containing oil, acetone or alcohol. To easy the insertion of the device, you main use a lubricant, water based only. Do not use a silicone based lubricant as it may affect the quality and material of your device.

Store your device in the satin bag provided to keep it away from dust, light and heat.

For health and hygiene reasons, do not share your device with another person.

#### Warranty:

Your product is covered by a 5 year limited warranty and all purchases are final.

Warranty over the covered period must have proof of purchase. Please keep original purchase receipt.

Miss VV Mystery inc.™ warrants its product against in materials and workmanship defects for a period of one (1) year from date of purchase (proof of purchase required). If you have a problem with your

product's functionality during that period, please email us at [bonjour@missvvsmyystery.com](mailto:bonjour@missvvsmyystery.com) with a valid proof of purchase indicating the original purchase date. We will replace the product up to two (2) times and tell you the steps to follow. The customer is responsible for the cost of returning a product. We will give you a refund but return shipping cost will be your responsibility.

If you have a problem with your product's functionality in the fourth (4<sup>th</sup>) year following the first (1<sup>st</sup>) year of use, we will give you a 50% discount on your next purchase. This warranty does not cover damage caused by misuse or use other than as intended and described in the product instruction manual. Upon receipt of the product, we will inspect it to determine the origin of the problem. Any attempt to open or dismantle the product will automatically void the warranty.

Do not discard packaging and/or used product but bring them to a collection center.
