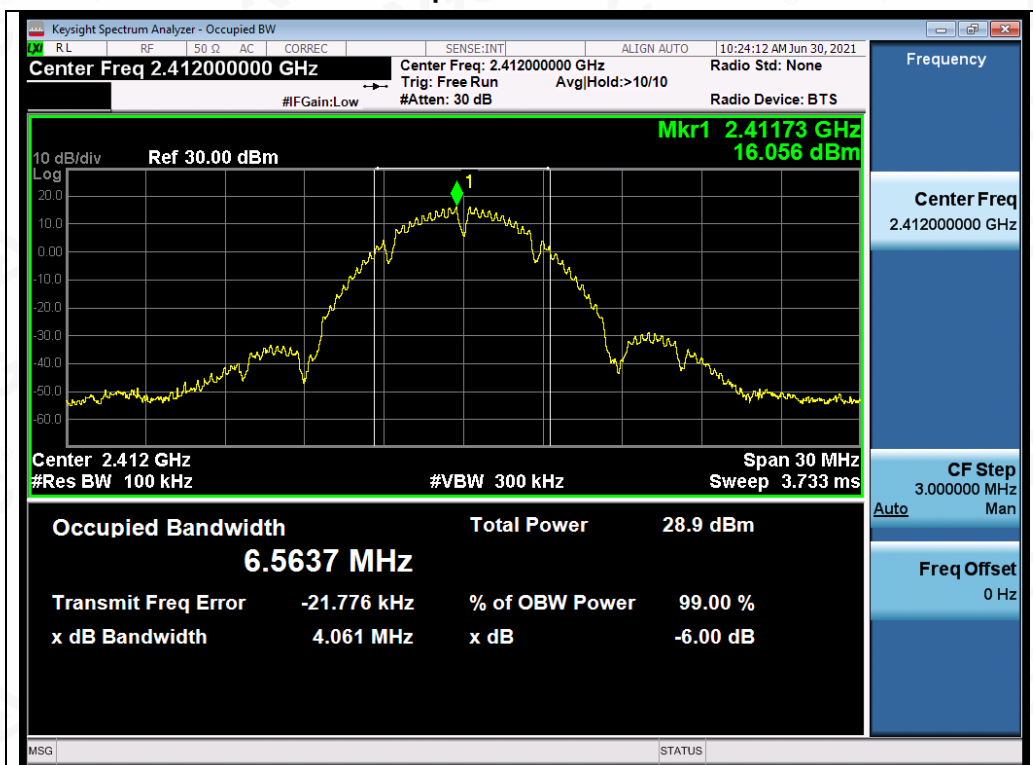

Test_Graph_OFDM_ANT1_2412_MCS0_DTSBW

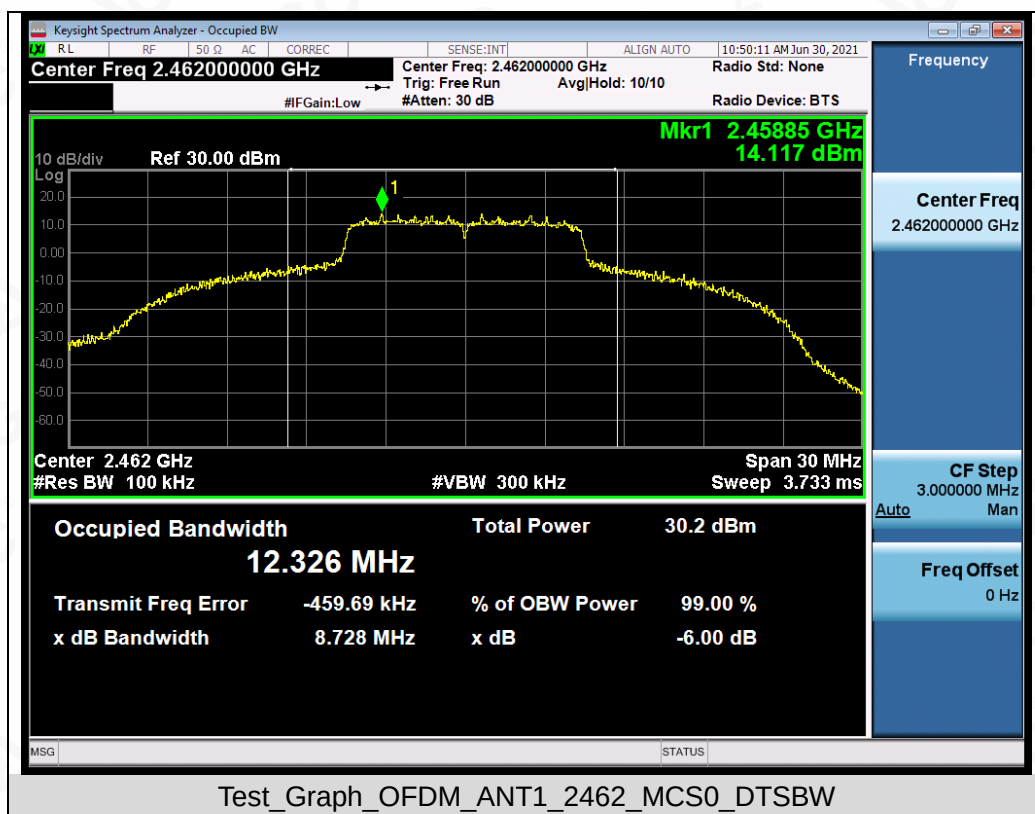

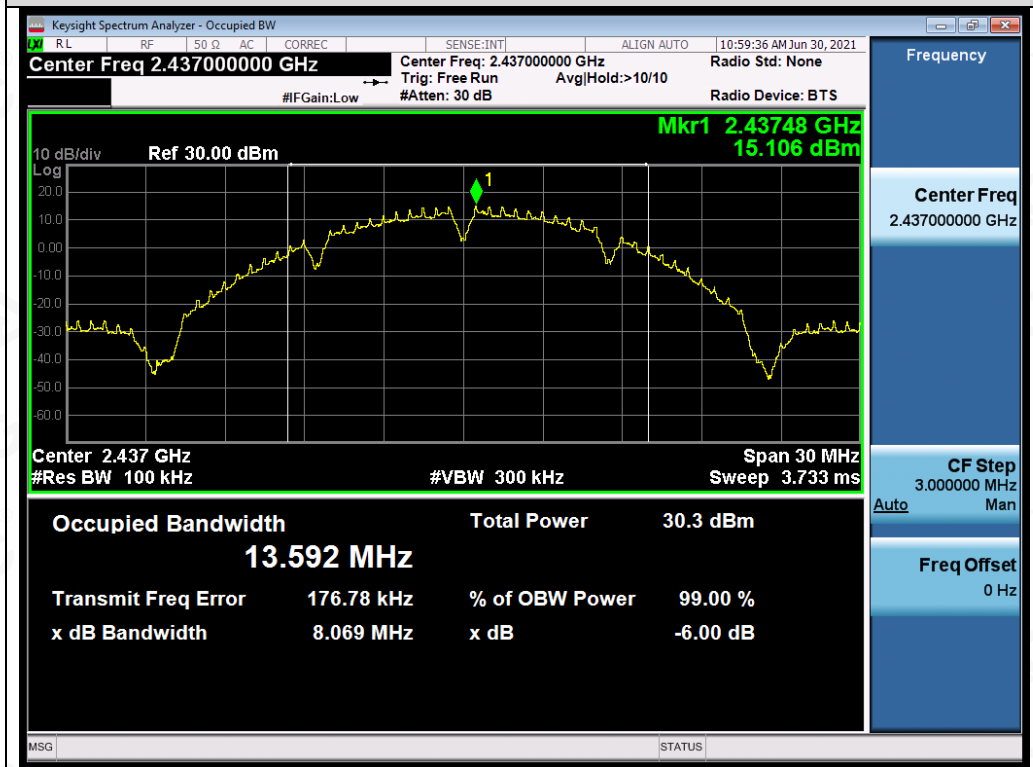

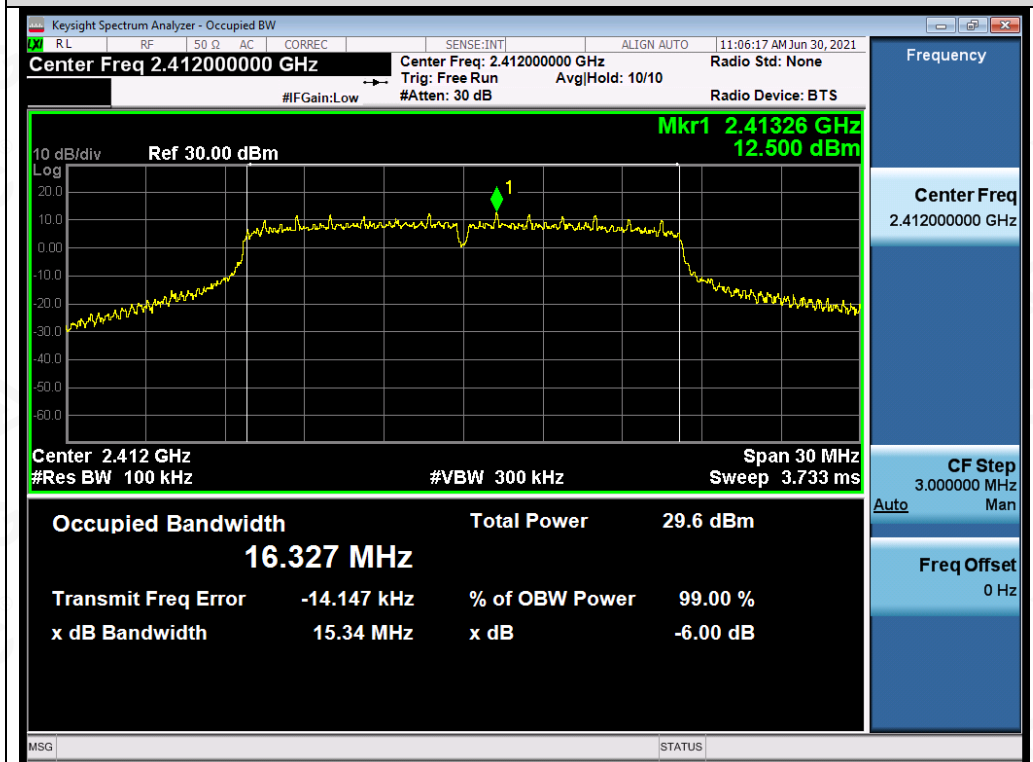

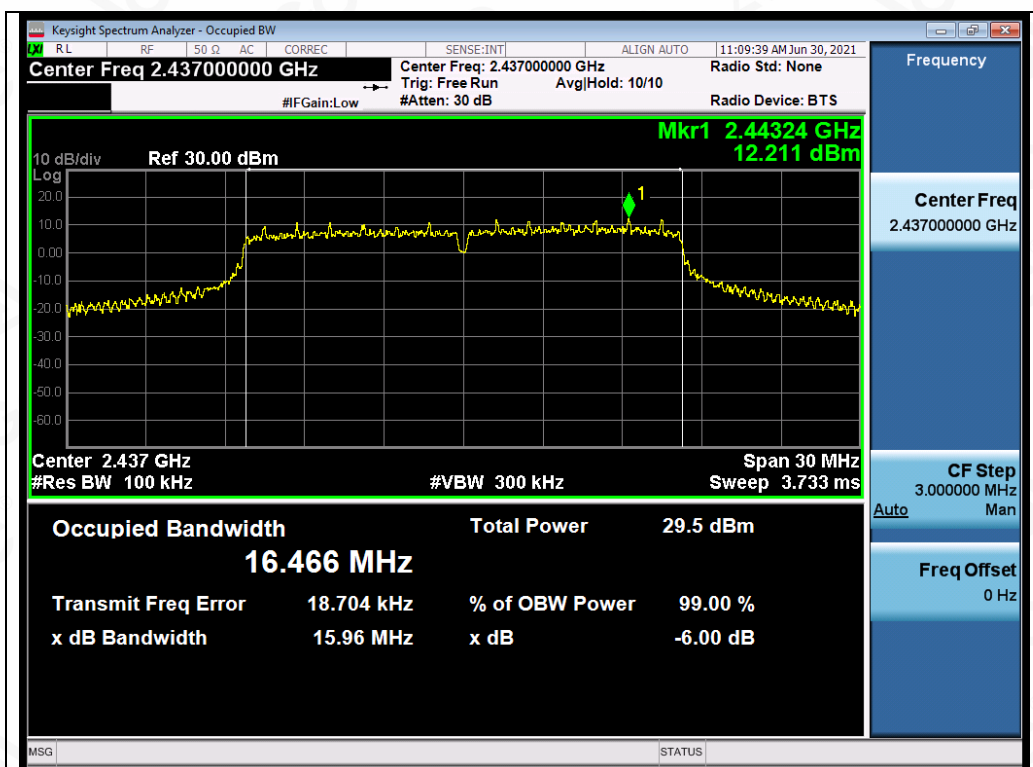

Test_Graph_802.11g_ANT1_2437_6Mbps_DTSBW

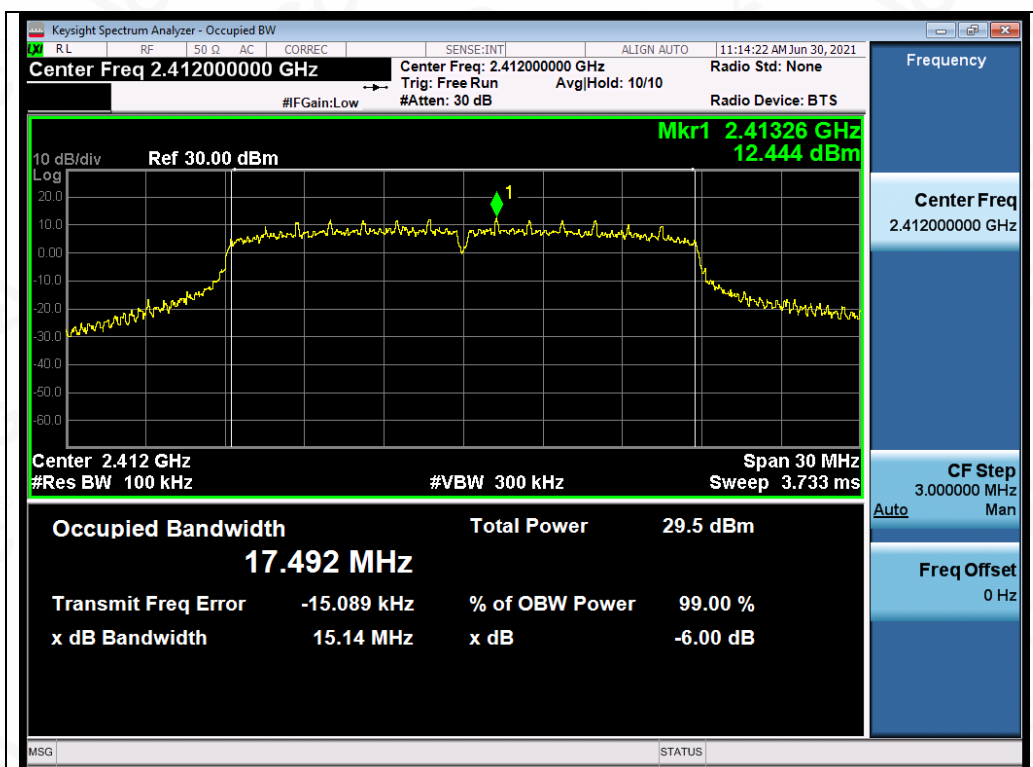
