

Below is the operation of Power Bank and Bluetooth Speaker.

Specifications:

- Input: DC 5V/1A
- Output: DC 5V/2.1A
- Capacity: Li-polymer 4200mAh
- Bluetooth Version 3.0
- Transmission distance: 10m
- Rated power: 3W
- Size: D43XL100mm
- Weight: Approx 168g

How to Charge the item:

1. Use the cable provided for charging.
2. When charging, the LED indicators will flash. When fully charged, the LED lights will stay on.

How to Charge devices:

1. Use your own device charging USB cable and connect USB end to the output and the other end to your device for charging.
2. The item will begin to charge your device automatically. The indicators will turn off automatically 5-8 seconds later and you can press the power button to see the power status.

How to play music:

1. Long Press the power button to open the Bluetooth and you will hear "discovering" when pairing with your device.
2. When you heard the voice "connected" which means your device has been connected with the Bluetooth of the item. And you can control the music by operating your device.
3. "+" button: Press once → volume up; when reaching the max, you can hear double low tone to remind; long-press → Next One
4. "-" button: Press once → volume down when reaching the min, you can hear double low tone to remind;; long-press → Last one

How to answer the phone:

1. When there is incoming calls, the item will ding-ling to remind you and you press the phone button to answer the phone; long press the button to switch to your own phone and press again to hang up the phone.
2. Long press the button to refuse the incoming calls.

Warning:

- Do not place or use the product in a high temperature and or in a humid environment.
- Keep the product out of the reach of children
- Do not vigorously shake hit or throw the product
- If this power bank is not used for a long time, please charge/discharge it once every three months to ensure the service time of the product.
