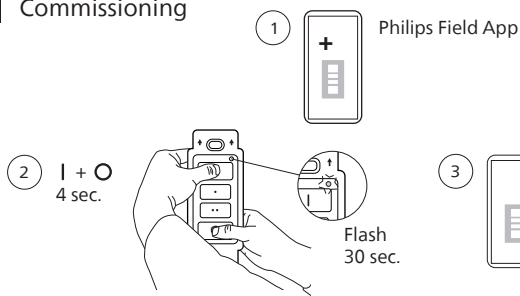
3a Junction box



3b Dry wall

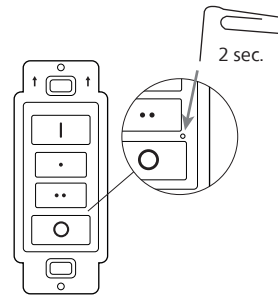

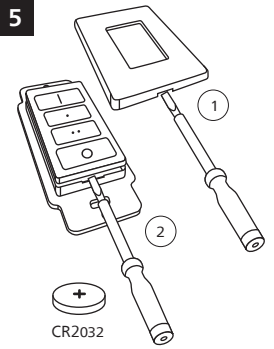
