

URE'S GUIDE

For your own protection, please read the following guide and follow the given instructions. This helmet was designed to reinforce your safety while doing the following winter sports activities: ski, snowboard and ski board, thus excluding all other activities, whether motorized or otherwise. WVI helmets meet the EN1077:2007/BS EN1077:2077 standards as well as ASTM F2040-11 to meet the European and American requirements for "Helmets used for Recreational Snow Sports".

✓ **Warning:**

You must close the buckle before beginning any activity and for the duration of this activity.

You must take off the helmet when you have finished your activity to eliminate a risk of hanging. Under no circumstances should the helmet be worn without the ear straps. You must remove all hard accessories such as barrettes, hair clips, etc.

You must verify the strap adjustments before each use. For children's helmets, an adult must always verify that the helmet has been adjusted correctly.

All protection equipment has limits; wearing a helmet can limit the severity of head trauma in the case of an accident.

A helmet does not however protect uncovered zones such as the face or neck.

Certain types of impact, even an accident at low speeds can cause severe injury, even death.

Always ski with caution respecting the security rules of your sport which can evolve; keep informed of these changes by asking the personnel of your resort or ski instructors.

✓ **Instructions for use – CAUTION!**

Storage: keep your helmet away from all sources of heat. Never expose your helmet to over 40°C. Extended exposure to fierce sunlight may weaken plastic materials.

These conditions often occur within a car parked in the sun.

Advice to choose your helmet: To ensure optimal protection, your helmet must be chosen in the correct size (avoid empty spaces and tight areas). Do not hesitate to consult a salesperson.

Adjustment of your helmet:

- 1) Position the helmet on your head, not too far forward not too far back. fig.1
- 2) For certain models, adjust the furnished spare parts to reduce the empty space

between the helmet and your head.

- 3) Close the buckle under your chin until you hear a click sound. fig.2
- 4) Adjust the length of the chin strap to maintain the position of the helmet. The helmet should fit well, yet not be too tight affecting your respiration. Try To move your head around to see if the helmet moves. It should stay in place and be comfortable.

Each Helmet shall have accompanying fitting and positioning instructions including graphic representation of proper positioning.

Cleaning:

- 1) External Shell: Use only soap and water. Do not use gasoline or any other solvent/chemical substances.
- 2) Lining & Ear pads:

Upkeep: Do not modify your helmet. Do not put varnish or any coloring product on your helmet. Do not cut the ends of the straps. Only use the included stickers on your helmet.

Servicing: Inspect your helmet regularly. If you remark any sign of deformation or damage, replace your helmet. Do not hesitate to show your helmet to a WVI dealer or contact our service department.

Replacement – WARNING!

This helmet was designed to absorb shocks by deformation. If your helmet has been subjected to a forceful shock, or involved in an accident, it should be destroyed and replaced even if the there is no visible damage because interior damage can occur that weakens the helmet. WVI recommends not use a helmet more than 5 years from the date of manufacture (month/year appears on the sticker inside the helmet).

✓ Usable Accessories – CAUTION!

WVI helmets are designed for use only with WVI accessories and stickers other than sunglasses or goggles. Mounting any other accessory is at the risk of the user.

CE levels of protection

The EN1077 Class A helmets may offer greater ventilation and better hearing, but protect a smaller area of the head and give a lesser degree of protection from penetration.

✓ Warranty


WVI products are guaranteed against any defects for 2 years from the date of purchase. This does not apply to any damages resulting from improper transport, improper storage, and normal wear of the product as well as disrespect of the user's

This warranty applies only to products sold by an authorized WVI dealer.

For all warranty question or concerns, please go to your local WVI dealer with the defective helmet and original sales receipt.
