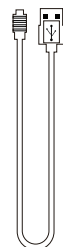

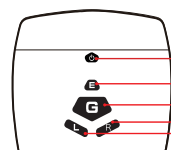

Instruction of Buttons



- ① Power button
- ② E button
- ③ G button
- ④ L button
- ⑤ R button

- 1.Constant power light stands for normal status.
- 2.The power light flashes on the condition of low battery.
- 3.The power light flashes while the cup is being charged.
- 4.Constant power light on indicates the charging is complete.

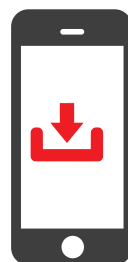
- 1.Disconnection results in light off.
- 2.Light on while it is connected.

- 1.Press the power button for 2 seconds to turn it on or off.
- 2.BKK turns to sleep mode if it hasn't been operated for 5 minutes constantly.
- 3.BKK will shut down automatically once it hasn't been operated for 10 minutes constantly.



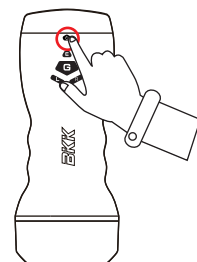
Operation Instructions

Step 01



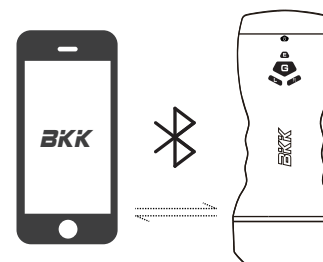
Download the application onto the smartphone, please visit www.bkksexttoy.com for more information.

Step 02



Press the power button for 3 seconds to turn on the cup.

Step 03



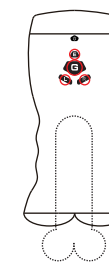
Run the application in smartphone, connect cup with bluetooth.

Step 04



Add appropriate lubricants into the silicon.

Step 05



Control device manually, interact with the app through the button and shaking device.



Maintenance

Step 01



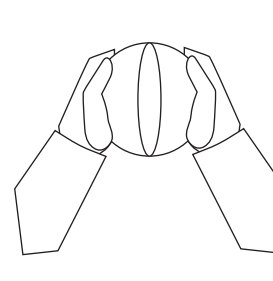
Remove the silica gel from the cup.

Step 02



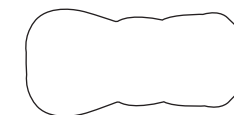
Rinse the silicone surface with water.

Step 03



Turn the silica gel inside out, rinse the surface with water.

Step 04



Wipe the silicone, and lay it in a cool place until it is dry.

Step 05



Put the silica gel back in the cup.



Handing Information

- 1.Please do not charge the masturbation cup next to the sink or under any humid environment.
- 2.Watch out for the food or dirty liquid dropping into the cup.
- 3.Please rinse the masturbation cup after every entertaining, and keep it clean, wipe it with soft cloth and lay it in a cool and well-ventilated place till it dries naturally.
- 4.Please do not use hair-dryer, microwave or other heating devices to dry the masturbation cup.
