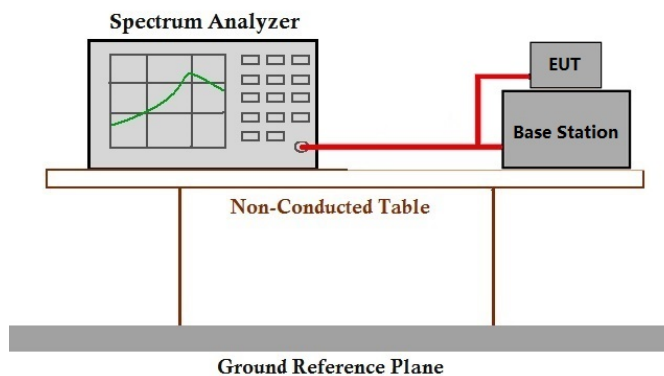

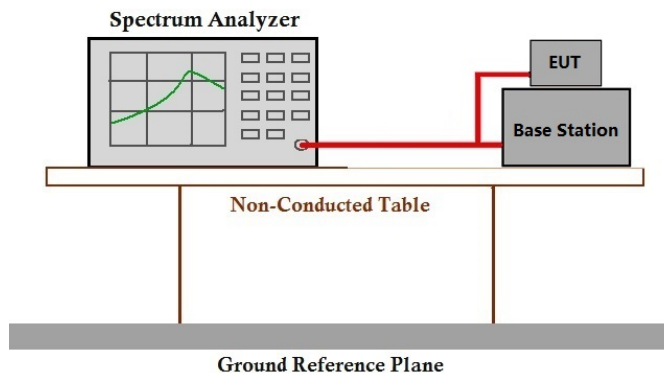

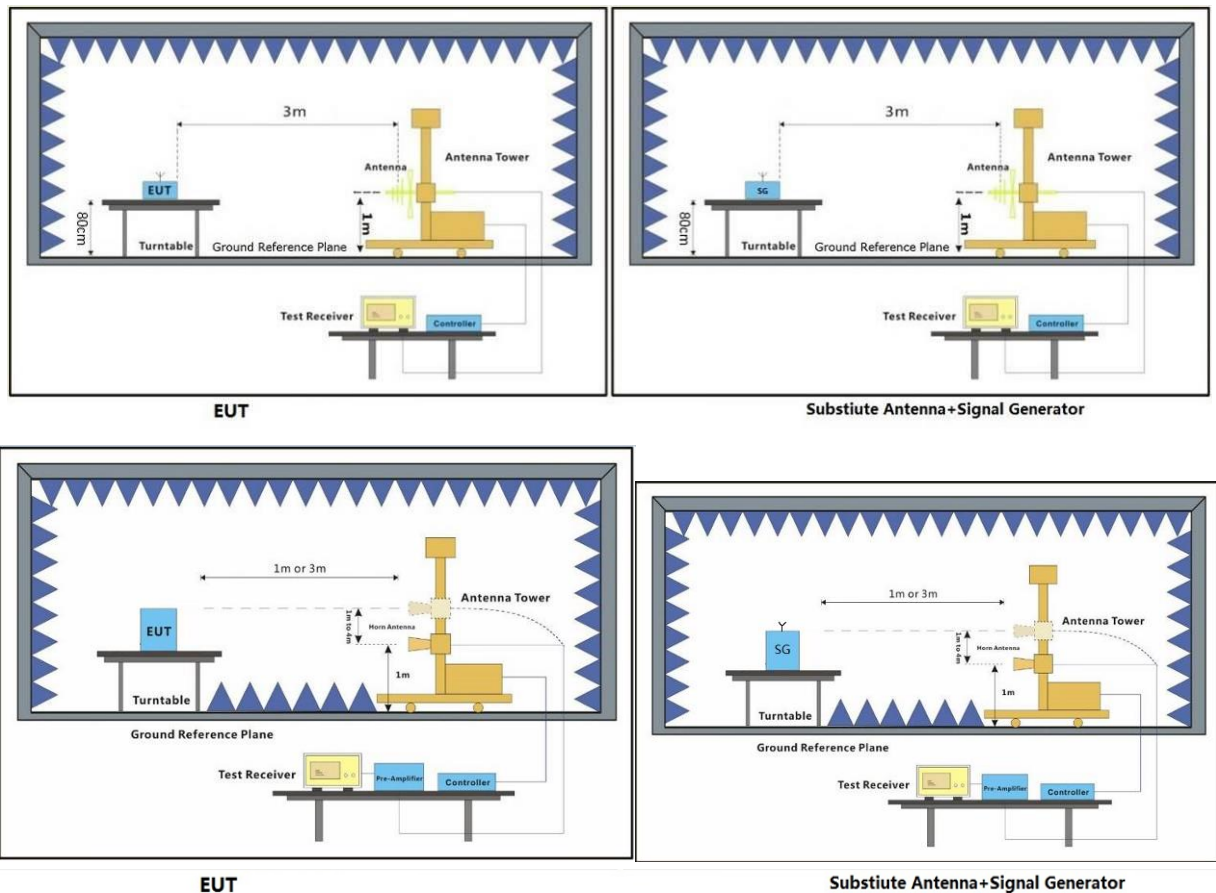

### 6.7.3 Measurement Procedure and Data

#### Test Procedure:

- (5) The test antenna shall be raised and lowered through the specified range of height until the measuring receiver detects a maximum signal level.

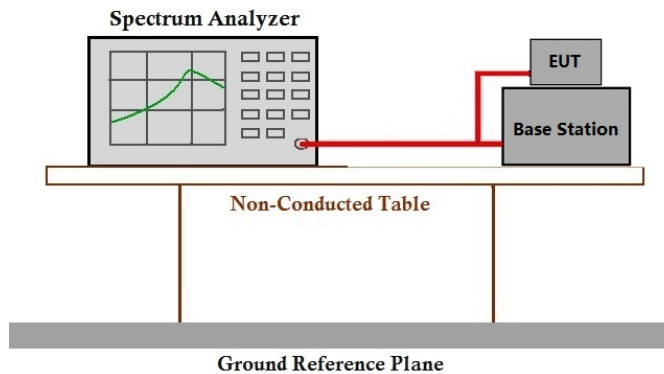
