<p><b>CHARGING THE SPEAKER</b></p> <ul style="list-style-type: none"> <li>- Plug the charging cable into the charging port of the speaker.</li> <li>- Plug the USB into a compatible power source</li> <li>- The red LED will turn on and indicate if the speaker is charging.</li> <li>- Once the speaker is fully charged, the red LED will turn off. When the device indicates the battery is low, approx.4-5 hours of charging time is needed to fully recharge the battery.</li> </ul> <p><b>SAFETY INFORMATION</b></p> <ul style="list-style-type: none"> <li>- Do not attempt to disassemble the device.</li> <li>- Do not expose the device to extreme heat or flames.</li> <li>- The speaker may become warm while charging. This is normal.</li> <li>- Ensure all cable connections are removed and port cap is closed and tightly sealed before getting the speaker near water.</li> <li>- Do not expose the speaker to water while it is charging.
