



#### Operation

- 1. Plug the power adapter into the wall socket (adapter not included)
- USB-A side connects to the power wall adapter, USB-C side connects to the wireless charger side, the LED light will illuminate blue which means the unit is ready to charge your device.
- 3. Place your device on to the charging stand, the LED light will change from blue to green which denotes the device is being charged.

1.0nly the QC2.0/QC3.0 Standard power adapter can support this product's fast charging. Adapters are not included with the product.

2. Iphone 12 mini and iphone 13 mini can support charging horizontally, but can not ensure to charge vertically.



#### Indicating status and protection function

- 1. LED blue light: Standby
- 2. LED green light: Charging
- 3. Blue light flashing: device is not correctly placed on the wireless charger, over temperature protection, or detects metal on the back of the device
