7.1 E.U.T. test conditions

Test frequencies are the lowest channel: 0 channel(2402MHz), middle channel: 20 channel(2442 MHz) and highest channel: 39 channel(2480 MHz)

7.2 Antenna Requirement

For intentional device. According to 15.203, an intentional radiator shall be designed to Ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

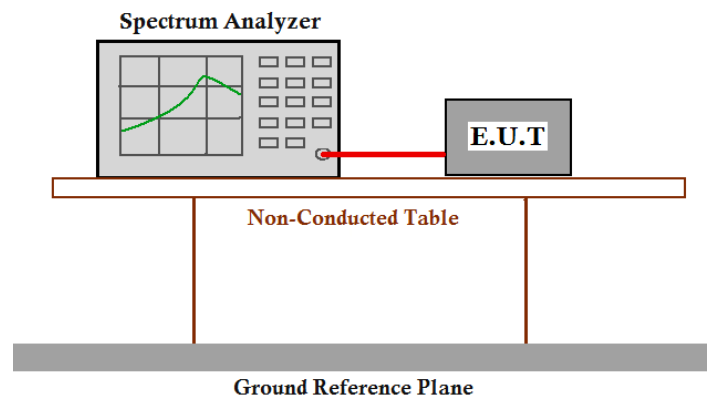

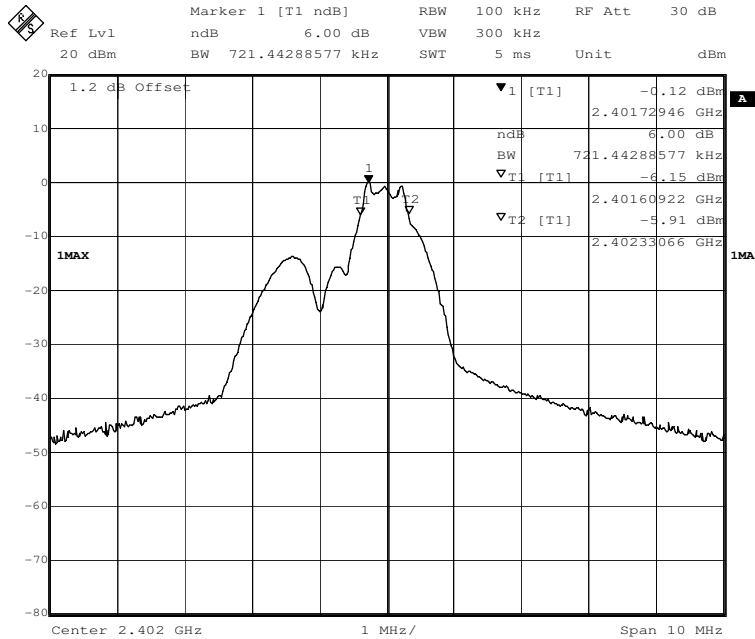

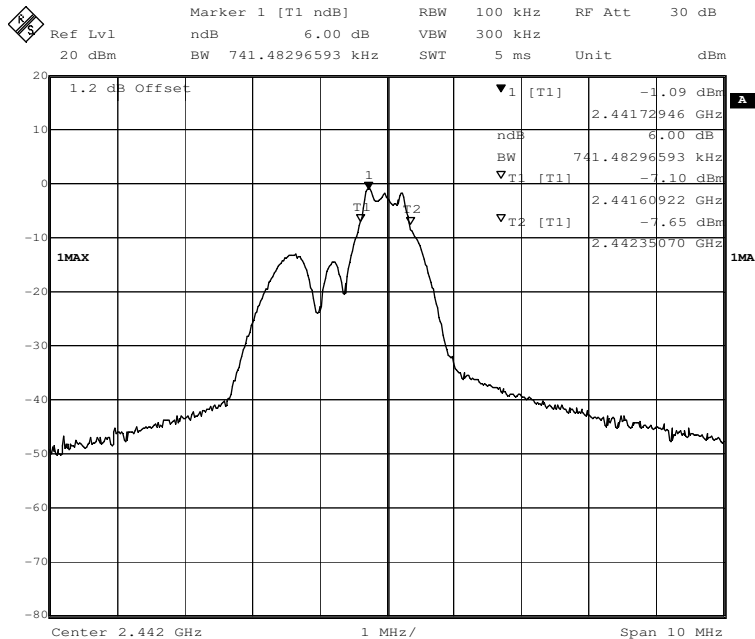


Result plot as follows:

Channel 0:2.402GHz:

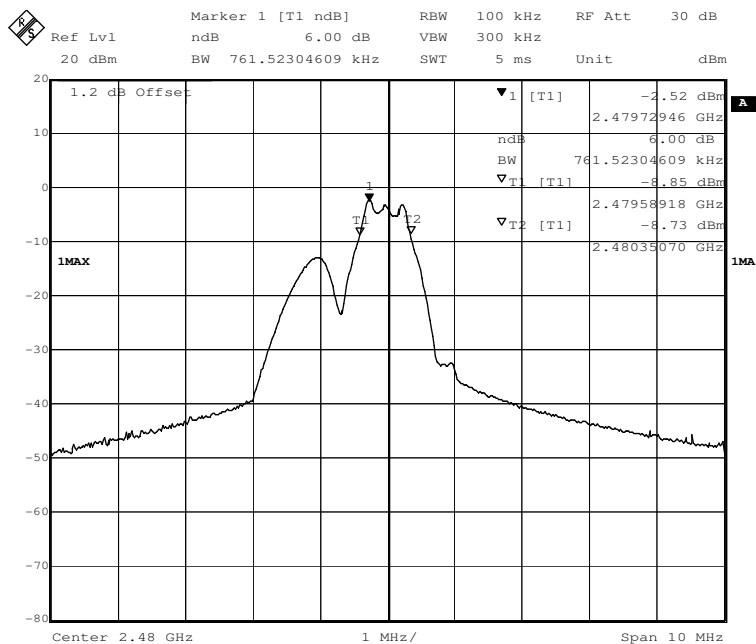


Channel 20:2.442GHz:



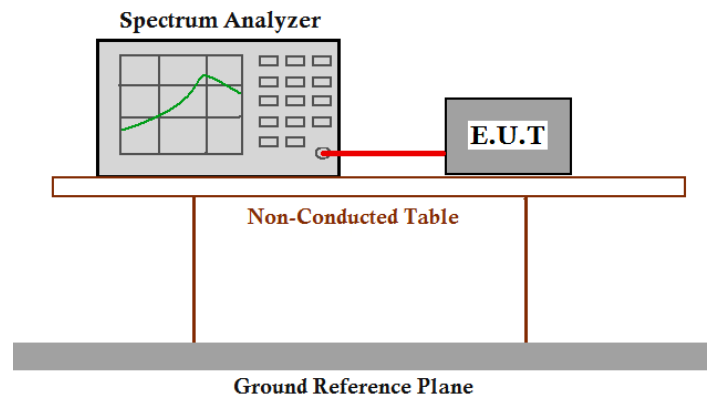


Channel 39:2.480GHz:

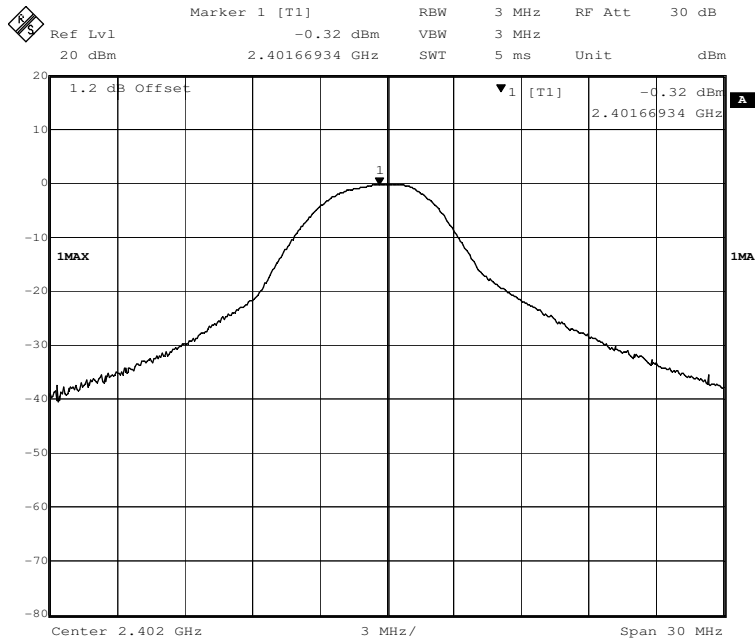

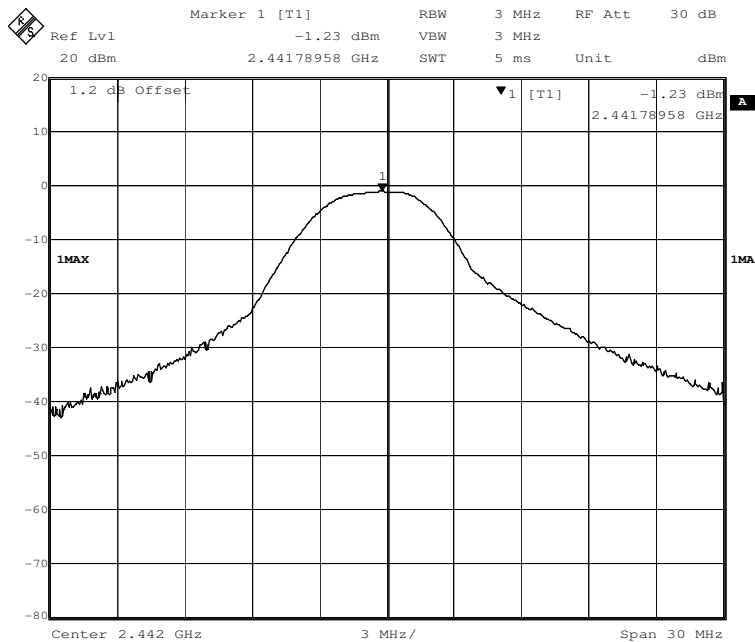


Result plot as follows:

Channel 20:2.442GHz:





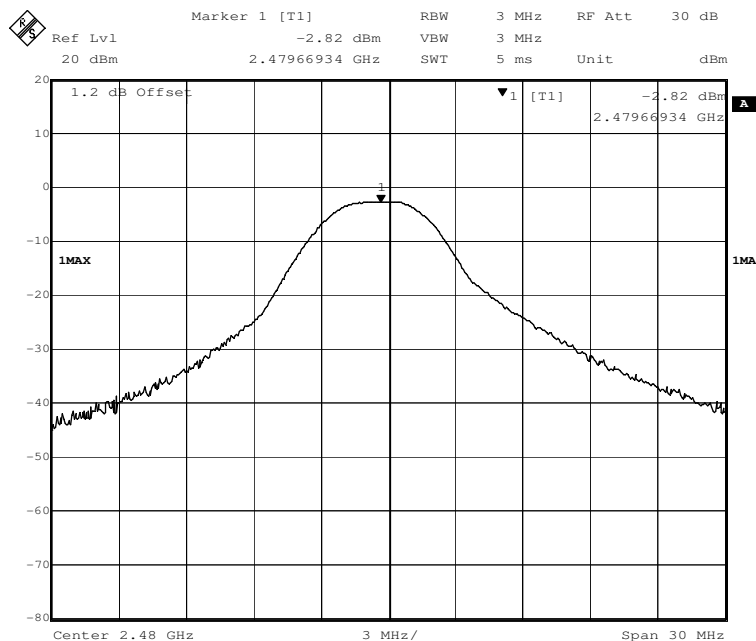
