**2M Dual HDR cameras:** Allows clear facial image capture under strong or against the light to match against the photo on the citizen ID card.


**Black list:** Connects with the police database to monitor, detect and report any entry of blacklisted persons.







## 6. Installation

### 6.1 Access Control

- (1) Remove the bracket: Slide the bracket down and take it out.
- (2) Install bracket: Fix the bracket to the wall.
- (3) Connect the power, wire, access control relay.
- (4) fix the back chute of the equipment on the bracket, tighten the bottom screw, and fix the BA8200.




## 6.2 Access Control With Turnstile

### (1) Drilling

Open a hole with a 32mm diameter near the entrance or middle of the turnstile for installing the BA8200. (See the position shown on the right  $\oplus$ )

### (2) Installing

- a.Unscrew the bottom nut of the equipment bracket.
- b.Pass the column and cable through the hole.
- c.Tighten the nut on the inside of the turnstile and fix the BA8200.
- d.Connect the power, wire, access control relay.
